- VIII. Speed Limit Bill (HB 562)
  - Approved to allow speed limit to be decreased to 15 miles per hour but a traffic study is required in order to lower the speed limit

    - i. Takoma Park does not have authority to do this and the County does not have authority to do this on Takoma Park.
  - c. Could Takoma Park reach out to Gaithersburg and Rockville to partner on this initiative?
