



## CITY OF TAKOMA PARK, MARYLAND IMPORTANT INFORMATION FOR NEW TENANTS

### Welcome to the City of Takoma Park!

Takoma Park has a history of political and civic activism. Efforts by residents have led the city to enact rent stabilization, declare itself a nuclear free zone and a sanctuary city, and allow non-U.S. citizen residents to vote in municipal elections. In 2013, the vote was extended to 16 and 17 year olds and to convicted felons who have completed their term of imprisonment.

The City Council and Staff of the City of Takoma Park hope that tenants will fully participate in the electoral process and the civic life of the community. You are encouraged to register, vote, serve on Council-appointed boards, commissions and committees, and run for office. Take advantage of all the opportunities available to be informed and involved in your home town.

### Government

Takoma Park operates under a Council-Manager form of government. An at-large Mayor and six Councilmembers representing wards comprise the Council. Councilmembers are elected for two-year terms. The next City election will take place on Tuesday, November 8, 2022. The Council sets policy, adopts the annual budget, appoints the City Manager and City Attorney, and appoints members to various boards and commissions. The City Manager directs the day-to-day operations of the city government, hires and manages staff, and proposes an annual budget for consideration by the Council.

The City of Takoma Park provides services through the following departments: Administration, Housing and Community Development, Library, Police, Public Works and Recreation. Social services, schools, courts, and most building inspections and planning and zoning services are provided by Montgomery County.

Takoma Park lies within Montgomery County Council District 4, Maryland General Assembly District 20, and U.S. House of Representatives District 8.

### Elections

The Mayor and all Councilmembers are elected for two-year terms in November of even-numbered years. In 2013, the City Council enacted two important amendments to the Housing Code to ensure that tenants who live in multi-unit housing have the opportunity to fully participate in the electoral process.

#### 1) Candidates' access to multi-unit buildings:

After providing notice to landlords and tenants, qualified candidates and their volunteers are permitted to enter apartment buildings for the purpose of campaigning for office or to register voters. This may occur during the 90-day period before an election and only for candidates who are running to represent an area that includes the multi-unit building. Of course, tenants are not required to open their doors to candidates. The City provides, free of charge, a sign that a tenant may place on the apartment unit door to indicate that canvassing is not welcome.

#### 2) Information packets for new tenants:

Within seven days of a new tenancy, landlords are required to distribute to new tenants a City-supplied packet of information to include: a) State of Maryland voter registration forms; b) City of Takoma Park voter registration forms for residents not eligible to register and vote in county, state, and national elections; and c) other material designated by the City regarding services, laws, and the electoral process.

# Voter Registration in the City of Takoma Park

In 2013, the Takoma Park City Council amended the City Charter to update Takoma Park's voting and election laws. The amendment expanded the right to vote in City elections to 16 and 17 year old residents and to residents who have been convicted of a felony but have completed serving any court-ordered sentence of imprisonment for the conviction.

Residents of Takoma Park who are not United States citizens have been eligible to register and vote in City elections since 1993.

Please review the information below to determine which voter registration application you should use. If you meet the Maryland Voter Registration Application qualifications, you should take advantage of your right to vote for school board, county, state, and federal officials. If not, or if you prefer only to vote in City of Takoma Park elections for mayor and city council, then register using the City of Takoma Park Voter Registration Application.

To register using the **Maryland Voter Registration Application**, you must:

- Be a U.S. citizen;
- Be a Maryland resident;
- Be at least 16 years old (you may vote in school board, county, state, and national elections when you are 18);
- Not be under guardianship for mental disability or, if you are, you have not been found by a court to be unable to communicate a desire to vote;
- Not have not been convicted of buying or selling votes;
- Not have been convicted of a felony or, if you have, you have completed serving a court-ordered sentence of imprisonment.

***If you are a Takoma Park resident eligible to vote in the State of Maryland, you do not need to fill out a special Takoma Park Voter Registration Application. The Maryland VRA can be completed online: [www.elections.maryland.gov](http://www.elections.maryland.gov).***

To register using the **City of Takoma Park Voter Registration Application**, you must:

- Not be eligible to fill out a State of Maryland voter registration application;
- Be a resident of the City of Takoma Park;
- Be at least 14 years old (you may vote in Takoma Park elections when you are 16);
- Not claim the right to vote elsewhere in the United States;
- Not be under guardianship for mental disability or if you are, you have not been found by a court to be unable to communicate a desire to vote;
- Not have not been convicted of buying or selling votes;
- Not have been convicted of a felony or, if you have, you have completed serving a court-ordered sentence of imprisonment.

***If you register to vote using the Takoma Park Voter Registration Application, you may vote in City of Takoma Park elections only. You may not vote in school board, county, state or national elections.***

## MARYLAND VOTER REGISTRATION APPLICATION

### TO REGISTER, YOU MUST

- Be a U.S. citizen;
- Be a Maryland resident;
- Be at least 16 years old\*;
- Not be under guardianship for mental disability or if you are, you have not been found by a court to be unable to communicate a desire to vote;
- Not have been convicted of buying or selling votes;
- Not have been convicted of a felony, or if you have, you have completed serving a court-ordered sentence of imprisonment.

\*You may register to vote if you are at least 16 years old but cannot vote unless you will be at least 18 years old by the next general election.

### DEADLINE INFORMATION

- This application must be postmarked no later than 21 days before an election.
- If your application is complete and you are found to be qualified, a Voter Notification Card will be mailed to you.
- The submission of this form to an individual other than an official, employee, or agent of a County Board of Elections does not assure that the form will be submitted or filed in a timely manner.

### YOU CAN USE THIS FORM TO

- Register to vote in federal, state, county, and municipal elections in Maryland.
- Change your name, address, or party affiliation.

### INSTRUCTIONS

- If you do not have a current, valid Maryland driver's license or MVA ID card, you must enter the last 4 digits of your social security number. The statutory authority allowing officials to request the last 4 digits of your social security number is Election Law Article, § 3-202. The number will only be used for registration and other administrative purposes. It will be kept confidential.
- Complete Items 1–11 in Voter Registration Application. Sign and date Item 12. If you are registered to vote in another Maryland county or another state, you must complete Items A–B in Last Voter Registration.
- You must register with a party if you want to take part in that party's primary election, caucus or convention. Check one box only.
- Detach this panel at the perforation.
- Address and mail the application to your County Board of Elections, using the list on the back panel.

### WARNING

Giving false information on an application for voter registration is perjury, punishable by imprisonment for up to 10 years, and a violation of the election laws, punishable by a fine of up to \$1,000, or by imprisonment for up to 5 years, or both.

### PERSONAL RECORDS NOTICE/CONFIDENTIALITY

This form collects personal information for voter registration purposes. If you are not registered to vote and you refuse to provide this information, you will not be allowed to vote in Maryland. You may update your voter registration at any time at your County Board of Elections. Except for items specified as confidential, voter registration records are generally available for public inspection; they may also be shared with jury commissioners/clerks or other government agencies as provided by law. The law prohibits use of voter registration records for commercial solicitation purposes. If you decline to register to vote, that fact will remain confidential and will be used only for voter registration purposes.

If you register to vote, the identity of the office at which the application is submitted will remain confidential and will be used only for voter registration purposes.

The Maryland Safe at Home Address Confidentiality Program (ACP) is administered by the Office of the Secretary of State and provides an important service to victims of domestic violence and human trafficking. For more information about this Program please call 1-800-633-9657, ext. 3875.

**REQUIRED IDENTIFICATION AND PROOF OF RESIDENCE:**

Please provide:

- (1) Photo identification or an identification card issued by a federal, state, or local government entity of the United States or any foreign country or school provided that the identification document contains a photograph and/or identifying information such as name, date of birth, gender, height, and eye color. Examples of acceptable documentation could include a U.S. or foreign passport, visa, alien registration card, driver’s license, MVA identification card, military identification, or school ID with photo; and
- (2) Document that establishes current residence in the City of Takoma Park if not already established by (1) above. Examples could include copy of a deed, house or apartment lease, utility bill, paycheck, bank statement, school record, or other official or government document that shows your name and current address in the City of Takoma Park.

**IF REGISTERING IN PERSON:**

**IF YOU DO NOT PRODUCE THE REQUIRED DOCUMENTATION AT THE TIME OF REGISTRATION:**

You will be asked to provide the information at the time you first vote.

**IF YOU ARE UNABLE TO PROVIDE THE REQUIRED IDENTIFICATION AND PROOF OF RESIDENCE:**

You may submit an affidavit on a form provided by the City Clerk attesting to your identity and place of residence. The affidavit must be executed by a person who:

- (1) Is registered to vote in the City of Takoma Park;
- (2) Is present with you to submit the affidavit; and
- (3) Has personal knowledge of your identity and actual residence.

Such affidavit shall be executed under the penalties of perjury.

**IMPORTANT INFORMATION FOR NON-UNITED STATES CITIZENS:**

If you apply for naturalization, you will be asked whether you have ever registered or voted in a federal, state, or local election in the United States. The City Clerk can provide a letter explaining that non-U.S. citizens who are residents of Takoma Park may register and vote in City of Takoma Park municipal elections.

Please be aware that registering to vote or voting in jurisdictions other than Takoma Park may result in adverse immigration consequences for a non-U.S. citizen.

***Registering to vote in Takoma Park does not authorize you to vote in any other elections.***
