Single Reading Ordinance Authorizing Contracted Services for Website Development

## **Recommended Council Action**

Adopt ordinance awarding contract to Ignition 72 for Phase II website development

#### Context with Key Issues

The current version ("Phase I") of takomaparkmd.gov represents over 18 months of work toward overhauling and improving the City's web presence. Phase I work culminated in the November 2015 launch of the new website. The new website represents a shift to a more data driven and iterative style of website development and offers us the ability to turn the website into an industry leading communications platform.

We now intend to start planned Phase II work. Phase II work will entail the addition of features that were beyond the scope of initial website development and address feedback about user experiences and website analytic data.

While staff makes improvements to the website on a day-to-day basis, we also hope to periodically overhaul certain components over time to keep up with trends and best practices. Phase II represents the next major step in that direction.

## **Environmental Impact of Action**

Using the City website as a means of communicating with stakeholders allows us to reduce our use of paper and the environmental impacts of delivery of paper materials.

#### **Fiscal Impact of Action**

The contracted Phase II website development work will cost up to \$14,000. The funds were appropriated for this purpose in the FY 2016 budget. The vendor is sole source, as the work will be performed by the company that designed the website.

#### AWARD OF CONTRACT FOR PHASE II WEBSITE DEVELOPMENT

- WHEREAS, staff recommends that the City contract with Ignition72 for Phase II website development; and
- WHEREAS, funding for the project is included in the FY 2016 budget.

SECTION 1. The City Manager is authorized to enter into a contract with Ignition72 for Phase II website development.
