**RESOLUTION 2016-
PROVIDING FOR APPOINTMENTS TO THE RECREATION COMMITTEE**

WHEREAS, the Recreation Committee was re-established as a statutory committee by Ordinance 2008-4 to advise the City Council on matters pertaining to recreation programs and facilities; and

WHEREAS, the ordinance provides that the Committee shall consist of seven to 15 Takoma Park residents appointed by the Council, with every effort being made to ensure that the membership represents all wards and the diverse populations in Takoma Park; and

WHEREAS, members of the Committee are appointed to serve staggered two-year terms, beginning on May 1 and ending on April 30; and

WHEREAS, there are five vacancies on the Committee and four members whose terms expired on April 30, 2016; and

WHEREAS, Jon Worley and Ryan Scully have applied as new applicants and Jay Keller, Howard Kohn, Jen Wofford, and Carolyn Leary Bobb have applied for reappointment; and

WHEREAS, the City Council has determined that all are appropriate candidates for service on the Committee.
