Second Reading Ordinance Eliminating the Area B Permit Parking Program

### **Recommended Council Action**

Adopt Ordinance at Second Reading to end the Area B parking permit program, with or without the additional language shown on the draft ordinance.

#### **Context with Key Issues**

Since the First Reading of the ordinance, additional language has been proposed to allow continued parking accommodation for certain current holders of Area B permits. That language is indicated by underlining on the attached draft ordinance. The key added provision is:

"The City Manager may, in her discretion on an individual basis, provide an Area B parking permit to allow parking for residents who are current holders of Area B permits and for whom the elimination of the Area B program is a hardship, provided that only one permit per family will be granted, and further provided that the parking area for such Area B permit holders will be in a public City lot designated by the City Manager."

#### **Council Priority**

A Livable Community for All

#### **Environmental Impact of Action**

Ending the permit program reduces the number of people who drive and park near the Takoma Metro station and helps encourage alternative modes of transportation.

#### Fiscal Impact of Action

This action would have a minimal fiscal impact.

# ORDINANCE #2016-22 Ordinance Eliminating the Area B Permit Parking Program

- WHEREAS, the Area B Permit Parking Program was established in 1985 via Ordinance 1985-68 to assist certain residents that did not have reasonable access to the Takoma Metro station by public bus service; and
- WHEREAS, the Area B Permit Parking Program criteria were changed by Ordinances 1998-24 and 2003-38; and
- WHEREAS, due to bus, bicycle and pedestrian improvements in Takoma Park, reasonable access to the Takoma Metro station is available to all residents; and
- WHEREAS, the Council has determined that the Area B Permit Parking Program is no longer needed; and
- WHEREAS, the Council wishes to provide a temporary accommodation to certain current holders of Area B parking permits who may face hardship with the ending of the program.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND THAT:

SECTION 1. The Area B Permit Parking Program will end effective June 30, 2016.

SECTION 2. The City Manager may, in her discretion on an individual basis, provide an Area B parking permit to allow parking for residents who are current holders of Area B permits and for whom the elimination of the Area B program is a hardship, provided that only one permit per family will be granted, and further provided that the parking area for such Area B permit holders will be in a public City lot designated by the City Manager.
