AUTHORIZATION TO PURCHASE SEVEN REPLACEMENT POLICE VEHICLES

WHEREAS,	seven police vehicles are scheduled for replacement in accordance with the City's vehicle replacement policy; and	
WHEREAS,	the FY 2017 budget has funds in the Equipment Replacement Reserve that will be used for the purchase; and	
WHEREAS,	the Police Department proposes to acquire seven Ford Interceptors at the cost of \$192,354 to replace the existing vehicles; and	
WHEREAS,	the quoted price is based on a competitively bid State of Maryland contract with Hertrich Fleet Services, Inc.	
NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND THAT:

AUTHORIZATION TO PURCHASE AND INSTALL EQUIPMENT FOR SEVEN POLICE VEHICLES

WHEREAS,	Department vehicles; and
WHEREAS,	each of the cars will need to be appropriately equipped with emergency lights, sirens, computer docks and related equipment; and,
WHEREAS,	the quoted price of \$86,500 is based on a competitively bid Maryland State contract with Brekford Corp.
NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND THAT:	
SECTION 1.	The City Manager or her designee is authorized to enter into an agreement with Brekford Corp. for the purchase and installation of equipment for the six vehicles at a total cost of \$86,500.
