Context with Key Issues

On February 1, 2017, staff presented its recommendations for the execution of a contract for services with <u>The Cloudburst Group</u> for the development of a community-wide Housing and Economic Development Strategic Plan. The firm has worked on similar planning projects across the country for communities of varying sizes and, as noted during the discussion, has been praised by former clients for their innovative, yet practical recommendations for advancing their identified goals.

Council Priority

- A Livable Community for All with the goal of ensuring that a range of safe, quality, and stable housing options are available for residents of varying incomes.
- Advancement of its Economic Development Efforts with a goal of attracting new businesses to the community and preparing for economic development within the City and the region.

AUTHORIZING EXECUTION OF A CONTRACT FOR SERVICES FOR THE HOUSING AND ECONOMIC DEVELOPMENT STRATEGIC PLAN

- WHEREAS, the Takoma Park City Council has identified as a programming priority, the development of a strategic plan for the preservation, retention and expansion of its housing and economic development infrastructure; and
- WHEREAS, in accordance with City procurement procedures, the Housing and Community Development Department issued a Request for Proposals on November 21, 2016 for the development of the desired plan; and
- WHEREAS, a total of six proposals were received by the December 28, 2016 deadline; and
- WHEREAS, The Cloudburst Group was found to have submitted, at the fixed price of \$84,124, the most responsive and responsible proposal; and
- WHEREAS, the FY17 budget includes funding in the amount of \$90,000 for development of a Housing and Economic Development Strategic Plan; and
- WHEREAS, the Housing and Community Development requests permission to award a contract for services to The Cloudburst Group for the development and completion of the proposed plan.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND, THAT:

- Section 1. The City Manager or her designee is authorized to enter into a contract for services with The Cloudburst Group for the Housing and Economic Development Strategic Plan for a fee of \$84,124.00.
- Section 2. This Ordinance shall become effective upon adoption.
