#### **Context with Key Issues**

The Fiscal Year 2018 budget includes funding for the purchase of a backhoe. The Department has selected a manufacturer of this equipment and identified an intergovernmental cooperative purchase agreement that we can participate on for the purchase. The National Joint Powers Alliance (NJPA) has hundreds of contracts for equipment and services available for local governments to purchase from at reduced pricing based on the large size of the buying group.

The backhoe selected is a John Deere, Model 310L, distributed by Jesco Inc. The NJPA price for this equipment includes a 47% discount from list price, bringing the cost of the purchase to \$100,299.91.

### **Council Priority**

Engaged, Responsive and Service-Oriented Government

#### **Environmental Impact of Action**

This equipment will be used to perform certain projects related to streets and park maintenance. The equipment uses diesel fuel and the city uses an environmentally preferred blend of bio-diesel which is 20% soy oil and 80% diesel fuel.

#### **Fiscal Impact of Action**

This purchase will be made through the Equipment Replacement Reserve and funds are available within the reserve to cover the cost of the equipment. The cost estimate included in the FY18 CIP was incorrect (\$49,909) and the actual purchase price is higher.

The purchase and use of this equipment will not adversely affect or disproportionately impact any particular group.
