Context with Key Issues

Since 2010, the City has maintained three contracts for comprehensive engineering services to assist with the implementation of the ADA sidewalk compliance program, new sidewalk design, and neighborhood traffic calming requests. The City has had ongoing multi-year contracts with two firms and has found their services to be exemplary. The contract for the third firm has changed every few years and department staff has not been completely satisfied with the service provided by the third firm.

Recently the Department has worked with the engineering firm of A. Morton Thomas and Associates, Inc. as a subcontractor on the Sligo Mill Playground project and would like to bring the firm on board to provide engineering services. A. Morton Thomas has a competitively bid contract with the Maryland-National Capital Park and Planning Commission that the City could ride on for civil and site engineering services. The contract is in effect until October 17, 2018.

WHEREAS	Public Works Department staff have identified the engineering firm of A. Morton Thomas and Associates, Inc. working under contract with the Maryland-National Capital Park and Planning Commission;
WHEREAS,	the services to be provided by A. Morton Thomas and Associates, Inc. under this contract meet the identified needs of the City; and
WHEREAS,	sufficient funds are available in the capital improvement budget to cover the anticipated cost of these services.
