Context with Key Issues

The Takoma Park Independence Day Committee organizes an annual Independence Day celebration that includes a parade, concert, and fireworks. Recognizing the value of the celebration for the community and the challenges of fundraising to maintain the activities, the City Council has included \$17,500 in the FY 2018 budget to support the July 4, 2018 Independence Day events.

The Takoma Park Independence Day Committee, Inc. submitted an application for \$17,500 to the City requesting funding to plan and produce the 2018 fireworks display.

ORDINANCE NO. 2018-

AUTHORIZING THE EXECUTION OF A GRANT AGREEMENT WITH THE TAKOMA PARK INDEPEDENCE DAY COMMITTEE, INC.

WHEREAS, the Takoma Park Independence Day Committee, Inc. organizes an annual Independence Day celebration that includes a parade, concert, and fireworks; and WHEREAS, recognizing the value of the celebration for the community and the challenges of fundraising to maintain the activities, the City Council has included \$17,500 in the FY 2018 budget to support the Independence Day events organized by the Committee; and WHEREAS, a grant agreement has been prepared setting forth the terms of the grant and providing for orderly disbursement of the funds. NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND, THAT: Section 1. The City Manager or her designee is authorized to execute a grant agreement with the Takoma Park Independence Day Committee, Inc. for disbursement of up to Seventeen Thousand Five Hundred Dollars (\$17,500.00) to support the 2018 Independence Day events.
