Context with Key Issues

The Police Department proposes the replacement of five current fleet vehicles. These are all replacement vehicles and no new vehicles are being added. Four of the vehicles to be replaced are non-patrol vehicles and the department is proposing to purchase Ford Fusion Hybrid vehicles. The other vehicle is a replacement of a patrol K-9 vehicle, for which the department is proposing the purchase of a Ford Interceptor.

These proposals were reviewed and approved by the Fleet Review Committee in accordance with the Vehicle Replacement/Addition/Transfer Policy and schedule.

Council Priority

Environmental Impact of Action

Hybrid vehicles burn less fuel and produce fewer harmful emissions than conventional gas or diesel vehicles.

Fiscal Impact of Action

The total cost to purchase the proposed vehicles and associated equipment is \$181,880.

Replacement of the Police Department vehicles will not disproportionately impact any particular group.

AUTHORIZATION TO PURCHASE FIVE REPLACEMENT POLICE VEHICLES

WHEREAS, five police vehicles are scheduled for replacement in accordance with the City's vehicle replacement/addition/transfer policy; and

WHEREAS, the FY 2018 budget has funds in the Equipment Replacement Reserve for the purchases; and

WHEREAS, the Police Department proposes to acquire four Ford Fusions and one Ford Interceptor at a cost of \$130,214 to replace the existing vehicles; and

WHEREAS, the quoted price is based on a competitively bid State of Maryland contract with Hertrich Fleet Services, Inc.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND THAT:

SECTION 1. The City Manager or her designee is authorized to enter into an agreement with Hertrich Fleet Services, Inc. for the purchase of five vehicles at the cost of \$130,214.

**AUTHORIZATION TO PURCHASE AND INSTALL EQUIPMENT
FOR FIVE POLICE VEHICLES**

WHEREAS, the FY 2018 budget includes funding for the purchase and equipping of Police Department vehicles; and

WHEREAS, each of the cars will need to be appropriately equipped with emergency lights, sirens, computer docks and related equipment; and,

WHEREAS, the quoted price of \$51,667 is based on contract pricing with Priority Install, LLC.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND THAT:

SECTION 1. The City Manager or her designee is authorized to enter into an agreement with Priortiy Install LLC for the purchase and installation of equipment for the six vehicles at a total cost of \$51,667.
