The Emergency Preparedness Committee provides community input to the Council and the City on Emergency Preparedness and assists in the City's planning for emergency operations.

Serving on the Committee are residents Rebecca Chestnutt (Ward 3); Andy Kelemen (Ward 1); Fred Levenson (Ward 2); Donald Pinkston (Ward 5); Kathleen Quinn (Ward 2); and Claudine Schweber (Ward 3). There is one resident vacancy.

Representative members include Ron Hardy, City Emergency Preparedness Manager; Thomas Horne, Takoma Park Volunteer Fire Department; Meg Usher, Washington Adventist Hospital; Joe Corona, Montgomery County Office of Emergency Management and Homeland Security; and Herma Percy, Washington Adventist University. Resident members serve staggered three-year terms.

Satchel Kornfeld (Ward 5) has applied for a resident appointment. The attached resolution will provide for his appointment to serve a three-year term.
