Recommended Council Action

To approve the purchase and adopt the Ordinance

Context with Key Issues

The Human Resources Department is undergoing renovations to improve the security and privacy of information held within its purview. Members of the Department are currently using tables, desks and chairs which are deteriorating and ill-fitted for the functions and tasks for which they are used. Additionally, renovations in the Department require reconfiguration of the workstations, files and storage solutions to fit within the area. Washington Group Solutions has provided a quote under the National IPO agreement. The options for workstations and furniture provided will refit the space and provide staff with the needed storage and work surface solutions. Staff recommends purchase of the Groupe Lacasse Morpheo line.

Environmental Impact of Action

The Group Lacasse Morpheo line of furniture is certified level 1, BIFMA's sustainability certification for furniture. Group Lacasse Environmental Certification

Fiscal Impact of Action

Funds for the purchase of the furniture will be used from the Department's operating budget, \$15,300 as well as the Facility Maintenance Reserve in the amount of \$5,000.

Racial Equity Impact of Action

Currently, all members of the Human Resources Department are people of color as is 40% of City staff. Providing a functional workspace will have a positive impact on the Human Resources Department staff and will provide the appropriate level of privacy for City staff visiting the Department.

AUTHORIZING CONTRACT FOR PURCHASE OF HR OFFICE FURNITURE	
WHEREAS,	the FY18 Operating budget includes funds to replace existing workstations in the Human Resources Department to accommodate the needs of staff; and
WHEREAS,	Washington Group Solutions company has identified LaCasse company's Morpheo office system and SitOnIt Seating to provide an appropriate solution which addresses the needs of the Department; and
WHEREAS,	the purchase would be made under the terms of a National IPO cooperative purchase agreement between the GSA and Washington Group Solutions and, in accordance with the provisions of City Code Chapter 7.08.070 (E) Other Procurement Method, competitive bids are not required; and
WHEREAS,	sufficient funds are available in the Human Resources Department's operating budget and the Facility Maintenance Reserve to cover the anticipated cost of this purchase.
