Resolution Affirming Our Support of the Treaty on the Prohibition of Nuclear Weapons

Recommended Council Action

Consider and vote on the resolution.

Context with Key Issues

Nuclear weapons are the only weapons of mass destruction not subject to an international ban. The Treaty on the Prohibition of Nuclear Weapons would establish a ban on nuclear weapons. It was adopted by 122 nations on July 7, 2017 and was opened for signing in September 2017. Once 50 nations have ratified or acceded to it, the Treaty will enter into force.

Given that the United States has declined to ratify the Treaty, cities and states are encouraged to take their own steps to comply with the Treaty by not investing in the 26 companies that make nuclear weapons, not purchasing products or services from the companies, and prohibiting all other nuclear weapons-related activity within their borders.

Environmental Impact of Action

Use of nuclear weapons would have catastrophic environmental effects resulting from both blast damage and release of radiation. Manufacture, testing, and deployment of the weapons results in environmental hazards and harm.

**RESOLUTION 2018-
AFFIRMING THE CITY'S SUPPORT OF THE
TREATY ON THE PROHIBITION OF NUCLEAR WEAPONS**

WHEREAS, the City of Takoma Park established itself as a nuclear-free zone in 1983, when the City Council adopted the Takoma Park Nuclear Free Zone Act; and

WHEREAS, the Act prohibits production of nuclear weapons as well as facilities, equipment, components, supplies, or substance used for their production; requires that the City develop a socially responsible investment policy, specifically addressing any investments the City may have or may plan to have in industries and institutions which are knowingly and intentionally engaged in the production of nuclear weapons; and, prohibits the City from granting any award or contract to a nuclear weapons producer or purchasing or leasing products produced by a nuclear weapons producer; and

WHEREAS, the Act established the Nuclear-Free Takoma Park Committee to ensure compliance with the Act, provide advice to the City Council, and conduct educational activities related to the intent and purpose of the Act; and

WHEREAS, Takoma Park has continued to take the lead among nuclear-free cities in maintaining a high level of awareness about the importance of abolishing humankind's most deadly and unnecessary invention; and

WHEREAS, in the more than 70 years since nuclear weapons were used on the cities of Hiroshima and Nagasaki, the weapons technology has proliferated and the number of nations with known nuclear warhead production capability has grown to nine, despite efforts to contain it; and

WHEREAS, according to the Federation of American Scientists, in 2017 the nine nuclear weapons powers had a total of 14,900 nuclear warheads, over 13,000 of which are held in the arsenals of the United States and Russia; and

WHEREAS, another five European nations host US nuclear weapons on their soil as part of a NATO nuclear-sharing arrangement, and roughly two dozen other nations claim to rely on US nuclear weapons for their security; and

WHEREAS, the production, testing, and deployment of these weapons results in health and environmental hazards and harm, while diverting scarce public resources away from human needs; and

WHEREAS, nuclear weapons have been the only weapons of mass destruction not subject to a categorical ban, despite the catastrophic consequences that would result if they are used again; and

WHEREAS, the Treaty on the Prohibition of Nuclear Weapons, adopted by 122 nations on July 7, 2017, establishes a ban; and

WHEREAS, the Treaty establishes the same standards for all nations and embodies the principle that there can be no safe hands for nuclear weapons; and

WHEREAS, once 50 nations have ratified or acceded to it, the Treaty will enter into force; and

WHEREAS, as a Nuclear-Free Zone for almost 35 years and signatory to the Mayors for Peace covenant, the City of Takoma Park is compliant with the Treaty.

NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND endorses the efforts of the International Campaign to Abolish Nuclear Weapons (ICAN) to promote adherence to and implementation of the United Nations nuclear weapon ban treaty; and

BE IT FURTHER RESOLVED THAT the City Council affirms its support of the Treaty on the Prohibition of Nuclear Weapons and urges other cities to become nuclear-free zones.
