## **Context with Key Issues**

The Commission on Landlord-Tenant Affairs (COLTA) is a statutory commission which is responsible for hearing and ruling on landlord-tenant complaints and selected rent stabilization applications. COLTA's full composition is 12 members whose three-year terms are staggered. There are currently three vacancies on the Commission and three Commissioners are seeking reappointment.

The appointment terms of Ms. Lauren Price, Ms. Victoria Sutton, and Mr. Michael L. Mullings expired on June 30, 2017. They have expressed interest in being reappointed to the Commission. If reappointed, their terms will expire on June 30, 2020.

Ms. Elly Kugler, Ms. Antoaneta Tileva, and Ms. Thais-Lyn Trayer have expressed their interest in serving on the Commission. If appointed, Ms. Klugler and Ms. Tilvea terms will expire on June 30, 2021 and Ms. Trayer's term will expire on June 30, 2020.
