Resolution Providing for Reappointments to the Recreation Committee

Recommended Council Action

Adopt the Resolution as part of the consent agenda.

Context with Key Issues

The Recreation Committee advises the City Council on matters pertaining to recreation programs and facilities. The City Council appoints seven to 15 members to staggered two-year terms that expire on April 30. There are six vacancies on the Committee and four members whose terms have expired. Members applying for reappointment include Carolyn Leary Bobb (Ward 6), Jay Keller (Ward 3), Howard Kohn (Ward 3), and Jon Worley (Ward 2). There are two applications from residents seeking to serve on the Committee: Rachel Vierling (Ward 4) and Nicholas Dean (Ward 3). All applications have been submitted to Council for review.

**RESOLUTION 2018-
PROVIDING FOR APPOINTMENTS TO THE RECREATION COMMITTEE**

WHEREAS, the Recreation Committee was re-established as a statutory committee by Ordinance 2008-4 to advise the City Council on matters pertaining to recreation programs and facilities; and

WHEREAS, the ordinance provides that the Committee shall consist of seven to 15 Takoma Park residents appointed by the Council, with every effort being made to ensure that the membership represents all wards and the diverse populations in Takoma Park; and

WHEREAS, members of the Committee are appointed to serve staggered two-year terms, beginning on May 1 and ending on April 30; and

WHEREAS, there are six vacancies on the Committee and four members whose terms expired on April 30, 2018; and

WHEREAS, the four members serving expired terms have all applied for reappointment and the Council has received two new applications for membership; and

WHEREAS, the City Council has reviewed the applications and determined that all applicants are qualified for service on the Committee.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND THAT the following individuals are hereby appointed to the Recreation Committee with terms to expire as indicated:
