## **Context With Key Issues**

The Community Partnership Program was established by the City Council in 2016 "to provide services that augment but do not duplicate existing City programming, advance Council priorities, and provide residents with support and resources needed to meet fundamental human needs." Providing additional opportunities for residents to enjoy activities that offer athletic, cultural and artistic benefits in a fun, free environment was identified by City staff as a fundamental need that could be addressed through the program.

A request for proposal for services designed to increase community play opportunities was developed and posted. A single proposal was submitted by Let's Play America.

Services detailed in Let's Play America's proposal include providing three (3) Community Play Days throughout the year. The proposal has been reviewed by staff and found to be in compliance with the requirements set forth in the RFP.
