# **Context with Key Issues**

The Takoma Park Folk Festival is annual music festival in Takoma Park. The festival, first held in 1978, is a free event featuring a range of music and dance, children's activities, community groups, arts and crafts, and ethnic food from around the world.

In May 2017, with the adoption of its FY19 budget, the City Council approved the allocation of grant funds in the amount of \$20,000 for the 2018 Takoma Park Folk Festival.

#### **ORDINANCE NO. 2018-**

# AUTHORIZING THE EXECUTION OF A GRANT AGREEMENT WITH TAKOMA PARK FOLK FESTIVAL, INC.

- WHEREAS, the Takoma Park Folk Festival, Inc. organizes the annual Takoma Park Folk Festival; and
- WHEREAS, the Takoma Park Folk Festival is a free event that includes music and dance performances, craft sales, food vendors, and community tables; and
- WHEREAS, recognizing the value of the Festival, the prestige it brings to Takoma Park, and the difficulties of fundraising to maintain the activity, the City Council has included \$20,000 in the FY 2019 budget to support the Festival; and
- WHEREAS, a grant agreement has been prepared setting forth the terms of the grant and providing for orderly disbursement of the funds.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND, THAT:

- Section 1. The City Manager or her designee is authorized to execute a grant agreement with the Takoma Park Folk Festival, Inc. for disbursement of up to TWENTY THOUSAND DOLLARS (\$20,000.00) to support the 2018 Takoma Park Folk Festival.
- Section 2. This Ordinance shall become effective upon adoption.
