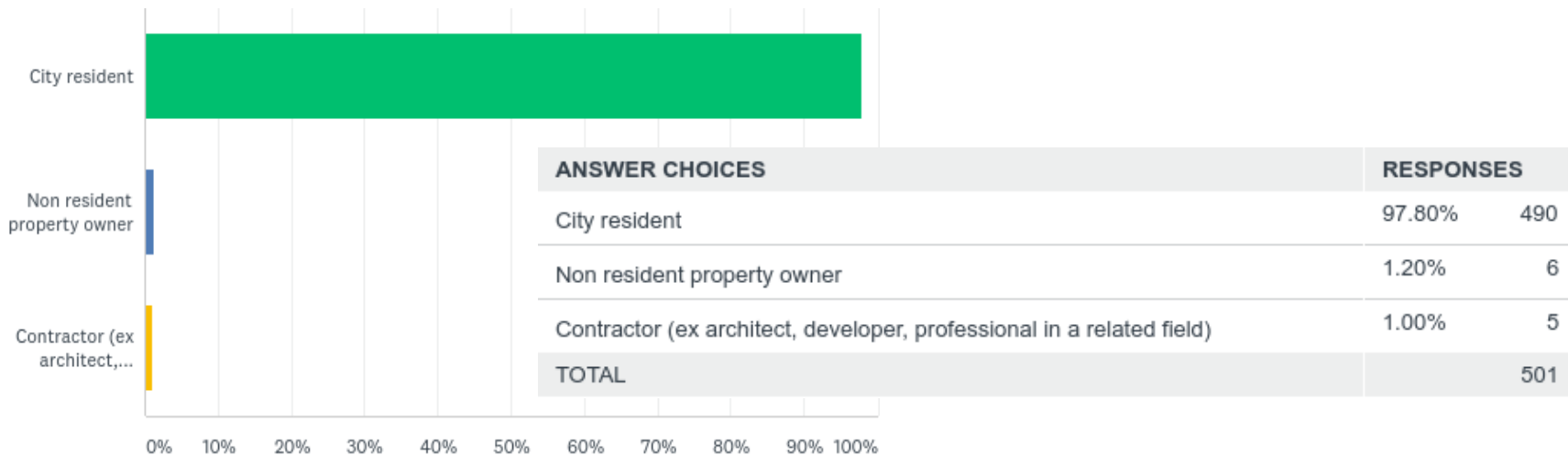

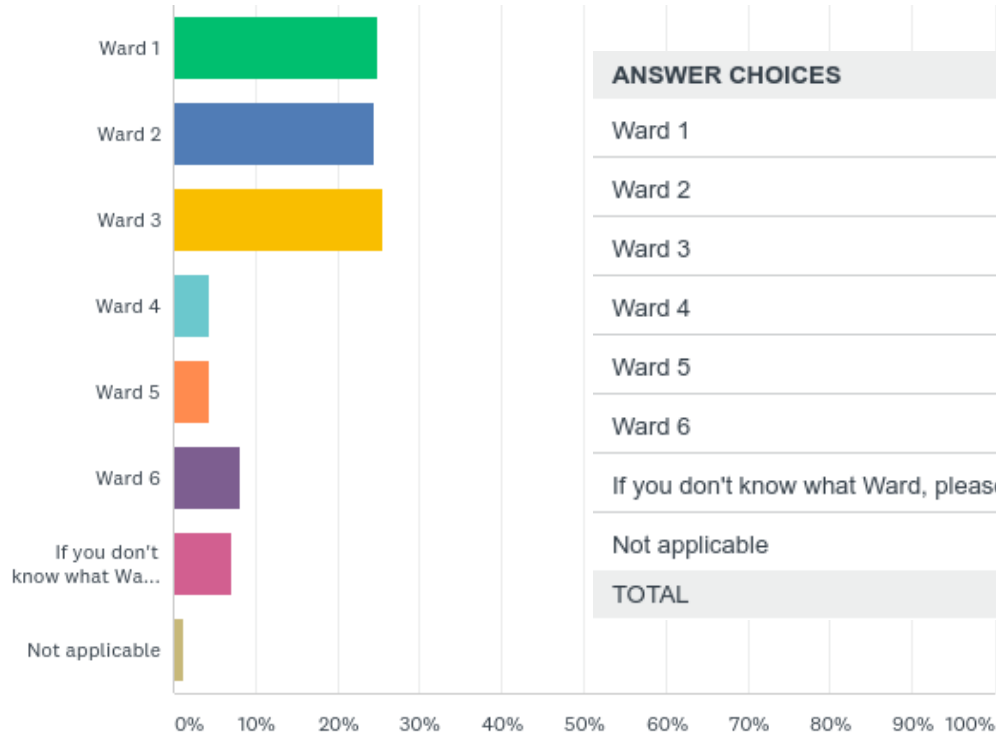

Q2: In what Ward do you live or own property?

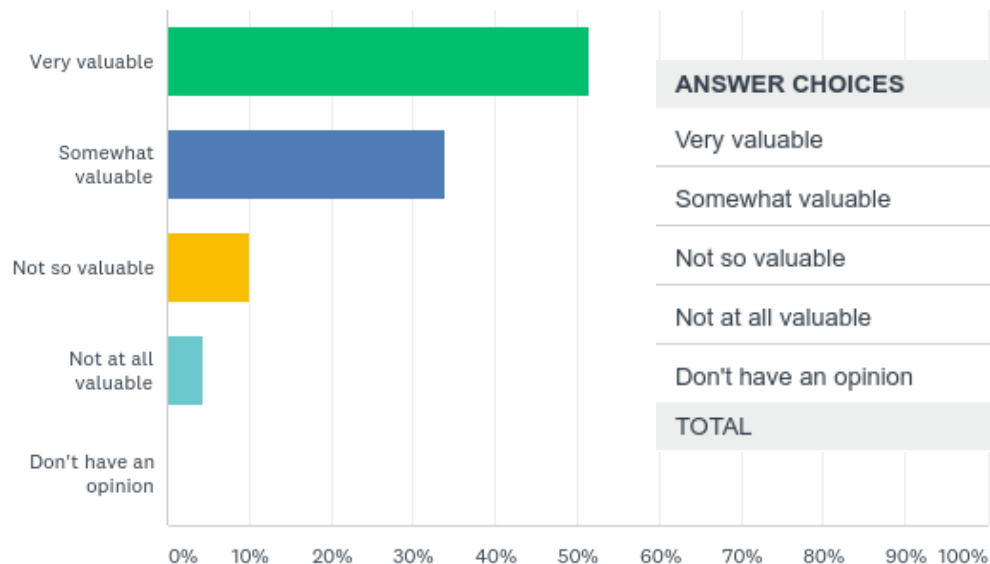

Q3: In your opinion, how valuable is the City's focus on protecting, preserving and enhancing the urban forest through the ordinance and permit requirements:

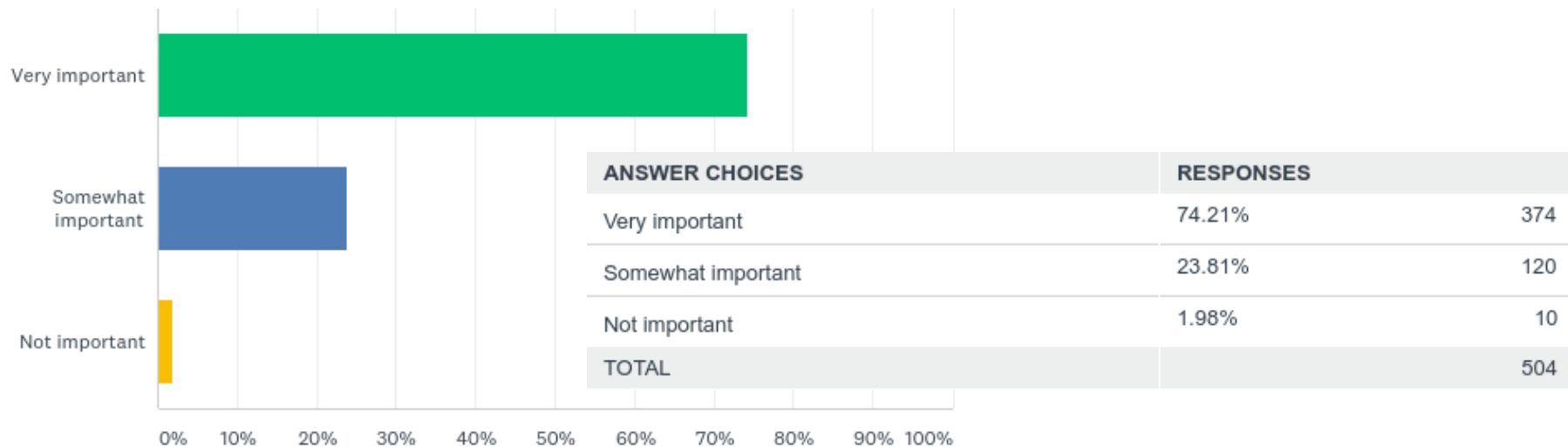

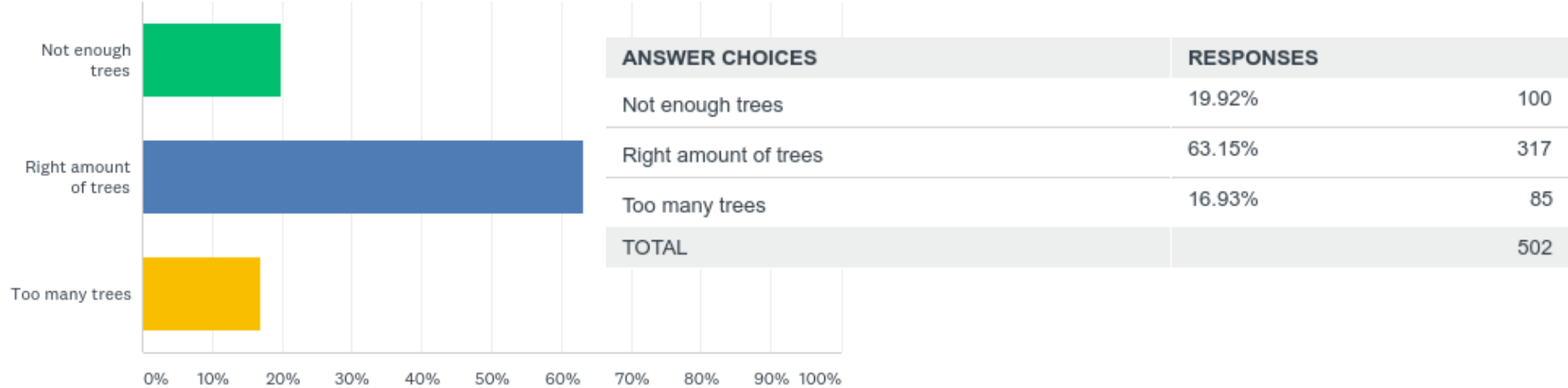
Q4: How would you rate the importance of trees to you and your neighborhood?

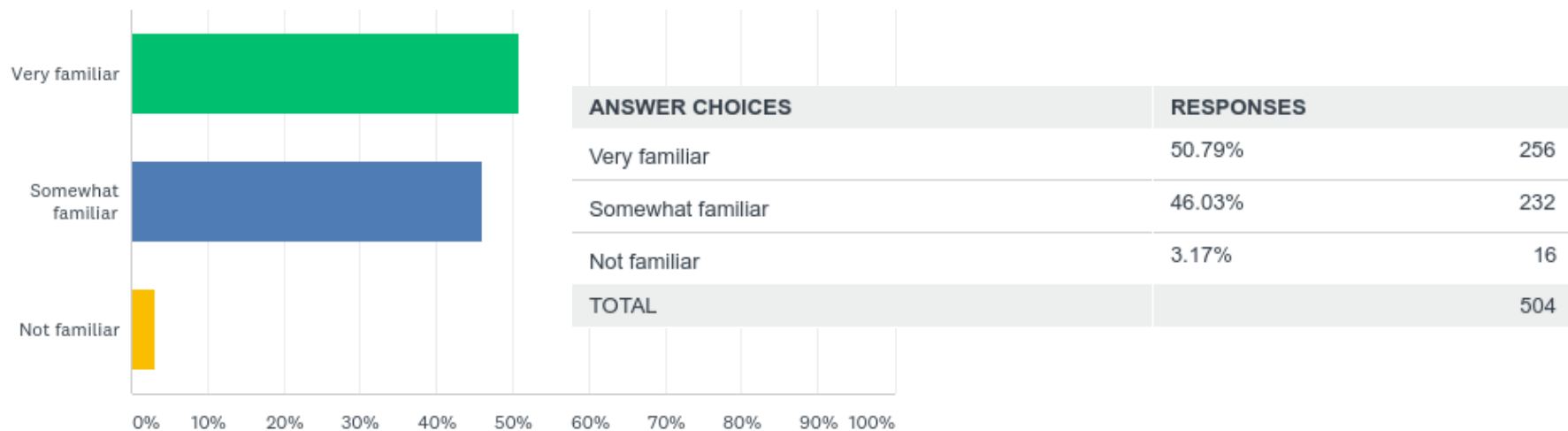
Q5: How do you feel about the number of trees in your neighborhood?

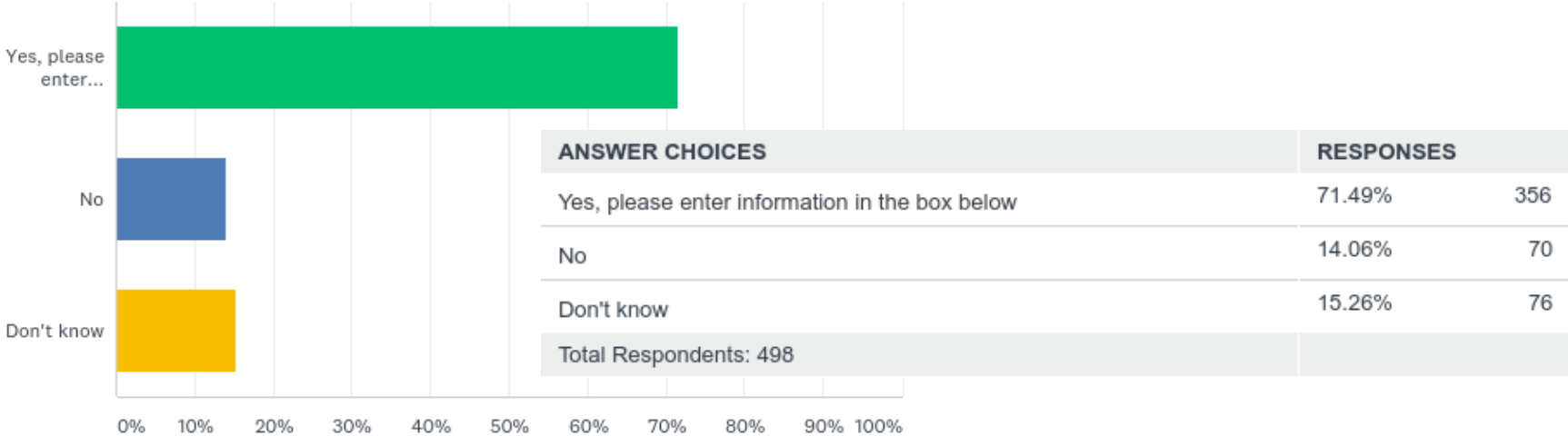
Q6: How familiar are you with the City's Tree Ordinance and permitting process?

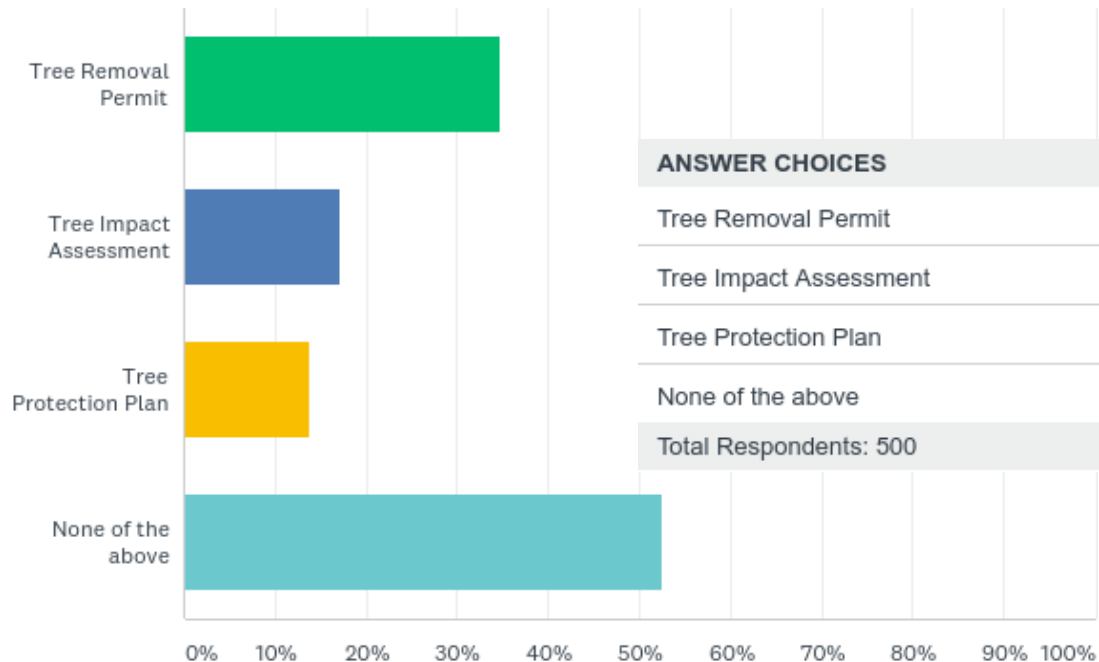
Q7: Do you think the Tree Ordinance should be changed?

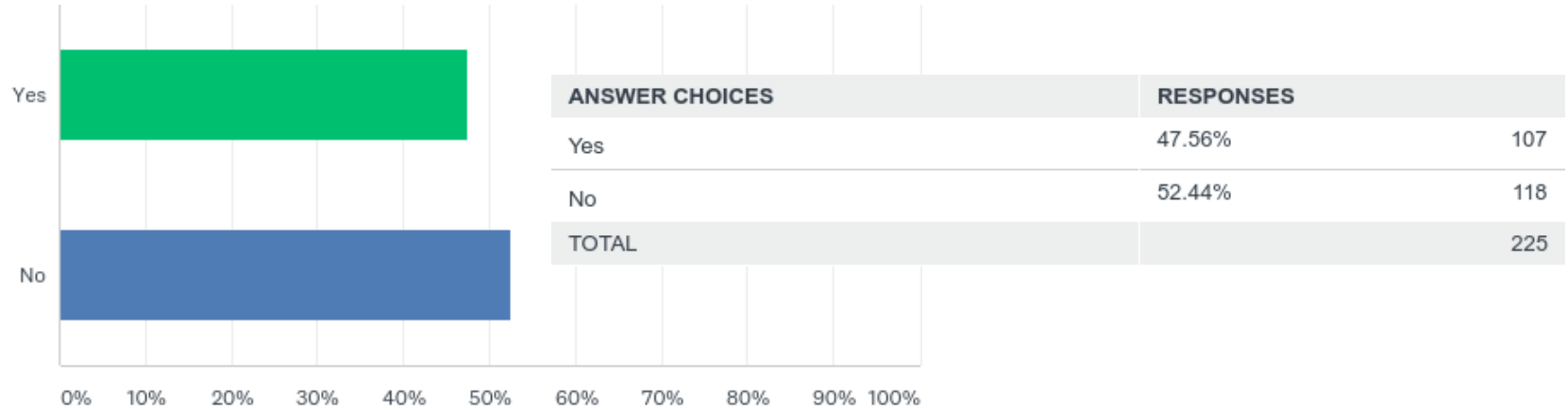

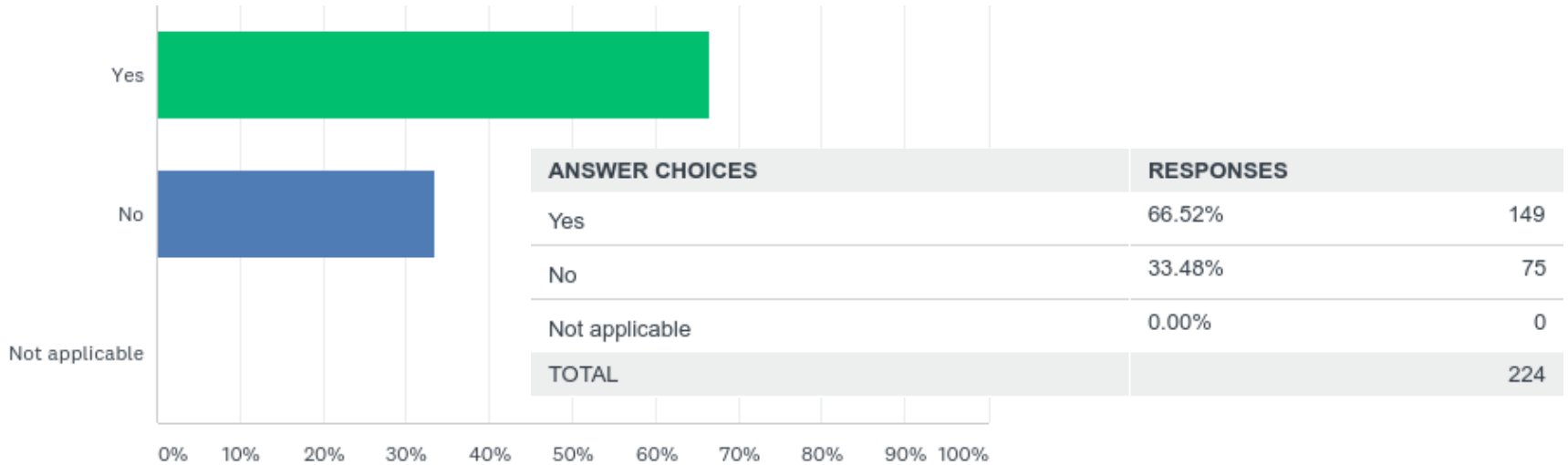
Q9: Did the application process meet your expectations?

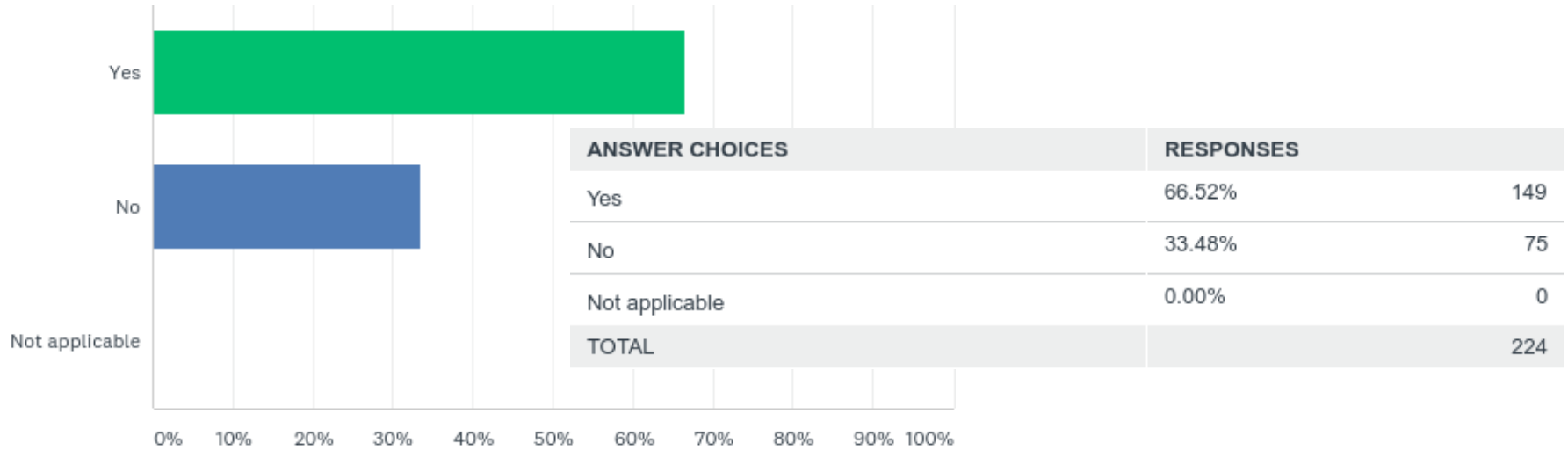
Q10: Was the application process easy to understand?

Answered: 224 Skipped: 284



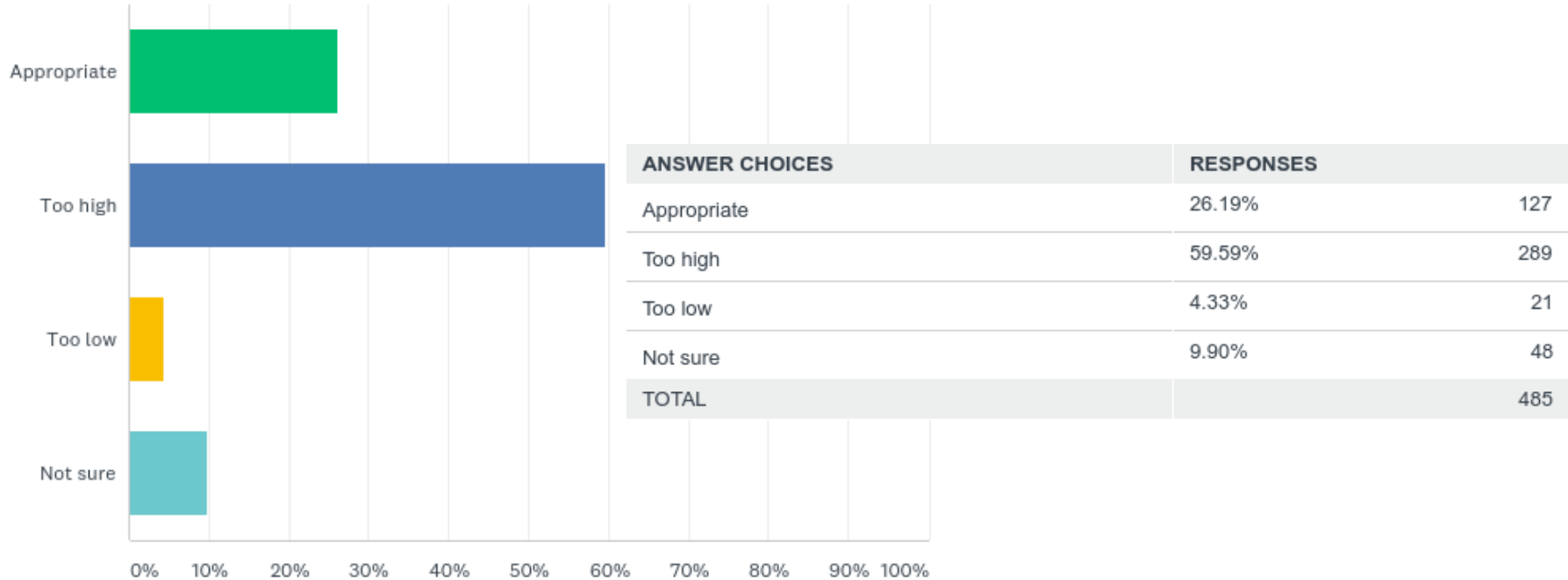
Q11: Did you receive a decision in a timely fashion?

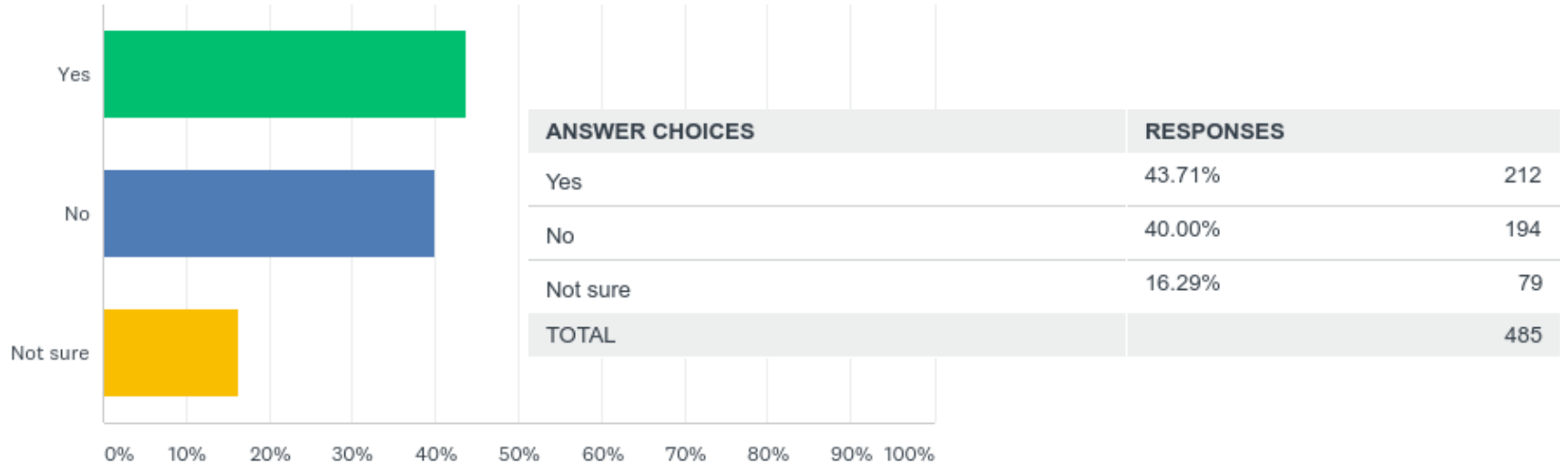
Q12: Do you think the current tree replanting requirements are:

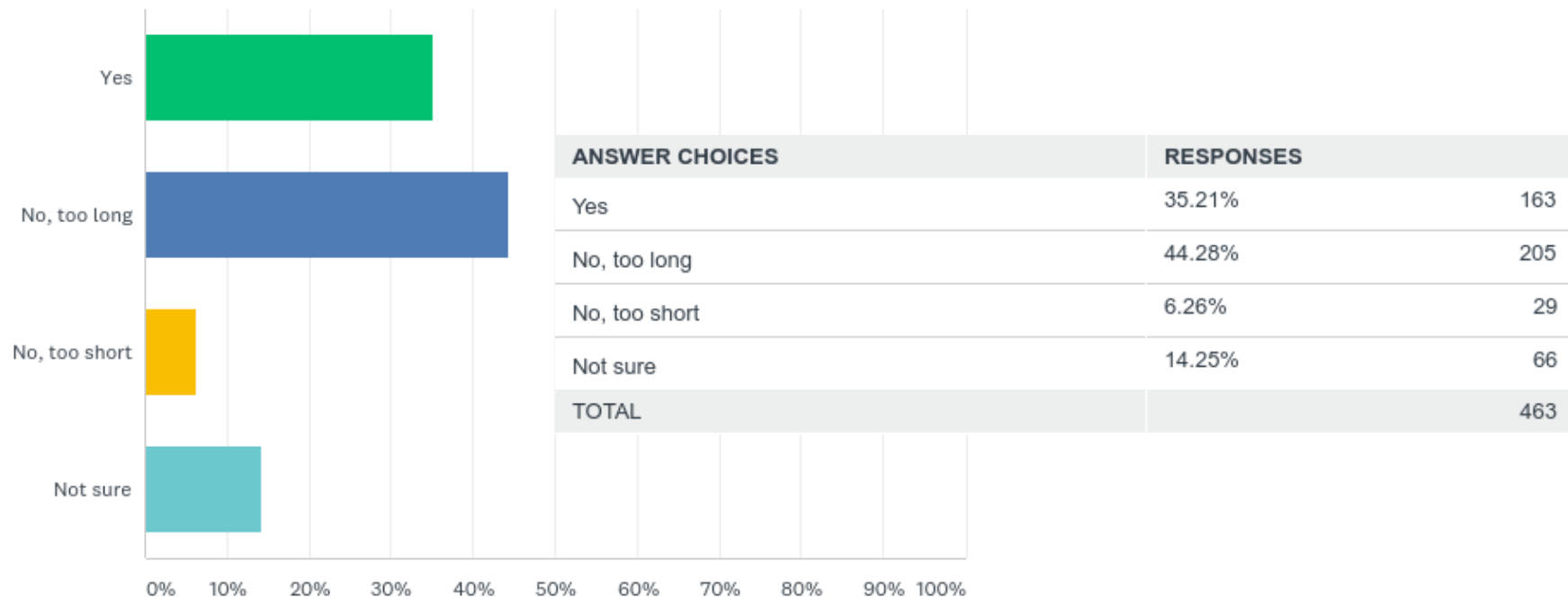
Q13: Before a Tree Removal Permit can be issued or a Tree Protection Plan approved, there is a required 15-day period for comment. Do you think a comment period should be required?

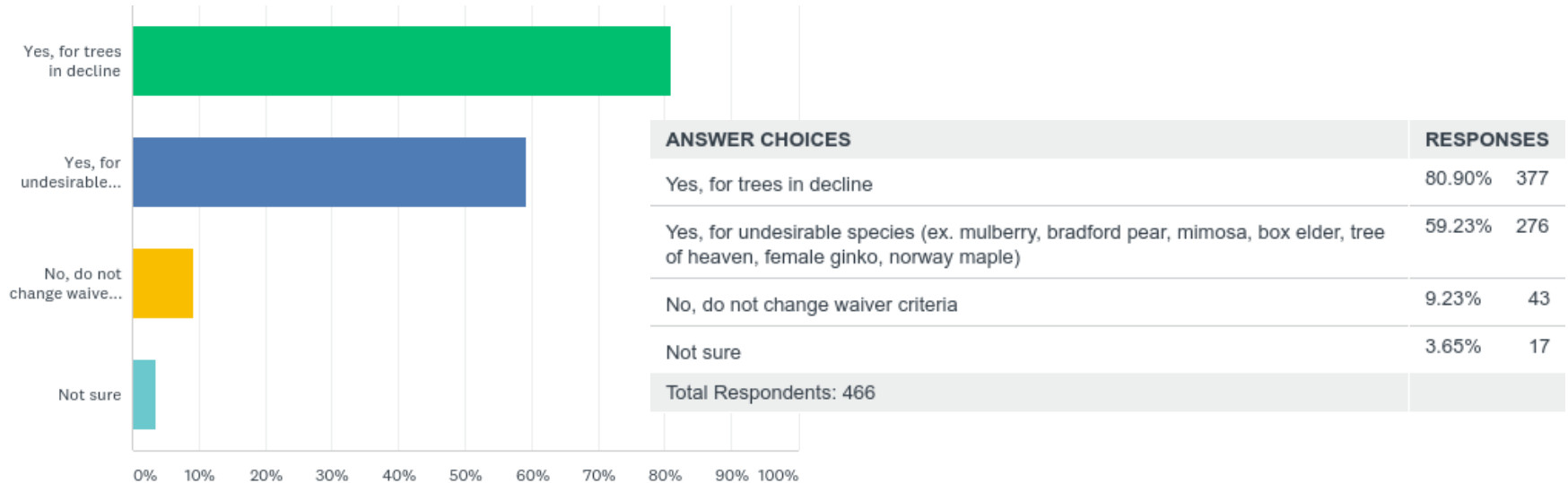
Q14: Do you think the 15-day period is the appropriate length of time for public comment?

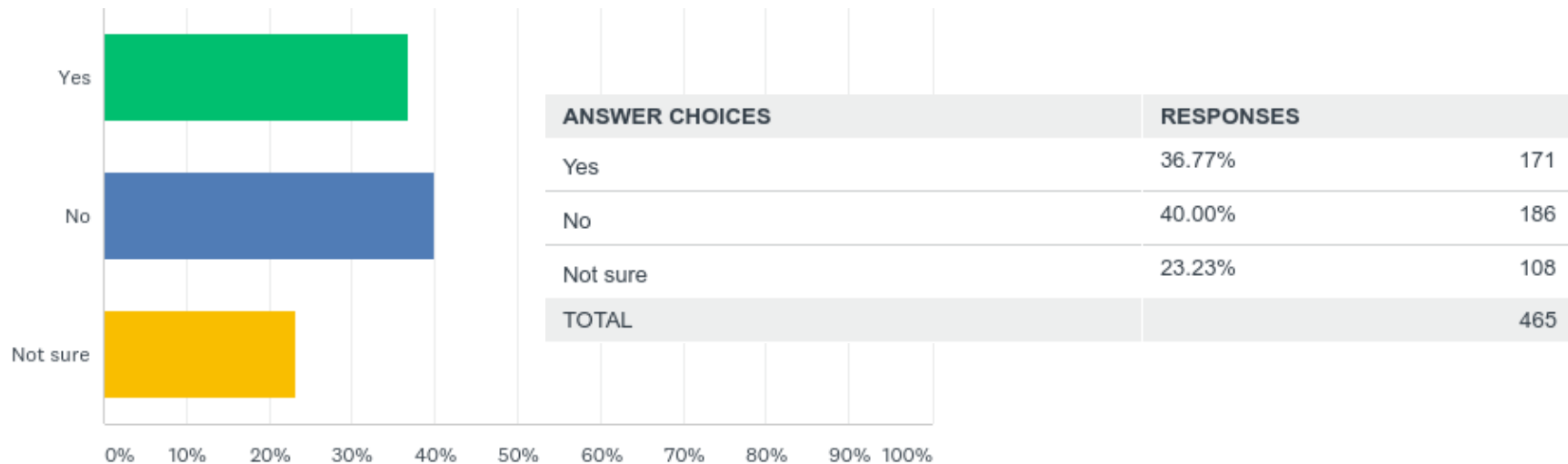

A tree is considered dead when there is no evidence of live wood, leaves or buds and hazardous if pruning or other maintenance methods cannot resolve the hazard. When a waiver is issued no tree replacement is required. Do you think the City should expand the waiver criteria to include trees in decline (likely to die within 1 to 3 years) or a tree of an undesirable species?

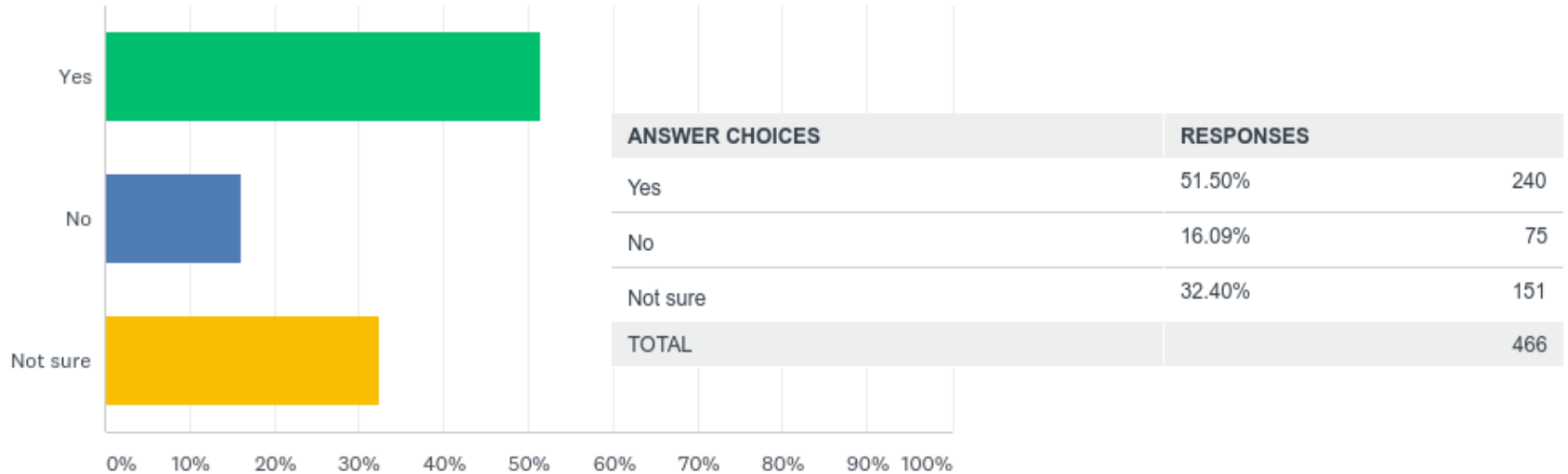

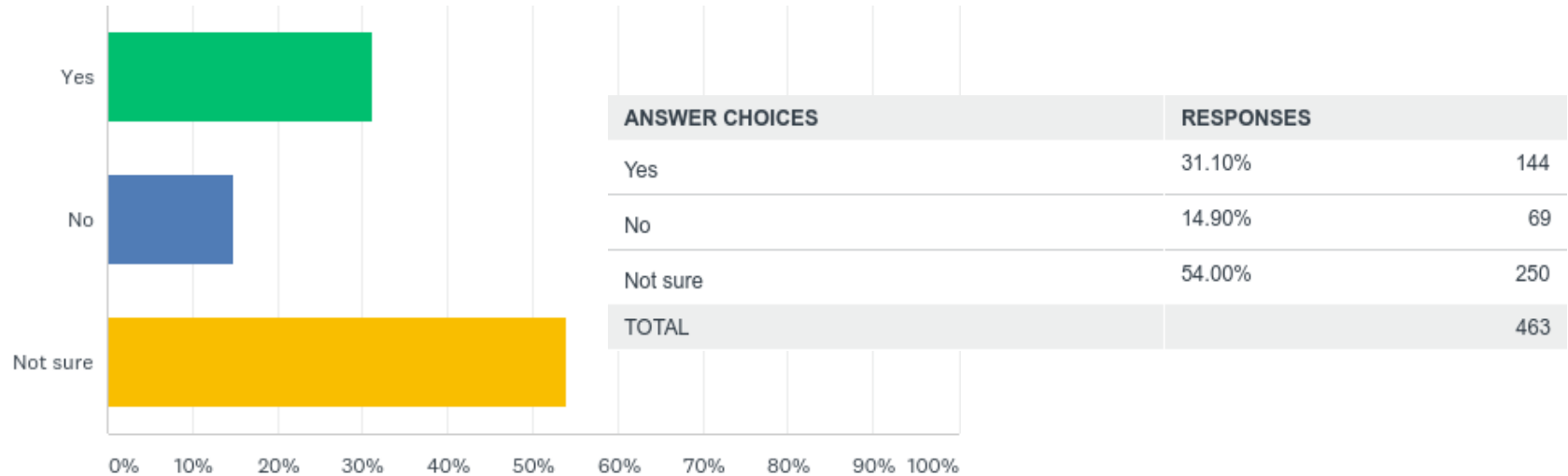

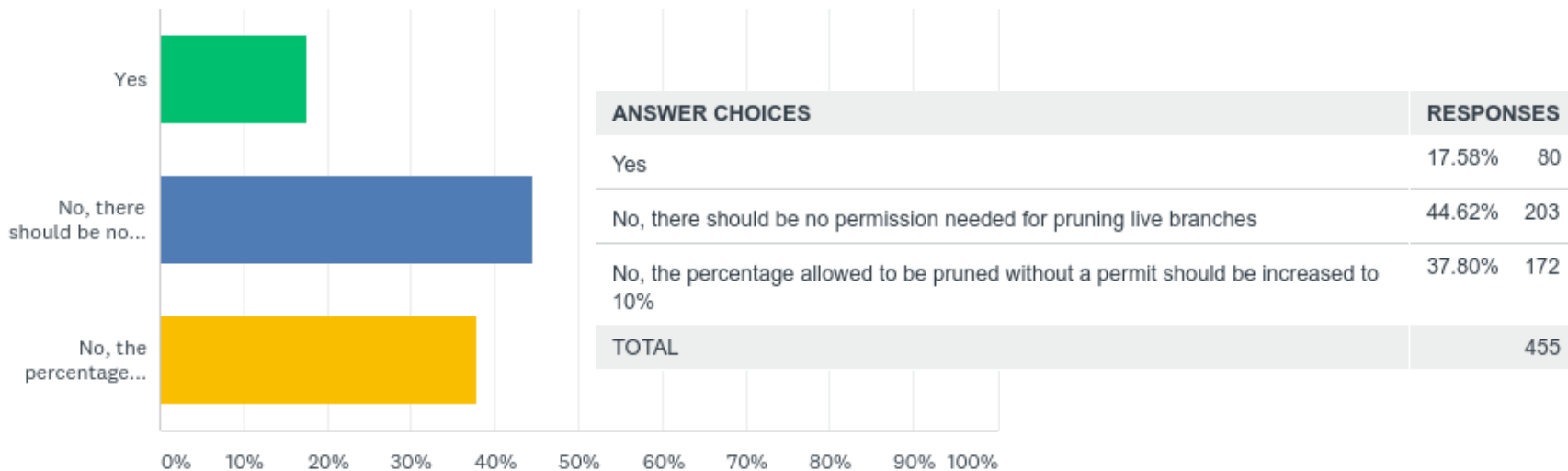
Q18: Do you think other tree related decisions should be allowed to be reviewed or appealed to the Tree Commission?

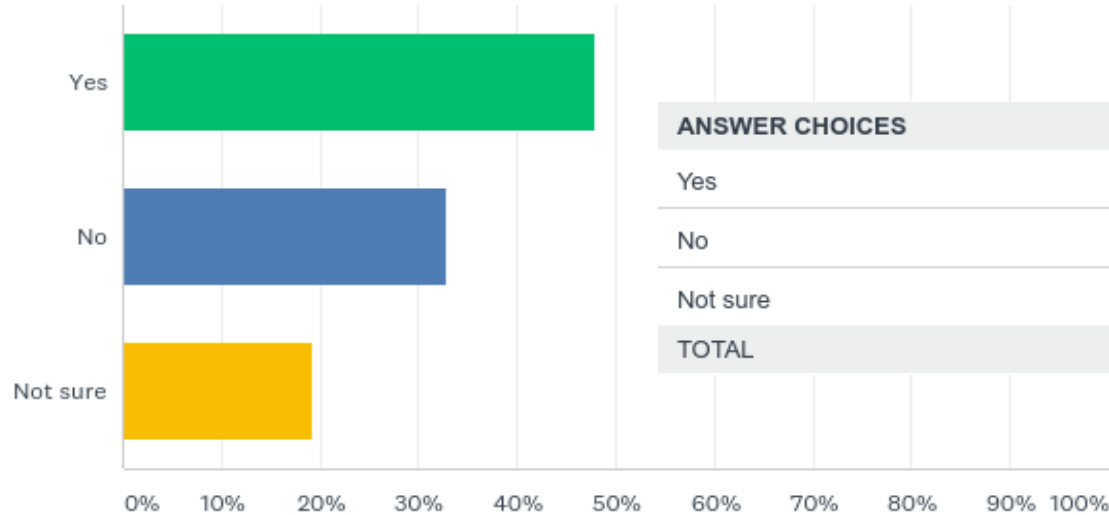
