Resolution Authorizing the Temporary Closure of Anne Street on Saturday, September 28, 2019 for a Night Market

Recommended Council Action

Review and vote on the resolution.

Context with Key Issues

The Takoma/Langley Crossroads Development Authority would like to hold the Annual Night Market on Anne Street, on Saturday, September 28 from 4:00 p.m. to 8:30 p.m. (This is one hour later than the two previous Night Markets.)

Street closure of a one-block section of Anne Street from the intersection of University Boulevard to Hammond Avenue is requested from 11:00 a.m. to 11:00 p.m. to allow for set up and clean-up.

The event will be similar to Spring Fest, with 20 food and craft vendors, a beer vendor, and a stage with sound and live music. The CDA will make the standard application to the Montgomery County Department of Liquor Control for the license to have the beer vendor and will arrange for security.

Environmental Considerations

The City's environmental codes are applicable to festivals in the City.

Fiscal Considerations

The Department of Public Works provides trash and recycling containers and barricades for the street closure and three to four hours of overtime for a staff person to pull trash/recycling during and after the event.

Racial Equity Considerations

The event is intended to celebrate local food, local culture and showcase Takoma Park's unique Takoma/Langley Crossroads neighborhood and businesses.

AUTHORIZING A TEMPORARY CLOSURE OF THE 1100 BLOCK OF ANNE STREET FOR THE TAKOMA/LANGLEY CROSSROADS NIGHT MARKET

- WHEREAS, the Takoma/Langley Crossroads Development Authority (CDA) has been organizing events in the Takoma Crossroads to enliven the area and highlight local businesses; and
- WHEREAS, the CDA has proposed to close a portion of the 1100 block of Anne Street between Hammond Avenue and University Boulevard on Saturday, September 28, 2019 from 11:00 a.m. to 11:00 p.m. for the Annual Night Market; and
- WHEREAS, the Night Market hours will be from 4:00 p.m. to 8:30 p.m.; and
- WHEREAS, the Crossroads Farmers Market operates in this location on Wednesdays and the impact of the Anne Street closure on traffic circulation and neighborhood parking is minimal and without incident.

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF TAKOMA PARK, MARYLAND authorizes the City Manager to close the 1100 block of Anne Street on Saturday, September 28, 2019 from 11:00 a.m. to 11:00 p.m. for the Annual Night Market.

BE IT FURTHER RESOLVED that the Takoma/Langley Crossroads Development Authority shall assume full responsibility for notifying residents of the 1100 block of Anne Street of the approved closures, arranging for the placement of "No Parking" signs and "Local Traffic Only" signs as necessary, restoring the area following the planned events, and ensuring that the roadway is re-opened for traffic by the designated time.
