Contract for Renovation of the Community Center Elevator

Recommended Council Action

Discuss purchase and review Ordinance

Context with Key Issues

The Fiscal Year 2020 budget includes funding for the renovation of the original elevator in the center of the Community Center building. The elevator was last upgraded in 1999 and is need of repairs and refurbishment. The existing elevator does not currently meet ADA requirements. The project was originally included in the FY19 budget, but was delayed to FY20. The FY20 Equipment Replacement Reserve includes funding of \$213,733.

The Department solicited interest from several elevator companies. The work involved is very specialized. The City received responses from two companies as follows:

Thyssenkrupp \$136,659 (base quote)

Elevator Control Service \$196,715

The bid from Thyssenkrupp did not include several items that were included in the Elevator Control Services price. These include replacement of the sump pump (\$10,892), new cab interior (\$21,430), damp proof the pit (\$6,024), and additional cost estimated at \$35,000 for building related work to include upgraded electrical connections and disposal costs. These additions bring their price to \$210,000. Additionally, Thyssenkrupp uses proprietary equipment, which can only be serviced by them in the future. The quote received from Elevator Control Services use non-proprietary equipment. The City has used Elevator Control for elevator inspections and servicing for over five years.

The Department recommends the Council award the bid to Elevator Control Services.

Environmental Considerations

This project has no environmental considerations. However, the improvements will bring the elevator cab up to Federal ADA standards.

Fiscal Considerations

Funding for this purchase is allocated in the FY 20 Equipment Replacement Reserve.

ORDINANCE NO. 2019-

AUTHORIZATION TO CONTRACT FOR ELEVATOR REFURBISHMENT

WHEREAS,	in accordance with the City procurement procedures, the Public Works Department solicited price proposals for refurbishment for the Community Center elevator; and
WHEREAS,	funds for this purchase are included in the Capital Improvement Budget; and
WHEREAS,	two vendors provided proposals for the project; and
WHEREAS,	the Department recommends the City award the contract to Elevator Control Services which provided the most comprehensive proposal.
NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND, THAT:	
Section 1.	The City Manager or her designee is authorized to enter into a contract with Elevator Control Services for the renovation of the elevator in the amount of One Hundred Ninety-Six Thousand, Seven Hundred Fifteen Dollars (\$196,715).
Section 2.	This Ordinance shall become effective upon adoption.
