Context with Key Issues

Since 2010, the City has contracted for comprehensive engineering services to assist with the implementation of the ADA sidewalk compliance program, new sidewalk design, and neighborhood traffic calming requests. The City has had multi-year contracts with two firms, Rummel, Klepper & Kahl and Whitman, Requardt and Associates, and has found their services to be exemplary. The previous contract term expired last year. These firms were awarded new contracts through the Montgomery County Department of Transportation in April 2020. The Department wishes to ride on this contract for engineering services for up to a five-year term. The County contract provides a three-year term with the option of extending for two additional one-year terms.

Council Priority

Environmental Impact of Action

Projects require designs that are compliant with environmental regulations related to tree protection, stormwater management and sediment and erosion control

Fiscal Impact of Action

Annual expenditures will depend on funds available in the Capital budget and Special Revenue budget, as well as the type and number of projects for which the contract is utilized.

Racial Equity Impact Statement

This contract renewal for engineering services is not expected to have a direct impact on racial equity, however, the process by which projects for these services get identified and selected for implementation is being evaluated by Council, committees and City staff to identify and remove racial bias.
