Fiscal Year 2021 Budget Amendment No. 2

Recommended Council Action

Approve Second Reading Ordinance for FY 2021 Budget Amendment No. 2

Context with Key Issues

The Fiscal Year (FY) 2021 Budget was adopted by the City Council on May 20, 2020. Modification to the FY21 budget is required in order to carry forward unspent funds, acknowledge a project completed in FY20 that was anticipated to be done in FY21, note a reduction in anticipated revenue regarding the County tax duplication payment, note receipt of funds from a FEMA reimbursement and for grant awards, and note a significant savings in Workers Compensation costs from what had been anticipated for FY21.

Since the Work Session on September 30, there are two changes proposed to this Budget <u>Amendment.</u> The first is to remove the receipt of FEMA COVID-19 reimbursement funds, as they should be attributed to Fiscal Year 2020. The second is to add \$50,000 to the FY21 budget to pay for facilitation services for the new Reimagining Public Safety Task Force.

Environmental Considerations

The receipt of the New Ave Bikeway Grant allows for completion of design of Section A of this important bicycle facility, furthering efforts to rely on motorized vehicles. HVAC improvements have positive environmental benefits. The Flower Avenue Green Street project completion will provide significant environmental benefits to the community.

Fiscal Considerations

General Fund (GF) Fund Balance: Net decrease \$1,048,093

- Decrease GF revenue by \$99,000
- Increase GR expenditures by \$949,093
- Non carryover General Fund decreases equal \$177,300; non carryover General Fund increases equal \$276,116 with a net non carryover balance of \$98,816.

Special Revenue Fund (SRF) Fund Balance: Net decrease \$0

- Increase SRF revenue by \$578,273.97
- Increase SRF expenditure by \$578,273.97

Racial Equity Considerations

We do not believe that the act of adopting this budget amendment will disproportionately impact any particular group. The addition of \$50,000 in Public Safety Task Force facilitation will help Black and Brown members of the Task Force be able to participate more comfortably and effectively.

CITY OF TAKOMA PARK, MARYLAND ORDINANCE NO. 2020-

FY 2021 BUDGET AMENDMENT NO. 2

- WHEREAS, the Fiscal Year (FY) 2021 budget was adopted by the City Council on May 20, 2020 and;
- WHEREAS, since this date, information has been received that requires amendments to the FY 2021 budget; and
- WHEREAS, the budget for the In lieu of Police revenue is decreased \$99,000 due to the adjustment of Tax Duplication by Montgomery County late in the County's budget process; and
- WHEREAS, the budget for the Workers Compensation expenditure decreased \$276,116 due to the premium reduction; and
- WHEREAS, the budget for the City Administration Contract expenditure is increased \$50,000 to provide for the facilitation services for the Reimagining Public Safety Task Force; and
- WHEREAS, the budget for the Flower Avenue Green Street Capital Improvement expenditure is increased \$1,146,909 to provide for the completion of the street project in 2021; and
- WHEREAS, the budget for the Facility Maintenance Capital Improvement expenditure is increased \$28,300 to provide for the completion of the HVAC improvement project in 2021; and
- WHEREAS, the expenditure and revenue budgets for the Flower Avenue-Montgomery County sidewalk project in the Special Revenue Fund are decreased \$200,000 due to the completion of the project in FY20 and the grant reimbursement submitted; and
- WHEREAS,the expenditure and revenue budgets for the WSSC Flower Avenue project in the Special
Revenue Fund are increased \$300,327.56 to provide for construction costs; and
- WHEREAS, the expenditure and revenue budgets for the New Avenue Bikeway Section A in the Special Revenue Fund are increased \$475,000 due to the new grant fund awarded to provide for the project costs; and
- WHEREAS, the expenditure and revenue budgets for the Maryland Citizens for Arts in the Special Revenue Fund are increased \$2,946.41 due to the new grant fund awarded; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND THAT:

SECTION 1. The Fiscal Year 2021 Budget is amended as follows:

General Fund - Revenues

1. Reduce \$99,000 to account 0001-33250, In Lieu of Police, due to the Tax Duplication adjustment.

General Fund – Expenditures

- 1. Appropriate \$1,146,909 to account 9100-80010, Flower Avenue Green Street Project Expenditures, to provide funds for the completion of the Green Street project.
- 2. Appropriate \$28,300 to account 9100-80008, Facility Maintenance Expenditures, to provide funds for the completion of the HVAC project.
- 3. Reduce \$276,116 to account 9000-40060, Workers Compensation, due to the premium reduction.
- 4. Appropriate \$50,000 to account 1120-61040, Contracts, to provide funds to facilitate services for the Reimagining Public Safety Task Force.

Special Revenue Fund – Revenues

- 1. Reduce \$200,000 to account 0010-39161, Flower Avenue Montgomery County Grant, due to early sidewalk project completion in Fiscal Year 2020; grant reimbursement request has been submitted.
- 2. Appropriate \$300,327.56 to account 0010-36930, WSSC Flower Avenue, to provide funds for the completion of the project in FY21.
- 3. Appropriate \$475,000 to account 0010-39162, New Avenue Bikeway, to provide funds for the project in FY21.
- 4. Appropriate \$2,946.41 to account 0010-37040, Maryland Citizens for the Arts, to provide funds for the activities in the project in FY21.

Special Revenue Fund – Expenditures

- 1. Reduce \$200,000 to account 0010-0010-68028, Flower Avenue Montgomery County expenditure, due to the early sidewalk project completion in Fiscal Year 2020 and grant reimbursement submitted during the same year.
- 2. Appropriate \$300,327.56 to account 0010-0010-80020, WSSC Flower Avenue, to provide funds for the completion of the project in FY21.
- 3. Appropriate \$475,000 to account 0010-0010-68029, New Avenue Bikeway, to provide for the project costs.
- 4. Appropriate \$2,946.41 to account 0010-0010-68018, Maryland Citizens for the Arts, to provide funds for the activities in the project.

SECTION 2. The City's Capital Improvement Program for FY 2021 shall be amended to reflect the aforementioned changes in the General Fund budget.

SECTION 3. This Ordinance shall become effective upon adoption.
