

# Takoma Park City Council Meeting – September 16, 2020 Agenda Item 4

Work Session Election Update

## **Recommended Council Action**

Review update on election planning and activities and ask questions of staff and the Board of Elections.

#### **Context with Key Issues**

The November 3, 2020 City Election will be the first one scheduled to coincide with presidential and gubernatorial general elections. Due to the pandemic, the City election will be conducted mainly by mail.

A postcard has been mailed to all households informing residents about the election.

A second mailing will go out in late September to inform registered voters that ballots will be coming in the mail. Ballots will be mailed to be received by voters around Friday, October 9 or early the following week.

Communications to voters will emphasize that the City election process is different than the presidential process, the way ballots are obtained for the two elections are different, and the completed ballots are to be sent to different locations. This will require increased communications efforts in multiple languages.

The City has contracted with Fort Orange Press to print and mail the ballots to all active registered voters. The City Clerk will mail or make ballots available to out of town registered voters upon receiving a written request. Voted ballots may be returned using the postage prepaid envelope or by placing the return envelope in a secure Takoma Park ballot drop box.

The City will deploy two secure ballot drop boxes. One box will be located at the Takoma Park Recreation Center, 7315 New Hampshire Avenue. The second box will be located at the Takoma Park Community Center, 7500 Maple Avenue. Also at the Community Center, the Montgomery County Board of Elections will place a presidential ballot drop box for the convenience of Takoma Park voters. The County BOE box will be checked and emptied by County BOE staff.

As ballots begin to arrive, Board of Elections members and staff will be scanning barcodes on ballot envelopes to record which ballots have been received. Later in October, return envelopes will be opened to check to see that oaths are signed on ballot envelopes so that we can attempt to contact voters who forgot to sign or enclose their ballot envelope.

Later in October, on dates to be announced, voter services such as voter registration, use of ballot marking devices, responding to voters' questions, etc. will be available during published hours behind the Community Center, at the main entrance from the rear parking lot.

On Election Day, there will be drive-through and walk-through voting in the Community Center rear parking lot from 7:00 AM to 8:00 PM. Voter registration and assistance with voting will be available as well.

#### **Fiscal Considerations**

The FY21 Budget includes \$57,000 for the election. The estimated cost of the election is being revised to incorporate vote by mail. The cost related to vote by mail will include printing of ballots, envelopes, and instructions, and inserting and mailing ballots to all Takoma Park registered voters. Postage for return ballots will be paid. Staff will provide a financial update at the meeting.

### **Racial Equity Considerations**

A reason for the change in election date to coincide with presidential and gubernatorial elections is to encourage more residents to vote in Takoma Park elections. It has been particularly difficult to draw in voters from Wards 4, 5, and 6, the wards with larger numbers of people of color and people who live in multifamily housing.

The change to vote by mail could negatively impact the turnout originally anticipated when the election date was changed. In preparing for 2020, staff and the Board will be focused on outreach, education, and preparation for residents to vote. When practicable, mailings to voters will be provided in English, Spanish, Amharic, and French.

# ORDINANCE NO. 2020-21 2020 Takoma Park City Election

- WHEREAS, Section 606(a) of the City Charter provides that an election shall be held on the first Tuesday after the first Monday in November of every even numbered year to elect six Councilmembers by ward and one Mayor elected at large; and
- WHEREAS, pursuant to Section 301(a) of the City Charter, the term of the Councilmembers and Mayor elected in the 2017 regular election was three (3) years, with two-year terms resuming with the 2020 regular election; and
- WHEREAS, pursuant to a pending amendment to the City Charter, the newly elected Councilmembers and the Mayor will take office on the second Monday following their election, which will fall on November 16 in 2020; and
- WHEREAS, the City Charter, in Section 607, provides that the Council, by ordinance, shall provide for said election by designating a convenient polling place or places, appointing judges of election, designating the manner of holding said election, providing the voting system to be used, and conducting said election in accordance with the Charter; and
- WHEREAS, the outbreak and spread of the novel coronavirus, known as COVID-19, has resulted in the need to limit gatherings to protect public health during the 2020 election cycle.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND, THAT:

- SECTION 1. The City Clerk shall convene the Nominating Caucus on Tuesday, September 15, at 7:30 p.m. for the purpose of nominating candidates for Mayor and City Council. The meeting shall be held online to ensure public safety. Accommodations shall be made to allow for participation by phone or other means for anyone unable to participate online.
- SECTION 2. The November 3, 2020 City Election shall be conducted by mail.
  - A. The Mayor shall be elected at large and one Councilmember for each ward shall be elected by the voters of that ward only;
  - B. A ranked choice voting system shall be used to allow voters to rank

candidates in order of choice;

- C. Ballots will allow for up to one write-in vote per contest;
- D. A ballot will be mailed to every qualified registered voter of the City;
- E. To accommodate voters who cannot vote by mail, at least one voting center will be open from 7:00 a.m. to 8:00 p.m. on November 3;
- F. Absentee voting will be available to eligible voters as set forth in Section 608 of the City Charter; and
- G. If necessary, an individual shall be permitted to cast a provisional ballot as set forth in Section 610 of the City Charter.
- SECTION 3. The City Manager, in coordination with the City Clerk and Board of Elections, is authorized to select and contract with a vendor to print, insert, and mail the ballots to eligible City voters. The City Manager shall inform the Council of the selection as soon as practicable.
- SECTION 4. Section 609 of the City Charter provides that early voting locations, days, hours and mechanisms shall be established for all elections. Because this election will be conducted by mail to limit personal contact, traditional early voting will not be conducted. The Takoma Park Board of Elections and City Clerk may arrange for and promote hours and locations for voters to seek assistance in marking and casting their ballots.
- SECTION 5. Names of qualified candidates for Mayor and Councilmember duly nominated at the Nominating Caucus on September 15, 2020 shall be listed on the ballot unless the candidate declines the nomination in writing by 5:00 p.m. on Friday, September 18, 2020. Such candidates shall meet all qualifications of the office sought.
- SECTION 6. The City Clerk shall provide paper ballots for the City Election. Pursuant to Chapter 5.16, Section 5.16.020 of the City Code, the names of candidates for Mayor, arranged alphabetically, shall appear first on all ballots, followed by the names of candidates for Councilmember, arranged alphabetically, with each ward ballot displaying the names of candidates for that ward only.
- SECTION 7. If any eligible person registers as a write-in candidate for Mayor or Councilmember in accordance with Section 605 of the City Charter, then the City Clerk shall arrange to have their name posted in any City voting location and on the City website for the purpose of identifying them as a candidate for office.
- SECTION 8. The City Clerk shall include on all ballots any advisory referendum question so adopted by resolution passed by a majority of the Council pursuant to Section 612 of

the City Charter. Any advisory referendum question shall appear last on all ballots, after the names of the candidates for Mayor and Councilmember.

- SECTION 9. A sample ballot, showing the arrangement of the candidates' names, offices, Councilmember wards, and any advisory referendum questions which will appear on the City Election ballot, shall be posted on the City website and at any voting location.
- SECTION 10. The City Clerk shall supply for the election voter lists bearing the names and addresses of all eligible voters as certified by the Montgomery County Board of Elections, and any supplemental list of voters prepared by the City Clerk.
- SECTION 11. Eligible Takoma Park residents may register up to and including the day of the election, pursuant to Section 603(c) of the City Charter.
- SECTION 12. Members of the Takoma Park Board of Elections shall serve as Judges of Election and may appoint Election Workers to assist with the election and with canvassing the ballots.
- SECTION 13. Election Judges and other Election Workers are eligible to receive payment equal to the schedule for Montgomery County Election Judges and Election Workers.
- SECTION 14. The City Manager may authorize hazard pay for Election Judges and Election Workers and provide for any and all necessary measures to protect the health of the election workers as well as ensure transparency of the process.
- SECTION 15. All Election Judges and Election Workers must participate in training arranged by the City Clerk and/or Board of Elections in order to receive payment for their service.
- SECTION 16. The Board of Elections shall ensure the secrecy of the ballot, correct counting of votes, the tabulating and recording of votes by ward for or against any candidate or question, and the prompt reporting of election returns.
- SECTION 17. The Board of Elections shall ensure that the canvass and tabulation of ballots is conducted in a transparent manner, while providing for physical distancing and other accommodations to protect public health. Such accommodations may include, but are not limited to, video broadcasting of canvassing and tabulation, and permitting inperson viewing but limiting the number of people in a facility where canvassing and tabulation is being conducted, requiring representatives of candidates and the press to schedule and stagger their observations of canvassing and tabulation, or other similar arrangements.
- SECTION 18. In each contest, the candidate receiving a majority of votes shall be declared elected. If no candidate receives a majority of first choices, the Election Judges shall apply

the ranked choice voting rules detailed in Section 606 of the City Charter.

- SECTION 19. The Board of Elections shall meet to determine and certify the results of the election and shall present the certification of results to the City Council at a special meeting at 7:30 p.m. on Thursday, November 12, 2020.
- SECTION 20. This Ordinance shall become effective upon adoption.
