



Takoma Park City Council Meeting – September 8, 2021 Agenda Item 2

Work Session

Continue review of code changes for city committees, commissions and boards.

Recommended Council Action

Hear and discuss suggested code changes for city committees, commissions and boards, that reflect Council discussions and Council subgroup recommendations in previous work sessions.

Context with Key Issues

Currently there are 16 Council-appointed volunteer boards, commissions and committees, as distinct from short-term task forces. The Council has identified a priority of reviewing the existing structure, appointment processes, and practices for Council-appointed committees to increase efficiency and effectiveness, attract new members, and explore innovative ways to engage residents who tend to be harder to reach. The desired outcome is to enable more diverse, engaged, productive, and rewarding committee membership. At this work session, code changes that reflect Council discussions and Council subgroup recommendations in previous work sessions will be presented and discussed.

Council has been in the process of a series of work sessions over the past few months, from February to July, to finalize progress toward achieving these goals. In June 2021 the Council extended existing committee appointments to Oct. 15, to allow time to implement changes as well as to recruit and appoint new members. Work sessions have focused on defining an overall purpose for committees, factors for considering whether to create or continue a committee on a particular issue, applying these factors to existing committees, boards and commissions. Some of these actions require code changes. Other topics have been administrative and operational improvements, as well as the recruitment and appointment process this summer and fall leading to appointments in October. Committees and their members have had the opportunity to contribute to the discussions.

At the January 2021 Council priorities retreat, initial recommendations were presented. An informal working group of staff and Council members reported in June 2020 to Council on preliminary recommendations and results of a survey of committee members past and present, which highlighted issues of relevancy and purpose, lack of diversity in committee membership, and need for training and administrative improvements. Feedback from committees over the summer largely supported these concerns. City staff participating in a GARE cohort worked on diversity in committee membership as their project, and their feedback was to consider the committee system as a whole, topic areas, relevancy to all residents, and relationship to other ways to accomplish same purposes. Council also adopted a Code of Conduct for committee members (Resolution 2020-22, October 7, 2020).

At the September 8 work session, code changes that reflect Council discussions and Council subgroup recommendations in previous work sessions will be presented and discussed. Recommended code changes would:

- Establish a common membership, terms, and purposes;
- Provide limited exceptions for specific committees;
- Retain specific code language for quasi-judicial and regulatory groups;
- Streamline code language for non-regulatory standing committees; and
- Codify the Youth Council and Grants Review Committee.

Building on previous discussions, the code changes would:

- Continue five quasi-judicial & regulatory groups and five standing committees (and address minor code issues after reappointments);
- Discontinue three groups – Personnel Appeal Board, Facade Advisory Board, Commemoration Commission;
- Continue for now pending further discussion – Noise Control Board, in context of public safety discussion, and Nuclear Free Committee, pending outcome of proposed Sustainable Investing Task Force; and
- Discontinue two groups in their current form: Committee on the Environment (reconstitute in code as Sustainable Maryland Committee) and Complete Safe Streets Committee (consider a future Vision Zero Task Force).

Council Priority

Engaged, Responsive & Service-oriented Government: Improve and Formalize Systems for Council-Appointed Committees.

Goal: Improve and formalize systems for Council-appointed committees.

Strategy: Review existing structure, appointment processes, and practices for Council-appointed committees, and make changes to increase efficiency and effectiveness and attract new members; explore innovative ways to engage residents who tend to be harder to reach.

Desired outcome: Diverse, engaged, productive, and rewarding committee membership.

Environmental Considerations

There is no direct environmental impact from the review of the Council-appointed committees. A Council action related to the Committee on the Environment or other committees focused on climate-change or sustainability initiatives could have a positive or negative impact on environmental initiatives in the future, depending on final direction in this area and the future work of the committee.

Fiscal Considerations

Some of the recommendations related to recruitment activities and member supports, such as stipends or childcare/transportation reimbursement or services, have possible staff and budget impacts. Estimated costs will be considered in decisions about adopting changes.

Racial Equity Considerations

Existing Council-appointed committees do not generally reflect the diversity of the population of Takoma Park, as shown by the survey of committee members and data collected. Improvements in recruitment, training, operations and support of committees and committee members have the potential to create more diverse and representative Council-appointed committees and to bolster their capacity to incorporate racial equity considerations in all their committee work.

1 **Article 1. Advisory Committees - General Provisions.**

2
3 **2.16.010 Advisory Committees.**

4 A. The City Council may establish by ordinance any advisory committee it deems necessary. In
5 addition to other duties assigned, advisory committees are charged with:

6
7 1. Providing the City Council with tangible recommendations in key priority areas.

8
9 2. Leveraging residents' technical expertise and lived experiences to inform City
10 policies and programs.

11
12 3. Ensuring that the Council has regular and timely information to use when
13 considering its priorities or important issues.

14
15 4. Providing an opportunity to engage residents on issues that are important to them
16 as well as to assist in community education and engagement activities in their priority areas.

17
18 B. The authority of such entities is limited to that extended to it by the City Council.

19
20 C. Each Committee is required to report the status of its work annually or at the request of the
21 City Council. Council shall review each committee's report and may concurrently undertake a
22 review of each Committee's purpose, duties, other assigned tasks, and adjust them as
23 necessary.

24
25 D. Membership of advisory committees shall be in accordance with the provisions of this section
26 unless otherwise provided by City Code.

27
28 1. Only City residents may serve on a committee.

29
30 2. Individuals interested in serving on a committee may apply in accordance with
31 procedures and time frames set forth by the City Council and shall be confirmed and
32 appointed by a majority vote of City Council.

33
34 3. A member who has served on a committee for six years continuously, may not be
35 reappointed to the same committee until one year has elapsed since the end of that
36 member's previous tenure.

37
38 4. A member who is term limited may apply to serve on a Committee for which the
39 member is not term limited.

40
41 E. Organization.

42
43 1. Unless otherwise stated in the Code or directed by Council, each advisory
44 committee should consist of up to nine members.

1
2 2. Each committee shall operate under a common set of procedural rules, which shall
3 be prepared by the City Attorney's office and be approved by Council.
4

5 3. Each committee shall elect from its members the following officers: chairperson,
6 vice chairperson, and secretary. Officers shall serve for a period of one year at which time
7 each committee shall elect again the officers. The chairperson shall be elected annually,
8 but may only serve in that capacity for two consecutive years. The Chairperson may not
9 hold two offices simultaneously.
10

11 F. Meetings.
12

13 1. Committees shall meet at least quarterly or as often as required to fulfill their
14 purposes.
15

16 2. All meetings shall be open to the public and are subject to Maryland's Open
17 Meetings Act. Meeting notices and agendas shall be prepared and submitted to the City
18 Clerk and posted in advance of any committee meeting in accordance with State law.
19 Written records of proceedings and attendance shall be maintained by the committee and
20 provided to the City Clerk for safe keeping. A report on the activities of each committee
21 shall be submitted to the City Clerk and Council once per year.
22

23 3. Meetings shall be held at times that facilitate and allow for committee member
24 attendance and ease of public attendance.
25

26 4. A majority of a committee shall constitute a quorum.
27

28 5. Meetings shall take place at a City government building or other publicly accessible
29 location approved by the City Manager. The meetings may occur in person or virtually,
30 so long as such is announced in advance. Meetings may include a virtual attendance option
31 for members and for the public.
32

33 6. At least three members of every committee must maintain current Open Meetings
34 Act certification and provide a copy of the certification to the City Clerk.
35

36 G. Each committee shall designate an individual who shall be responsible for preparing meeting
37 agendas and minutes, and coordinate publishing and storage of the same with the City Clerk.
38

39 H. Staff liaison. The City Manager shall assign a member of the City staff to act as a staff liaison
40 to each committee, who shall provide general support to the committee.
41

42 I. Member Conduct.
43

1 1. Members are expected to attend each meeting of the committee on which they
2 serve. Members may miss a scheduled meeting for cause.

3
4 2. Members are expected to adhere to the Code of Conduct established by the Code
5 of Conduct for Council-Appointed Members of Boards, Committees, Commissions, and
6 Task Forces (Resolution 2020-22, Oct. 7, 2020).

7
8 3. Council, **by resolution**, may remove a member from their position upon finding a
9 violation of the Code of Conduct, no longer meeting the requirements for membership, or
10 otherwise not fulfilling the duties of a member.
11

12 **2.16.01020 ~~Membership of statutory Council-appointed~~ Terms of advisory committees.**

13
14 A. Except as noted elsewhere in this Chapter, beginning in 2021, the initial term for half of a
15 committee's members will end on June 30, 2022. The initial term for the other half of a
16 committee's members' terms will begin in 2021 and end June 30, 2023. **If there are an odd**
17 **number of appointees, the odd number appointee shall be considered part of the term having the**
18 **later expiration date.**

19
20 B. Except as noted elsewhere in this Chapter, after the initial terms have expired, all terms of
21 office will be staggered terms of two years. Said terms shall begin on July 1st and end June 30th.

22
23 C. The total terms of office for members of a committee shall be no more than six continuous
24 years unless otherwise provided in this Chapter.

25
26 D. A member appointed to fill a vacancy shall serve the remainder of the term of office that
27 became vacant.

28
29 E. Below is a table containing each advisory committee, the term length, and the expiration

8 **Article 7. Youth Council**

9 **2.16.190 Council established.**

10 There is established a Takoma Park Youth Council.

11 **2.16.200 Statement of purpose.**

12 The purpose of the Youth Council is to serve in an official advisory and coordination role to the
13 City Council on all matters related to and of importance to youth.

14 **2.16.210 Duties and responsibilities of the Council.**

15 A. To provide an opportunity for the youth of Takoma Park to acquire a greater knowledge of and
16 appreciation for local government through active participation in the system.

17
18 B. To help the City Council to address and accomplish the goals of this community by working
19 directly with the representatives of youth.

20
21 C. To serve the youth of Takoma Park by: informing the Takoma Park municipal government of
22 the needs and wishes of youth; planning and implementing social, educational, cultural and
23 recreational activities for the youth; working with the Mayor, City Council, City department
24 heads, schools, civic clubs, and service organizations to provide service and leadership
25 opportunities for the youth of the City; and, helping to instill a feeling of positive self-worth
26 and esteem, teaching respect for the rights of others, and promoting community pride.

27 **2.16.220 Membership.**

28 A. The Youth Council shall consist of up to eleven Takoma Park youth appointed by the City
29 Council representing a cross-section of the City's youth.

30
31 B. The Youth Council shall report to the City Council the names of the elected Chairperson and
32 Vice Chairperson.

33
34 C. All members shall be in grade levels 7 through 12, except the Chairperson shall be in the 11th
35 or 12th grade.

1
2 D. The term of each member shall be one year. Members are eligible to reapply annually if they
3 meet member eligibility requirements.

4
5 E. Members must meet the following qualifications:

6
7 1. Remain residents of the City and the ward they may represent;

8
9 2. Attend meetings on a regular basis and inform the Youth Council of absences prior to
10 meetings;

11
12 3. Maintain at least a 2.5 grade point average for the current school year;

13
14 4. Fulfill the responsibilities of the office held; and

15
16 5. Set an example for youth in the community.

17
18 F. In addition to other bases for removal set forth in this Chapter, a member can be removed
19 from the Youth Council if they fail to sustain any of the above qualifications and by a majority
20 vote of the members, subject to the approval of the City Council or City Manager.

22 G. Vacancies shall be filled by the City Council for the remainder of the unexpired term.

23
24 H. Members shall be appointed annually at the start of the school year and shall serve one-year
25 terms.

27 **Article 8. Nuclear Free Committee**

28 **2.16.230 Committee established.**

29 There is established a Takoma Park Nuclear Free Committee. Committee members shall have
30 collective experience in the areas of science, research, finance, law, peace and ethics.

31 **2.16.240 Statement of purpose.**

32 The purpose of the Takoma Park Nuclear Free Committee is to fulfill the duties and responsibilities
33 assigned to it by the City Code and to perform such other tasks as Council may direct from time
34 to time.

35 **2.16.250 Duties and responsibilities.**

36 The Committee shall have the following duties and responsibilities:

37 A. The Committee may review any work within the City which it has reason to believe is not
38 in compliance with Section 14.04.040 of this Act. The Committee shall notify the City Council
39 and the City Manager inform appropriate legal authorities of a suspected violation of this Act.

40 B. The Committee shall review existing City contracts, awards, purchase orders and

1 investments and may review proposed contracts, awards, purchase orders and investments to
2 assure compliance with Sections 14.04.050 and 14.04.060 of this Act. If the Committee finds any
3 contracts, awards, purchase orders or investments in violation of this Act, it shall, in conjunction
4 with the City Manager ~~Administrator~~, make recommendations to the Mayor and Council regarding
5 the existence of reasonable alternatives.

6 C. The Committee, in conjunction with the City Manager ~~Administrator~~, shall propose a
7 socially responsible investment policy and implementation plan as specified in Section 14.04.050
8 and, upon the adoption of the policy and plan, shall annually thereafter review the investment
9 policy to ensure its conformity to this Act.

10 D. The Committee shall, through the collection of materials, newsletter articles, cable
11 television programming, public forums and other means, provide public education and information
12 on issues related to the intent and purpose of this Act. In performing this task, the Committee shall
13 cooperate with City staff, the Nuclear Freeze Task Force and other interested community groups
14 and individuals.

15 E. The Committee shall maintain a collection of current materials concerning the production
16 of nuclear weapons and the components thereof and the transportation of high-level nuclear waste
17 resulting from the production of nuclear weapons and nuclear energy. From this information and
18 from consultations with individuals and organizations involved in the nuclear weapons and nuclear
19 energy debate, the Committee shall annually prepare and report to the City Council a list of nuclear
20 weapons producers to guide the City, its officials, staff and agents in the implementation of
21 Sections 14.04.050 and 14.04.060 of this Act. The Committee shall also make recommendations
22 to the City Council from this information and from consultations with individuals and
23 organizations involved in the transportation of high-level nuclear waste on how best to promote
24 the safety and welfare of the City from harmful exposure to high-level nuclear waste.

25 F. Before a waiver of the provisions of Sections 14.04.060(A), (B) or (C) ~~above~~ pursuant to
26 Section 14.04.060(F) may be sought, the Committee, in conjunction with the City Manager
27 ~~Administrator~~ or his or her designee, shall conduct a diligent search to determine the availability
28 of reasonable alternative sources for a necessary product or service, except, however, the City
29 Manager ~~Administrator~~ or his or her designee and/or the Committee's unwillingness or inability
30 to conduct such a search shall not preclude actions by the Mayor and Council pursuant to Section
31 14.04.060(F). (Ord. 2005-29 (part), 2005/prior code § 8A-12)

- 15 A. Boards and commissions are charged with the duties assigned to them in the City Code.
- 17 B. The authority of such entities is limited to that extended to it by the City Code and other
18 applicable law.
- 20 C. Each board and commission are required to report the status of its work annually or at the
21 request of City Council.

1 D. Membership of boards and commissions shall be in accordance with the provisions of this
2 section unless otherwise provided by City Code.

3
4 1. Unless provided otherwise in the applicable section of the City Code, only City residents
5 may serve on boards and commissions.

6
7 2. Members of a board or commission may apply to serve and shall be confirmed and
8 appointed by a majority vote of City Council.

9
10 3. Beginning in 2021, the initial terms for one-third of a board or commission's members will
11 end on June 30, 2022, one-third of the members will expire on June 30, 2023, and one-third
12 will expire on June 30, 2024. In the event that the membership of board or commission is not
13 evenly divisible by three when creating the staggered terms, the appointments shall be evenly
14 distributed in the one year and two year staggered terms. The three year staggered term shall
15 contain the odd number of appointments.

16
17 4. After the initial terms have expired, all terms of office will be staggered three-year terms.
18 Said terms shall begin on July 1st and end June 30th.

19
20 5. Vacancies may be filled by the Council for the remainder of any unexpired term.

22 D. Organization.

23
24 1. Each board or commission shall consist of the number of members stated in the provisions
25 of the City Code establishing each board or commission.

26
27 2. Each board and commission shall operate under a set of rules of procedure necessary to
28 accomplish its purposes, which shall be provided by the board or commission to Council for
29 review by the City Attorney periodically, but not less than every five years.

30
31 E. Meetings.

32
33 1. Boards and commissions shall meet at least once every quarter or as often as required to
34 fulfill their purposes.

35
36 2. All meetings shall be open to the public and are subject to the Maryland Open Meetings
37 Act unless otherwise permitted or required by applicable law. Meeting notices and agendas
38 shall be prepared and submitted to the City Clerk and posted in advance of any meeting in
39 accordance with State law. Written records of proceedings and attendance shall be maintained
40 by the board or commission and provided to the City Clerk for safe keeping. A report on the
41 activities of each entity shall be submitted to the City Council once per year and as directed by
42 Council.

1 3. Meetings shall be held at times that facilitate and allow for member attendance and ease of
2 public attendance.

4 4. Meetings must take place at a City government building and may occur in person or
5 virtually, so long as such is announced in advance. Meetings may include a virtual attendance
6 option for members and for the public.

7
8 5. At least three members of every board and commission shall maintain current Open
9 Meetings Act certification and provide a copy of the certification to the City Clerk.

10
11 6. Each board and commission shall designate an individual who shall be responsible for
12 preparing meeting agendas and minutes, and coordinate publishing and storage of the same
13 with the City Clerk.

14
15 F. Staff liaison. The City Manager shall assign a member of the City staff to act as a staff liaison
16 to each board and commission, who shall provide general support to the board or commission.

17
18 G. Member Conduct.

19
20 1. Members are expected to attend each meeting of the entity on which they serve. Members
21 may miss a scheduled meeting for cause. A member who misses more than one-third of the
22 meetings of the entity on which they serve in any calendar year may face removal from the
23 same.

24
25 2. Members are expected to adhere to the Code of Conduct established by the City Council
26 for Boards, Commissions, Committees, and Task Forces (Resolution 2020-22, Oct. 7, 2020).

27
28 3. Council may remove a member from their position upon finding a violation of the Code of
29 Conduct, no longer meeting the requirements for membership, or otherwise not fulfilling the
30 duties of a member.

32 **2.17.025 Interpretation of Chapter 2.17.**

33 Chapter 2.17 shall be interpreted as supplementing existing Code provisions establishing quasi-
34 judicial Boards and Commissions to promote uniformity in organization, membership, and
35 procedures where applicable. If any provision in this Chapter 2.17 is interpreted as conflicting
36 with another provision of the City Code addressing City Boards and Commissions, the non-

6 **3.04.050 Ethics Commission.**

7 A. There shall be a City Ethics Commission, which is composed of up to seven members
8 appointed by the Council. The Commission shall have the following responsibilities:

9 1. To devise, receive, and maintain all forms generated by this chapter.

10 2. To provide, at the request of any person concerning the application of this chapter to an
11 actual situation or one seriously contemplated, written advisory opinions. The Commission
12 shall respond promptly to these requests, providing interpretations of this chapter based on the
13 facts provided or reasonably available to it. The Commission shall, to the extent practicable,
14 publish its advisory opinions with any information that would identify the subject of the
15 opinion deleted. The publication of advisory opinions shall include the publication of a
16 summary of the advisory opinion in the City Newsletter and the posting of the advisory opinion
17 on the City's website.

18 3. To investigate, hear, and decide any inquiry or complaint filed by any person regarding
19 an alleged or potential violation of this chapter. The Commission has the power of subpoena
20 to require the attendance of persons and the production of documents. If any person refuses to
21 comply with a subpoena of the Commission, the Commission may initiate a suit in equity in
22 the Circuit Court to enforce compliance with the subpoena.

23 4. To conduct a public information program regarding the purposes and application of this
24 chapter.

25 5. To recommend legislative changes and improvements to this chapter, including such
26 changes as are necessary to maintain compliance with the requirements of State Government
27 Article, Title 15, Subtitle 8, of the Annotated Code of Maryland.

28 6. To promulgate regulations to accompany this chapter.

29 7. To certify to the State Ethics Commission on or before October 1st of each year that the
30 City is in compliance with the requirements for elected local officials of State Government
31 Article, Title 15, Subtitle 8, of the Annotated Code of Maryland.

32 B. The members of the Commission are appointed to staggered **three two-year** terms and may
33 only be removed by the Council for cause. "Cause" includes neglect of duty, misconduct in office,
34 a disability rendering the member unable to discharge the powers and duties of the office or a
35 violation of this chapter. **Initially, three members are appointed to one year terms and two**
36 **members to two year terms. The terms begin on October 1st and end on September 30th.** Any
37 vacancy occurring on the Commission is filled for the unexpired term in the same manner as
38 provided for appointments to the Commission. Commission members shall not serve past the
39 expiration date of their term.

1 C. Consistent with the provisions of State and City laws and ordinances, the Commission shall
2 operate under Robert's Rules of Order or such rules as it may promulgate.

3 D. Its members shall take an oath of office.

4 E. The Commission may establish three-member review panels to investigate and adjudicate
5 inquiries and complaints or respond to requests for advisory opinions.

6 F. Each year the Commission shall elect one of its members as Chair and one of its members
7 as Vice Chair. The Chair shall preside over meetings, assign members to such review panels as
8 may be established and carry out other duties as may be established in the Commission's rules.
9 The Vice Chair shall act as Chair in the absence of the Chair.

10 G. Its members are authorized to administer oaths.

11 H. The City Manager shall make available to the Commission such staff assistance as may be
12 needed and shall provide appropriate space and security for Commission records.

13 I. Except as prohibited in Section 3.04.060(M), the City Attorney shall assist the Commission
14 in carrying out its responsibilities at the Commission's discretion. (Ord. 2012-36, 2012/Ord. 2003-

Article 14. Grievance Procedure

4.04.780 Rights of employees.

A. Any employee occupying a permanent position, who feels that he or she has received inequitable treatment through some personnel action, shall have the right to appeal, either personally or through a representative, for relief from the personnel action. Except as provided in subsections (B) and (C) of this section, no issue involving a change in the pay plan, a policy prerogative of the Council or any other issue which does not have a direct impact upon the day-to-day working conditions of the employee or relations with a supervisor shall be considered relevant. Consequently, these issues shall not be addressed through this grievance procedure.

B. An employee may appeal a decision involving:

1. The description of the employee's position;
2. The assignment of an employee to a specified position; and
3. The allocation of the employee's position to a specific class.

C. An employee has no right of appeal if the employee is not satisfied with the grade to which the Mayor and Council have assigned the employee's class. However, the employee does have the right to ask the Council to reconsider its decision. The employee should notify the City Manager that the employee is asking the Mayor and Council to reconsider, so that the personnel officer can make the recommendation required by Section 4.04.210(A).

D. An employee must file a grievance under subsection (A) or (B) of this section within 15 days after a decision has been made and the employee has been informed. After 15 days, the employee loses the right to appeal.

E. If an official fails to reach a decision on a grievance or appeal within the time provided, the employee may appeal as if the grievance or appeal had been denied. However, if the final authority fails to reach a decision within the time provided, it is not a denial. The employee must wait for a decision. (Prior code § 8B-179)

4.04.790 Procedure.

A. Except for grievances listed in Section 4.04.780(B) or (C) and grievances involving dismissal from employment, all grievances shall be handled in accordance with the grievance procedure in this subsection. The procedure to settle grievances shall be as follows:

1. Step 1. The employee shall first present his or her grievance to the department head who shall make every effort to dispose of the matter forthwith. If the issue cannot be resolved immediately, the employee shall return to work and await the department head's written decision. The department head shall render such decision within 7 days upon receipt of the grievance and make copies of the decision available to the personnel officer. Should the decision be unacceptable to the employee, the employee may proceed with the grievance procedure.

1 2. Step 2. Should the employee elect to exercise his or her right to proceed with the
2 grievance procedure, he or she shall petition the City Manager in writing requesting a review
3 of the case. Such request shall contain a list of the particular grievance(s). The City Manager
4 shall have 14 days to reach a decision concerning the grievance. The City Manager shall
5 consider all aspects surrounding the grievance, solicit informal testimony from the involved
6 parties and reduce to writing the outcome of the City Manager’s deliberations. Copies of the
7 City Manager’s decision shall be given to the department head and the employee. The
8 decision of the City Manager is final.

9 ~~3.— Step 3. Should the employee receive an unacceptable decision, he or she may petition~~
10 ~~the City Administrator in writing requesting assemblage of the Personnel Appeal Board. The~~

1 3.—If the City Administrator does not reverse the decision to dismiss, the employee may
2 make a written demand to convene the Personnel Appeal Board to hear the employee’s appeal

23 of the Board will endeavor to rotate panel membership from time to time among members of
24 the Board.

25 2.—In the event that any matter is heard by a Commission panel designated pursuant to this
26 subsection, all panel members so designated must be present to conduct the hearing and all
27 official action by the panel shall be taken by the vote of not fewer than 2 members of the panel.

30 A.—The Board shall be the final arbiter in all cases brought before it.

31 B.—The Board only has the authority to hear employee grievance appeals if this chapter

6 **B.—Maintenance.**

7 1.—Low level facade lighting is recommended to be operational to 11:00 pm.

8 2.—Continuous internal security/police surveillance night lighting is recommended for all
9 street level businesses. (Ord. 1999-43 § 2H, 1999)

10 **8.40.140—Rear and side yards.**

11 **A.—Design (Modifications/Replacement).**

12 1.—Paved rear yards may be used for parking or loading.

13 2.—Storage or trash containers shall be screened from public view.

14 3.—Parking areas shall be screened from adjoining residential property.

15 4.—Refuse and storage areas shall be screened from the view of adjacent properties and
16 public rights of way. Screening may consist of masonry walls or durable wooden fences not

32 Commission may refuse to approve drawings, plans, or specifications that are not suitable or

1 desirable for aesthetic or functional reasons; and shall have the right to take into
2 consideration issues such as, but not limited to, the suitability of the site plan, architectural
3 treatment, plans, elevations, materials and color, construction details, streets, sidewalks, and
4 the harmony of the plans with the surrounding area.

5 3.—All demolition applications are subject to review and approval by the Montgomery-
6 County Historic Preservation Commission as stipulated under Chapter 24-A of the
7 Montgomery County Code.

8 4.—To help facilitate approval, it is recommended that plans also be reviewed and
9 submitted to the County with an endorsement/comment report by the FAB.

10 B.—Enforcement.

11 1.—The City shall provide training to the staff of the Office of Code Enforcement, and
12 distribute informational materials to affected building and business owners.

13 2.—Not sooner than 8 months following the date of adoption of the City Standards by
14 Montgomery County Historic Preservation Commission, the Facade Advisory Board shall
15 notify the owners of properties determined not to be in compliance with the City Standards
16 set forth in Section 8.40.080. Notice shall be in writing and shall include a statement of the
17 suggested corrective action and a notice that the FAB is available to provide assistance by
18 appointment.

19 23.—Should the Office of Code Enforcement identify a property which is not in
20 compliance with the City Standards set forth in Section 8.40.080, Code Enforcement may
21 issue a written notice of violation to the property owner which shall:

22 a.—Include a legal description or the street address of the property;

23 b.—Include a detailed description of the violation;

24 e.—State a reasonable time for the property owner to abate the violation.

25 34.—Notices of violation shall be deemed to have been properly served by personal
26 delivery, or by first class mail to the property owner's last known address, or by any other
27 method authorized by the laws of the State of Maryland and the City.

28 45.—If a property owner does not abate the violation within the time allowed for
29 correction, the maintenance provisions of the City Standards set forth in Section 8.40.080,
30 then a citation for a Class C municipal infraction may be issued to the property owner or

19 **12.04.030 Tree Commission.**

20 **A. Establishment.**

21 A Tree Commission is established to preserve, protect and promote the urban forest of Takoma
22 Park. (Ord. 2004-3 (part), 2004)

23 **B. Composition.**

24 The Tree Commission is composed of up to **five seven** City residents appointed by the Council.
25 The terms begin on October 1st and end on September 30th. The members shall elect among
26 themselves a Chair. (Ord. 2004-3 (part), 2004)

27 **C. Function.**

28 The Tree Commission, with the assistance of the **Urban Forest Manager Arborist**, shall propose
29 rules, regulations, procedures and actions to be taken by the City to preserve and protect the urban

16 This chapter shall be known as the “Takoma Park Nuclear-Free Zone Act.”

17 (Prior code § 8A-1)

18 **14.04.020 Purpose.**

19 The purpose of this Act is to establish the City as a nuclear-free zone in that work on nuclear
20 weapons is prohibited and that harmful exposure to high-level nuclear waste is limited within the
21 City limits. Citizens and representatives are urged to redirect resources previously used for nuclear
22 weapons and nuclear power generation towards endeavors which promote and enhance life, such
23 as human services, including child care, housing, schools, health care, emergency services, public
24 transportation, energy conservation, public assistance and jobs. (Ord. 2005-29 (part), 2005: prior
25 code § 8A-2)

26 **14.04.030 Findings.**

27 It is the finding of the Mayor and Council of the City, that:

- 28 A. The nuclear arms race has been accelerating for more than 1/3 of a century, draining the
29 world’s resources and presenting humanity with the ever-mounting threat of nuclear holocaust.
- 30 B. There is no adequate method to protect Takoma Park residents in the event of nuclear war.
- 31 C. Nuclear war threatens to destroy most higher life forms on this planet.
- 32 D. The use of resources for nuclear weapons prevents these resources from being used for other
33 human needs, including jobs, housing, education, health care, public transportation and services
34 for youth, the elderly and the disabled.
- 35 E. The United States, as a leading producer of nuclear weapons, should take the lead in the
36 process of global rejection of the arms race and the elimination of the threat of impending
37 holocaust.

- 1 F. An emphatic expression of the feelings on the part of private citizens and local governments
2 can help initiate such steps by the United States and the other nuclear weapons powers.
- 3 G. Takoma Park is on record in support of a bilateral nuclear weapons freeze and has expressed
4 its opposition to civil-defense crisis relocation planning for nuclear war.
- 5 H. The failure of governments of nuclear nations adequately to reduce or eliminate the risk of
6 ultimately destructive nuclear attack requires that the people themselves, and their local
7 representatives, take action.
- 8 I. In view of the Nuremberg Principles, which hold individuals accountable for crimes against
9 humanity, and the illegality of nuclear weapons under international law, in adopting this chapter,
10 this community seeks to end its complicity with preparations for fighting a nuclear war.
- 11 J. The production of nuclear energy creates highly radioactive nuclear waste whose
12 transportation through the City creates substantial risk to the public safety and welfare of the City.
13 (Ord. 2005-29 (part), 2005/prior code § 8A-3)

14 **14.04.040 Nuclear facilities prohibited.**

- 15 A. The production of nuclear weapons shall not be allowed in the City. No facility, equipment,
16 components, supplies or substance used for the production of nuclear weapons shall be allowed in
17 the City.
- 18 B. No person, corporation, university, laboratory, institution or other entity in the City
19 knowingly and intentionally engaged in the production of nuclear weapons shall commence any
20 such work within the City after adoption of this chapter. (Prior code § 8A-4)

21 **14.04.050 Investment of City funds.**

22 The City Council shall consider a socially responsible investment policy, specifically addressing
23 any investments the City may have or may plan to have in industries and institutions which are
24 knowingly and intentionally engaged in the production of nuclear weapons.
25 ~~The City Manager in conjunction with the Nuclear-Free Takoma Park Committee shall propose,~~
26 ~~within 6 months of the Committee's creation, a socially responsible investment policy and~~
27 ~~implementation plan, specifically addressing any investments the City may have or may plan to~~
28 ~~have in industries and institutions which are knowingly and intentionally engaged in the production~~
29 ~~of nuclear weapons. The proposed policy and plan shall be presented to the Mayor and Council,~~
30 ~~who shall conduct a public hearing on the policy and plan before considering it for adoption. (Prior~~
31 ~~code § 8A-5)~~

32 **14.04.060 Eligibility for City contracts.**

- 33 A. The City and its officials, employees or agents shall not knowingly and intentionally grant
34 any award, contract or purchase order, directly or indirectly, to any nuclear weapons producer.
- 35 B. The City and its officials, employees or agents shall not knowingly and intentionally grant
36 any award, contract or purchase order, directly or indirectly, to purchase or lease products
37 produced by a nuclear weapons' producer.
- 38 C. The recipient of a City contract, award or purchase order shall certify to the City Clerk by a

1 notarized statement that it is not knowingly or intentionally a nuclear weapons' producer.

2 D. The City shall phase out the use of any products of a nuclear weapons' producer which it
3 owns or possesses. Insofar as non-nuclear alternatives are not available, for the purpose of
4 maintaining a product during its normal useful life and for the purpose of purchasing or leasing
5 replacement parts, supplies and services for such products. Subsections (A) and (B) of this section
6 shall not apply.

7 E. The City Council, ~~upon advice of the Nuclear Free Takoma Park Committee~~, shall ~~within 6~~
8 ~~months of its appointment and~~ identify a source annually ~~thereafter establish and publish that~~
9 maintains a list of nuclear weapons' producers to guide the City, its officials, employees and agents
10 in the implementation of subsections (A) through (C) of this section. The list shall not preclude
11 application or enforcement of these provisions to or against any other nuclear weapons' producer.

12 F. Waivers.

13 1. The provisions of subsections (A) and (B) of this section may be waived by resolution
14 passed by a majority vote of the Mayor and Council, provided that:

15 a. The Mayor and Council shall determine, after a diligent good-faith search, that a
16 necessary good or service cannot reasonably be obtained from any source other than a
17 nuclear weapons' producer;

18 b. The City Manager ~~or his or her designee~~ shall provide public notice ~~notify the~~

33 absence of such evidence shall diminish the necessity for waiver;

1 reasonably meeting the specification or requirements of the necessary good or service;

2 e. Quantifiable substantial additional costs that would result from the use of a good or
3 service of a non-nuclear-weapons' producer, provided that this factor shall not become the
4 sole consideration. (Prior code § 8A-6)

5 **14.04.070 Exclusions.**

6 A. Nothing in this chapter shall be construed to prohibit or regulate the research and application
7 of nuclear medicine or the use of fissionable materials for smoke detectors, light-emitting watches
8 and clocks and other applications where the purpose is unrelated to the production of nuclear
9 weapons. Nothing in this chapter shall be interpreted to infringe upon the rights guaranteed by the
10 first amendment to the United States Constitution nor upon the power of Congress to provide for
11 the common defense.

12 B. Nothing in this chapter shall be interpreted, construed or applied to prevent the Mayor and
13 Council or the City Manager or his or her designee of the City, from acting to remedy, ameliorate
14 or prevent an emergency situation presenting a clear and present danger to the public health, safety
15 and general welfare, as defined in Section 2-6.1 of this Code, provided that should any such
16 emergency situation require the purchase of products or services from or entry into a contract with
17 a nuclear weapons producer; then the City Manager ~~or his or her designee~~ shall notify the City
18 Council ~~the Chairperson or his or her designee of the Nuclear-Free Takoma Park Committee~~ within
19 3 working days of the City's actions.

20 C. Nothing in this chapter shall be interpreted, construed or applied to supersede or bypass any
21 procurement regulations, whether those regulations are legislative or administratively
22 promulgated; provided, however, that no procurement regulations pertaining to the granting of any
23 award, contract or purchase order shall alter or abrogate the intent or requirements of this chapter.

25 **14.04.080 Violations and penalties—Other remedies.**

26 A. Any violation of this chapter shall be a Class B offense.

27 B. Without limitation or election against any other available remedy, the City or any of its

36 "Nuclear weapon" is any device the sole purpose of which is the destruction of human life and

1 “Nuclear weapons producer” is any person, firm, corporation, institution, facility, parent or
2 subsidiary thereof or agency of the Federal government engaged in the production of nuclear
3 weapons or their components.

4 “Production of nuclear weapons” includes the knowing or intentional research, design,
5 development, testing, manufacture, evaluation, maintenance, storage, transportation or disposal of
6 nuclear weapons or their components.

7 A “product produced by a nuclear weapons producer” is any product which is made wholly or
8 primarily by a nuclear weapons’ producer, except that products which, prior to their intended
9 purchase by the City, have been previously owned and used by an entity other than the
10 manufacturer or distributor; such products shall not be considered produced by a nuclear weapons’
11 producer if, prior to their purchase by the City, more than 25% of the useful life of such product
12 has been used or consumed, or within one year after it has been put into service by the previous
13 nonmanufacturer owner. The “useful life of a product” shall be defined, where possible, by the
14 applicable rules, regulations or guidelines of the United States Internal Revenue Service. (Prior
15 code § 8A-9)

16 **~~14.04.100 Notification.~~**

17 A.—~~Upon adoption of this chapter and annually thereafter, the Mayor and Council shall present~~
18 ~~a true copy of this chapter to the President of the United States, to the Premier of the Union of~~
19 ~~Soviet Socialist Republics, to the ambassadors of all nations at that time possessing nuclear~~
20 ~~weapons, to the Secretary General of the United Nations and to the Director of the International~~

31 **~~14.04.110 Nuclear-Free Takoma Park Committee.~~**

32 A.—~~Within 60 days of the effective date of this chapter, the Mayor shall appoint, with the~~
33 ~~approval of the City Council, a nonpartisan Nuclear-Free Takoma Park Committee to oversee~~
34 ~~implementation of and adherence to this Act. The Committee shall consist of seven Takoma Park~~
35 ~~residents, with staffing to be provided by the City Administrator. Committee members shall have~~
36 ~~collective experience in the areas of science, research, finance, law, peace and ethics.~~

37 B.—~~Residents appointed to the Committee shall serve 2-year terms, except that 3 of the initial~~
38 ~~appointees as designated by the Mayor and Council shall serve one year terms. The terms shall~~
39 ~~begin on April 1st and end on March 31st. The Committee shall appoint its own chair and establish~~
40 ~~its own bylaws, both subject to approval by the Mayor and Council.~~

- 5 2.—The Committee shall review existing City contracts, awards, purchase orders and

- 15 4.—The Committee shall, through the collection of materials, newsletter articles, cable
- 16 television programming, public forums and other means, provide public education and

- 18 Committee shall cooperate with City staff, the Nuclear Freeze Task Force and other interested
- 19 community groups and individuals.
- 20 5.—The Committee shall maintain a collection of current materials concerning the

- 22 level nuclear waste resulting from the production of nuclear weapons and nuclear energy.
- 23 From this information and from consultations with individuals and organizations involved in

20 **14.12.140 Noise Control Board.**

21 A. Establishment and Membership.

22 1. A City Noise Control Board is established to assist and advise the City on noise control
23 issues, including administration and enforcement of this chapter, and to adjudicate noise
24 disturbance complaints.

25 2. The Board shall consist of **five up to seven** active members appointed by the Council.
26 ~~All members shall be residents of the City. Board members shall be appointed for a term of~~
27 ~~three years, except that three of the initial appointees shall serve two-year terms. Terms shall~~
28 ~~begin on April 1st and end on March 31st.~~

29 3. ~~The term of a Board member who is appointed to replace a member who cannot complete~~
30 ~~his or her term shall be for the remainder of the term of the Board member being replaced.~~

31 4. ~~A Board member who resigns, who is removed, whose term expires or who ceases to~~
32 ~~reside in the City is ineligible to continue to serve on the Board except that, at the discretion~~
33 ~~of the Chairperson, he or she may continue as an inactive member of the Board to complete~~
34 ~~work on cases in which he or she participated as an active member of the Board. This~~
35 ~~participation may include the approval and signing of Board decisions on noise disturbance~~
36 ~~complaints.~~

37 5. ~~The Council may, by resolution, remove a Board member before the Board member's~~
38 ~~term has expired if the Council determines that the Board member has become incapacitated~~
39 ~~or has failed to reasonably perform his or her duties as a Board member.~~

1 ~~6. The Board shall elect one member as Chairperson and another member as Vice~~
2 ~~Chairperson to serve at the pleasure of the Board. The Board shall meet at the call of the~~
3 ~~Chairperson as required to perform its duties, but not less often than semi-annually. A majority~~
4 ~~of the active members of the Board constitute a quorum for transacting business. The Board~~
5 ~~may act by a majority vote of those present.~~

6 ~~7. The Board may adopt rules of procedure which further regulate its operations and the~~
7 ~~conduct of hearings.~~

8 B. Hearings on Noise Disturbance Complaints.

9 1. When a noise disturbance complaint under Section 14.12.130(E) is received, the Board
10 shall schedule a hearing on the complaint and give reasonable advance notice of the date, time,
11 and place of the hearing before the Board to the persons who filed the noise disturbance
12 complaint (“the complainant”) and the alleged violator. The alleged violator also shall be
13 served with a copy of the noise disturbance complaint.

14 2. The hearing notice and noise disturbance complaint shall be deemed to be properly
15 served on the alleged violator if the notice and complaint is:

16 a. Delivered to the alleged violator personally;

17 b. Sent by certified mail and the return receipt is returned indicating that the certified
18 mail was received by the alleged violator;

19 c. Left at the alleged violator’s residence or place of business with a person of suitable
20 age and discretion; or

21 d. Mailed by first-class mail to the last-known address of the alleged violator or
22 emailed to the alleged violator and posted in a conspicuous location on the property where
23 the noise disturbance violation is alleged to have occurred.

24 C. Hearing Process.

25 1. The Chairperson of the Board is authorized to designate three active members of the
26 Board to sit as a panel to conduct a hearing on any noise disturbance complaint. The
27 Chairperson of the Board shall endeavor to rotate panel membership from time to time among
28 the active members of the Board. If the parties agree, a hearing may proceed before two
29 members of the Board.

30 2. The hearing shall be open to the public. At the hearing, the complainant and the alleged
31 violator may present testimony and evidence to substantiate any material point. All testimony
32 shall be given under oath or affirmation. Each party shall have the right to cross-examine
33 opposing witnesses, to submit rebuttal evidence, and to present summation and argument. The
34 Board panel also may ask questions of witnesses and enter its own evidence.

35 3. The Board panel may admit and consider evidence which would be commonly accepted
36 by reasonable and prudent people as having a causal relationship to the matter before the Board

1 panel. The Board panel may exclude from evidence irrelevant and repetitious testimony and
2 documents.

3 4. The burden of proof of establishing a violation of the noise control ordinance shall be
4 on the party who filed the noise disturbance complaint and shall be met by a preponderance of
5 the evidence.

6 5. An audio or video record of the hearing shall be made. The record of the case shall
7 consist of the recording and any written documentation accepted into the case file. The record
8 of the case shall be open to inspection by any person. Upon request, the Board shall furnish
9 copy of the record of the case to any person at the cost of supplying the same.

10 D. Decision of the Board on a Noise Disturbance Complaint.

11 1. After due consideration of the evidence and testimony presented at the hearing, the
12 Board shall issue its decision on the noise disturbance complaint and give notice of its decision
13 to all parties to the case. The Board's decision may be announced orally, following the hearing,
14 or the Board may take the case under advisement and issue a written decision on the noise
15 disturbance complaint within a reasonable time following the hearing.

16 2. In the event that the Board finds in favor of the complainant on the noise disturbance
17 complaint, the Board may order the violator to cease and desist from the conduct or activity
18 which created the noise disturbance and/or to take other corrective action in order to abate or
19 correct the violation of this chapter.

20 E. Appeals from a Board Decision on a Noise Disturbance Complaint. Within 30 days of the
21 issuance of a decision on a noise disturbance complaint, a person who was a party to the
22 proceedings before the Board and who is aggrieved by the decision may file a petition for judicial
23 review in accordance with Title 7, Chapter 200, Judicial Review of Administrative Agency
24 Decisions, of the Maryland Rules of Procedure, as amended.

25 F. Enforcement of Board Decision on a Noise Disturbance Complaint.

26 1. A violator who fails to comply with a Board decision on a noise disturbance complaint
27 may be issued a municipal infraction citation for a Class A offense.

28 2. In addition to any penalty provided herein, compliance with a Board decision may be
29 enforced by any appropriate action, at law or equity, in any court of competent jurisdiction.
