



## Takoma Park City Council Meeting – April 20, 2022 Agenda Item 2

### **Voting Session**

Resolution Endorsing Amended FY 2021, FY 2022 and FY 2023 Community Development Block Grant Projects

### **Recommended Council Action**

Vote on Resolution Endorsing Amended FY2021, FY2022 and FY23 Community Development Block Grant project

### **Context with Key Issues**

The Community Development Block Grant (CDBG) program provides flexible funding for a variety of activities that include neighborhood revitalization. Programming priorities, established by the Council with the adoption of Resolution No. 2016-16, limits the expenditure of CDBG funds to capital projects benefitting low- and moderate-income populations as defined by the U.S. Department of Housing and Urban Development (HUD). The Montgomery County Department of Housing and Community Affairs, which administers the CDBG program on behalf of HUD, allocated \$91,000 in CDBG funds to the City in FY21, FY22 and FY23.

Council passed Resolution 2019-49, endorsing the funds be set aside for various ADA streetscape improvements in the CDBG eligible areas. This project has not moved forward, as the bidding and contractual requirements that CDBG regulations mandate for construction projects result in higher project costs and add significant staff time due to enhanced federal regulation oversight needs. Past experience has found that the requirements render a project significantly more expensive to complete than the City would encounter utilizing our own bidding and contractual procedures.

Staff requests to repurpose the CDBG funds for Neighborhood Improvements in CDBG eligible areas and to allocate FY22 and FY23 CDBG funds for the same purpose. The City has identified various neighborhood improvements that could be undertaken in Ward 5, including improvements of Toatley-Fraser Park, last renovated in 2005. Specific project sites identified by Planning and Public Works staff will be approved by Montgomery County to ensure compliance with federal requirements. The project meets the federal low-and moderate-income beneficiary requirements as they are located within a CDBG eligible area. This proposed amended project will be combined with the previously endorsed CDBG project, approved by Council in Resolution 2018-51, for Neighborhood Improvements in this same area of the City.

The accompanying draft resolution endorses the proposed use of CDBG funds to provide for the advancement of this project.

### **Council Priority**

Livable Community for All

### **Environmental Impact of Action**

The Neighborhood Improvements project, with improvements at Toatley-Fraser Park and amenities such as benches, will not have an adverse environmental impact.

**Fiscal Impact of Action**

A total of \$273,000 is available for qualifying capital projects: \$91,000 in FY21 CDBG funds amended from ADA sidewalks to additional funds for Neighborhood Improvements in Ward 5; and the previously unspecified total of \$182,000 in FY22 and FY23 CDBG funds for Neighborhood Improvements in Ward 5.

**Racial Equity Impact of Action**

According to the American Community Survey, in Block Group 1, Census Tract 7017.02, 75.20 percent of the residents identify as people of color. By focusing the expenditure of CDBG funds specifically on this Census block group, the project will improve community amenities for this population.

**RESOLUTION 2022-**

**ENDORISING AMENDED FY2021, FY2022 and FY2023 COMMUNITY  
DEVELOPMENT BLOCK GRANT PROJECTS**

**WHEREAS**, the City of Takoma Park participates in the U. S. Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG) program; and

**WHEREAS**, the City has \$273,000 available from Montgomery County's annual CDBG entitlement funding; and

**WHEREAS**, Resolution 2016-16, adopted by the Council on June 15, 2016, limits the expenditure of CDBG allocations to capital projects benefitting the community's low and moderate income neighborhoods; and

**WHEREAS**, the Council approved Resolution 2019-49 to endorse the use of CDBG funds for streetscape and ADA improvements, however, the CDBG procurement policies make the funds difficult to use for this amount of funding; and

**WHEREAS**, the Council has endorsed the use of CDBG funds for a targeted neighborhood initiative in Ward 5 including but not limited to public improvements such as improvements to Toatley-Fraser Park and the installation of benches and other amenities in the neighborhood.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF TAKOMA PARK, MARYLAND** that the following amended capital project has been accepted for consideration for Community Development Block Grant (CDBG) funding:

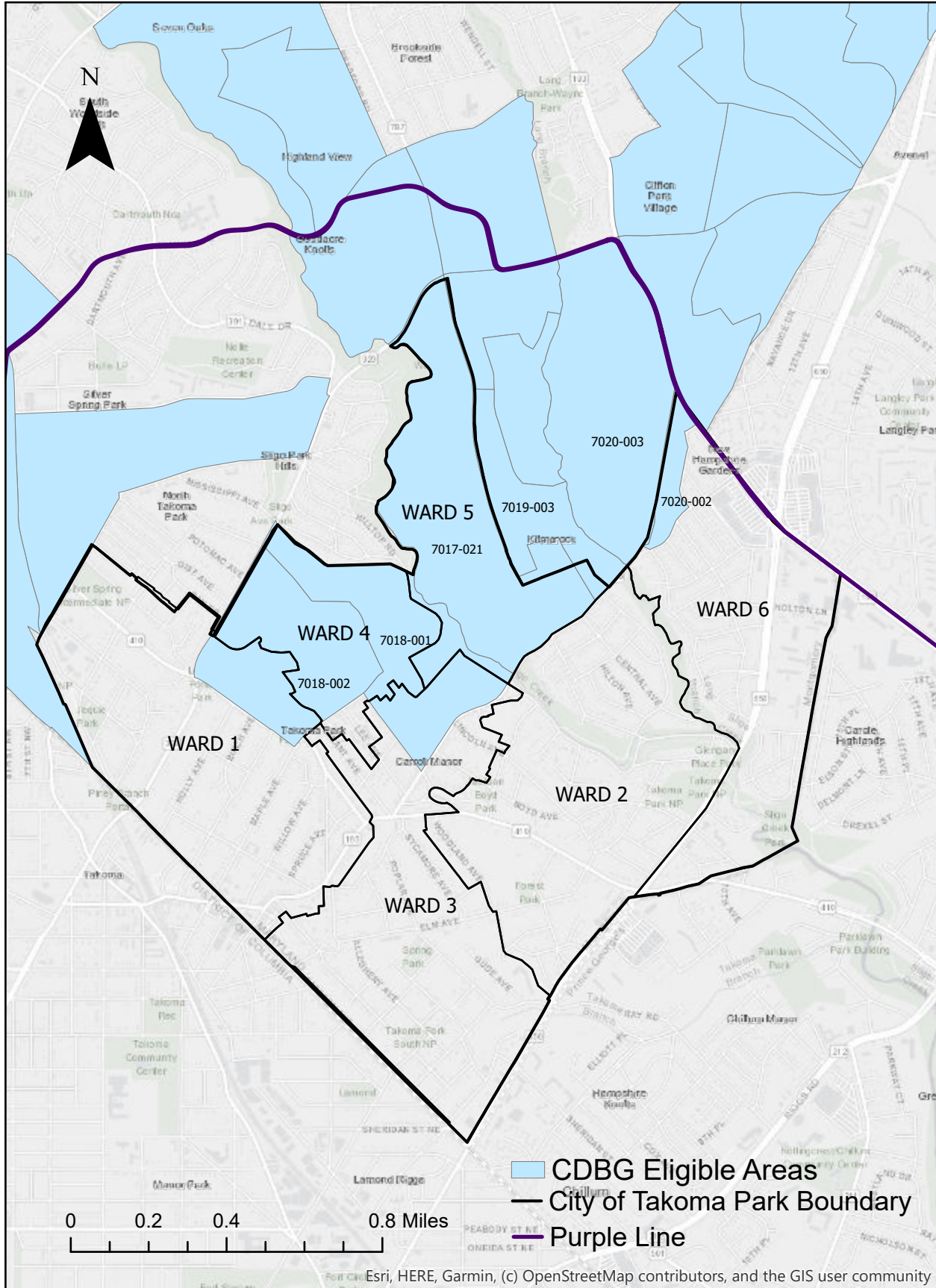
