Rescinding Ordinance which authorized execution of a contract with Paycom for implementation, support, and maintenance of a Human Resources Information System.

Recommended Council Action

Approve rescinding ordinance.

Context with Key Issues

On March 2, 2022 the City of Takoma Park issued a Request for Proposals (RFP) for contracting and implementation of a complete Human Resources Information System. The City received six responses and each firm was evaluated on the following criteria: experience and qualifications, responsiveness and understanding of the scope of services, prior experience working with local governments, and cost. Staff from various departments reviewed and evaluated each response and recommended Paycom as the qualified firm to implement and maintain a comprehensive Human Resources Information System. Due to failed contract negotiations, the City is unable to move forward with Paycom. Staff identified Paycor as the next qualified firm to implement a Human Resources Information System.

CITY OF TAKOMA PARK, MARYLAND ORDINANCE 2022-

RESCINDING ORDINANCE NO. 2022-37 (WHICH AUTHORIZED EXECUTION OF A CONTRACT WITH PAYCOM FOR IMPLEMENTATION, SUPPORT AND MAINTENANCE OF A HUMAN RESOURCES INFORMATION SYSTEM)

- **WHEREAS,** the City sought a qualified firm to implement and maintain a comprehensive Human Resources Information System; and
- **WHEREAS**, the City selected Paycom as the most qualified and experienced firm for contracting and implementation of a Human Resources Information System; and
- **WHEREAS**, the City Council adopted Ordinance No. 2022-37 authorizing the City Manager to enter into a contract for services with Paycom for the implementation, support, and maintenance of a Human Resources Information System for an amount not to exceed the total budgeted cost of \$177,000; and
- **WHEREAS,** the City and Paycom could not reach an agreement on contract terms for implementation and maintenance of a Human Resources Information System.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TAKOMA PARK, MARYLAND, THIS ___ DAY OF SEPTEMBER 2022, THAT:

- **Section 1.** Ordinance No. 2022-37 is rescinded, and the City Manager is no longer authorized to enter into a contract with Paycom for the implementation and maintenance of a Human Resources Information System.
- **Section 2**. This Ordinance shall become effective immediately.
