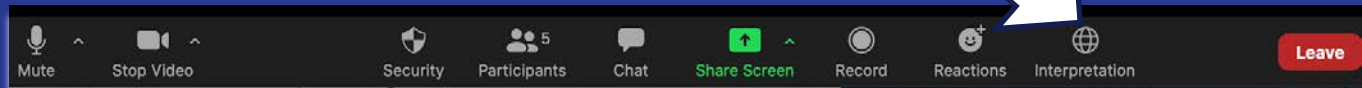

Staff-Recommended Five Year Spending Plan for American Rescue Plan Act (ARPA) Funds

What is the American Rescue Plan Act and how can the funds be used in Takoma Park?

What is the American Rescue Plan Act (ARPA)?

The **American Rescue Plan Act of 2021 (ARPA)** provides grant funds, **Coronavirus State and Local Fiscal Recovery Funds (SLFR Funds)** to States and other local jurisdictions to help Americans recover from the public health crisis and economic crisis caused by COVID-19.

ARPA Funds are intended to respond to acute pandemic response needs, fill revenue shortfalls among local governments, support populations hardest-hit by the COVID-19 pandemic, and lay the groundwork for an equitable economic recovery.

ARPA Funds must be used within a five-year period: 2021 – 2026.

The City of Takoma Park will receive \$17.4 million total in SLFR Funds. The first tranche, \$8.7 million, was received in July 2021. The second tranche will be paid in July 2022.

How can ARPA Funds be used by the City of Takoma Park?

FOUR CATEGORIES OF ELIGIBLE USES FOR ARPA

1. To respond to **the COVID-19 public health emergency or its negative economic impacts**.
2. To respond to workers performing essential work during the COVID-19 public health emergency by **providing premium pay to eligible workers**, or by providing grants to eligible employers that have eligible workers who performed essential work.
3. For the provision of **government services** that were curtailed during the COVID-19 public health emergency due to decreases in revenue and to avoid cuts.
4. To make necessary **investments in water, sewer, or broadband infrastructure**.

ARPA Category 1. Public Health/Negative Economic Impacts

- Programs and services that provide assistance to households, small businesses, and nonprofits and address disparities in public health exacerbated by the pandemic. For example:
 - ❖ Rent & Mortgage Payments
 - ❖ Affordable housing development
 - ❖ Utility Assistance
 - ❖ Capital Expenditures that support COVID-19 public health or economic recovery efforts
 - ❖ Support public health expenditures
 - ❖ Behavioral health services
 - ❖ Loans and grants to small businesses
 - ❖ Job training
 - ❖ Rehabilitation of commercial properties/façade improvements

ARPA Category 2. Premium Pay

- Funds may be used to provide premium pay to eligible workers performing essential work during the COVID-19 public health emergency
- Provide grants to employers with eligible workers performing essential work.

For example:

- ❖ Emergency Responders
- ❖ Medical Testing
- ❖ Public Health
- ❖ Staff at nursing homes, hospitals and home care settings
- ❖ Farm workers, grocery store workers
- ❖ Janitors and sanitation workers
- ❖ Truck drivers
- ❖ Childcare workers, educators, and other school staff



ARPA Category 3: Revenue Loss

- Funds can be used for the provision of government services to replace budget shortfalls that may have occurred during the pandemic.
- To avoid cuts to government services.
- To enable governments to continue to provide valuable services.

ARPA Category 4: Infrastructure

- Water and sewer (improve water quality, improve wastewater treatment, replace lead service lines, stormwater management, etc.)
- Green infrastructure projects that support stormwater system resiliency.
- Broadband Infrastructure: Projects designed to provide services meeting adequate speeds, increase affordability, and are provided to unserved and underserved households and businesses.

Development of the Staff- Recommended Spending Plan

Development of the Staff-Recommended Plan

- During the fall of 2021, Department Directors worked hard to design ARPA-eligible projects that addressed community needs. They generated a database of project proposals that reflected ideas suggested by Councilmembers, residents, non-profits, and other stakeholders.
- Staff evaluated and prioritized more than 40 projects using a priority-based budgeting (PPB) scoring process.
- 19 of the top-ranked projects were selected for the Staff-Recommended Spending Plan.
- Selected projects advance the Takoma Park City Council Strategic Priorities and focus on one-time investments.

Planning for a Recovered, Resilient Takoma Park

- Short-term: ARPA funds should be used for *economic recovery*, provide immediate aid for vulnerable residents and businesses and facilitate their recovery from the pandemic.
- Long-term: ARPA can be used for *community resiliency*– making systemic improvements for residents, businesses, and the City government that will have transformative, long-lasting impacts.
- ARPA funds are *one-time funds*, so should be targeted to one-time expenditures to protect the fiscal health of the City.
- ARPA funds should advance *City Council's Strategic Priorities* and *equity for all residents*.

ARPA (AMERICAN RESCUE PLAN ACT)

ARPA Funding Available to the City of Takoma Park

The **American Rescue Plan Act of 2021** (referred to herein as "ARPA") was signed into law on March 11, 2021, and appropriates \$1.9 trillion to States and other jurisdictions to help Americans recover from the public health crisis and economic crisis caused by COVID-19. As a part of ARPA, a total of \$350 billion will be delivered to states, local and Tribal governments through the **Coronavirus State and Local Fiscal Recovery Funds** (SLFRF) program. These funds are to be used over the next five years to support their response to, and recovery from, the COVID-19 public health emergency. SLFRF are intended to respond to acute pandemic response needs, fill revenue shortfalls among local governments, support populations hardest-hit by the COVID-19 pandemic, and lay the groundwork for an equitable economic recovery.

The City of Takoma Park has been allocated \$17.4 million in SLFRF which is distributed by the State of Maryland in accordance with guidance provided by the U.S. Department of the Treasury (grantor of ARPA/SLFRF). In 2021, \$3.9 million in ARPA funds were budgeted by the City Council for emergency rental assistance, food security, community engagement, administrative staffing, administrative oversight, and revenue loss reimbursement. Staff-Recommended ARPA Spending Plan

Based on a six-month needs assessment, project review and project prioritization process, staff have identified 20 projects that are being recommended to the City of Takoma Park City Council utilizing ARPA/SLFRF in the amount of \$13,495,100. The Staff-Recommended [ARPA Spending Plan \(Spending Plan\)](#) will be presented to City Council on January 12 during regular session. The Staff-Recommended Spending Plan is also available to the public for review and comment.

In developing the Staff-Recommended Spending Plan, staff took into consideration Council priorities, previous City planning documents, data on residents' needs, guidance from the U.S. Treasury Department (grantor), community feedback, and organizational needs. Staff recommendations include the following areas of investment:

- \$6.6 million to directly assist the City's most vulnerable residents and businesses
- \$4.8 million to renovate city facilities and improve public infrastructure as community anchors
- \$2 million to support city operations, workforce, and fiscal stability
