BACKGROUND

June 2019: the Complete and Safe Streets Committee (CSSC) was re-established.

 Purpose: "to advise the City Council on transportation-related issues including, but not limited to, pedestrian and bicycle facilities and safety, traffic issues, and transit services," and to encourage Takoma Park residents to use alternatives to driving, including walking, bicycling, and transit."

January 2021: the CSSC released a final set of recommendations before being formally disbanded.

STATE SAFETY EFFORTS

MD House Bill 562 (2021)

- Allows Montgomery County & its municipalities to lower the speed limit to as low as 15mph on certain roads.
- City staff are in conversation with Montgomery County Department of Transportation about best practices.



OPPORTUNITIES FOR COUNCIL

- Adopt criteria for new sidewalk and traffic calming requests, and any related ordinance or regulation changes.
- Consider additional staffing or funds to support consulting services to fully implement recommendations.
