Single Reading Ordinance Authorizing Renewal of In-Car (Fleet) Cameras for the Police Department

Recommended Council Action

Approve the ordinance.

Context with Key Issues

The use of In Car Camera (Fleet) systems provides an unbiased audio/video recording of events. These recordings can be useful for documenting of evidence, preparing offense reports, and future court testimony. In Car Camera systems can improve community relations and deter inappropriate conduct by both the members of the public and the police department. They can assist in the resolution of citizen complaints against police officers.

Our initial contract with Axon Enterprises for our Fleet system is up for renewal. The renewal will include the upgrading of the camera system in all fleet vehicles that are equipped with in car cameras (30 vehicles). The current cameras from Axon will be over 5 years old at the time the new cameras will be installed in the vehicles, and numerous upgrades have taken place in the intervening years. The updated cameras will provide High Definition video recording and the following upgrades from the current cameras/system:

- 24-hour video recall with remote access
- Daytime color video for interior camera
- Video overlay indicators for brakes, lights and sirens
- Respond for Devices add-on (vehicle location, alerts, livestreaming)
- Expandable up to five cameras

Our prior contract included the cost for purchase of the new cameras. The new contract also includes the cost of replacing the cameras at the end of the fifth year. The new proposed contract includes the installation of cameras with all new equipment and accessories, unlimited storage of recordings and a five-year extended warranty.

The total cost of the new contract is \$383,373.60, which will be paid in yearly installments. The following is the annual cost, with the first-year payment already included in the FY24 budget:

•	June 2025	\$73,612.41
•	June 2026	\$76,556.90
•	June 2027	\$79,619.18
•	June 2028	\$82,803.94

The previous, initial, five-year contract pricing was \$277,438.80. The last payment on that contract was made in December 2022.
