Context with Key Issues

Following the FY26 Budget Calendar work session last week, please find attached a revised version of the calendar. The revised version provides an extra few weeks for the newly elected Council to finalize its FY26 Budget Priorities Resolution with the voting session now occurring January 8 rather than December 11. This will push the council's receipt of the budget book and City Manager's first budget presentation back a week which also shifts subsequent meetings back a week as well. Timing flexibility was already built into the earlier draft so this shift will not present any new internal budget development challenges.

Context with Key Issues

Following FY24 budget development and adoption, the City Council passed Resolution 2023-15 establishing policy objectives for the FY25 budget. As part of the resolution, the Council formed a budget work group that evaluated "relevant budgetary practices of Maryland municipal structures for inclusion in the City budgetary preparations." Following several months of research and meetings with City staff, in September, 2023 the work group presented a draft proposed budget calendar for FY25. The work group later provided final findings and recommendations to the full council that included the recommendation that Council continue to include elements of the FY25 calendar in the future.

In Council packets for this agenda item is a draft FY26 Budget Calendar prepared by City Staff continuing many of the prior fiscal year's recommended elements as well as advancing a few of the recommendations for future fiscal years. These include:

- Council formally adopting the annual budget calendar
- A council candidate orientation that includes information on the City's annual budget process
- Formalized public engagement opportunities prior to budget development
- Newly sworn councilmember onboarding that includes additional information on the City's annual budget process
- A City Manager's financial forecast for the upcoming fiscal year
- Formally adopting Council budget priorities for the upcoming fiscal year
- Starting the budget calendar earlier to allow for a longer and more evenly paced budget development and adoption process
