MESSAGE FROM CHIEF DEVAUL

The purpose of this annual report is to provide information about your Police Department, about crime in the City of Takoma Park, the accomplishments of the Department, and to explain how every individual can partner with the police department to make our community safer.

In 2023, we continued to cultivate relationships with our stakeholders. We held several Ward-specific public safety meetings. We have also had several community meetings in specific neighborhoods throughout the city to address issues facing small geographic areas within the city. Transparency and communication are vital to relationship building.

The City of Takoma Park saw a 50% increase in Part 1 reported crime over the last year. This was mainly due to an increase in larceny shoplifting, assaults, theft from autos, robberies, and auto thefts. This trend is not unique to our agency. Many agencies locally and nationally have seen a significant increase in serious crime. We are doing everything we can to address the increase in crime in Takoma Park. We have increased high visibility patrols in our hot spot areas as well as undercover covert patrols.



Our officers are committed to being guardians of the community. Over 70% of our workforce has been hired in the last five years. Thirty-nine of our 43 sworn positions are filled. Our department is diverse, with the department staff being almost a direct reflection of the demographics of the City of Takoma Park. Our officers speak six different languages.

The Takoma Park Police Department is committed to taking a holistic review of the public safety model in Takoma Park. We are committed to promoting public safety while upholding the rights and dignity of all residents. This involves fostering a culture of transparency and accountability. Good, bad or indifferent, you will always get the full story from us. We use frequent and timely communications via social media and press releases to convey information to our residents. We also put out daily and weekly summaries on crimes occurring in Takoma Park.

We are committed to community policing, collaborative problem-solving with all community stakeholders, and continuing to build partnerships and trust with our constituents.

The City of Takoma Park appreciates the support of all members of the community. As your Chief, it is my responsibility to keep your trust in our staff by continuing to provide high-quality police services.

Total Part 1 Crimes Comparison 2022 and 2023 50% Increase

Uniform Crime Report (UCR) statistics for year-end 2023, as compared to year-end 2022, show a 50% increase in Part 1 Crime. This is mostly due to an increase in reported larceny shopliftings, robberies, assaults, thefts from autos, and auto thefts. Percent change values have been rounded to the nearest whole number.

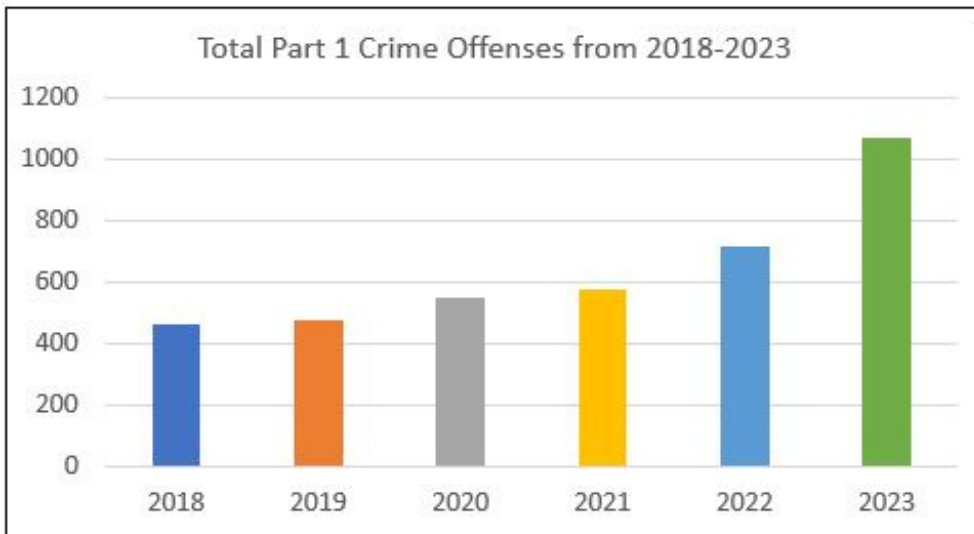

In the last six years, we have observed a 22% increase in UCR Part 1 Crime in Takoma Park over time since 2018.

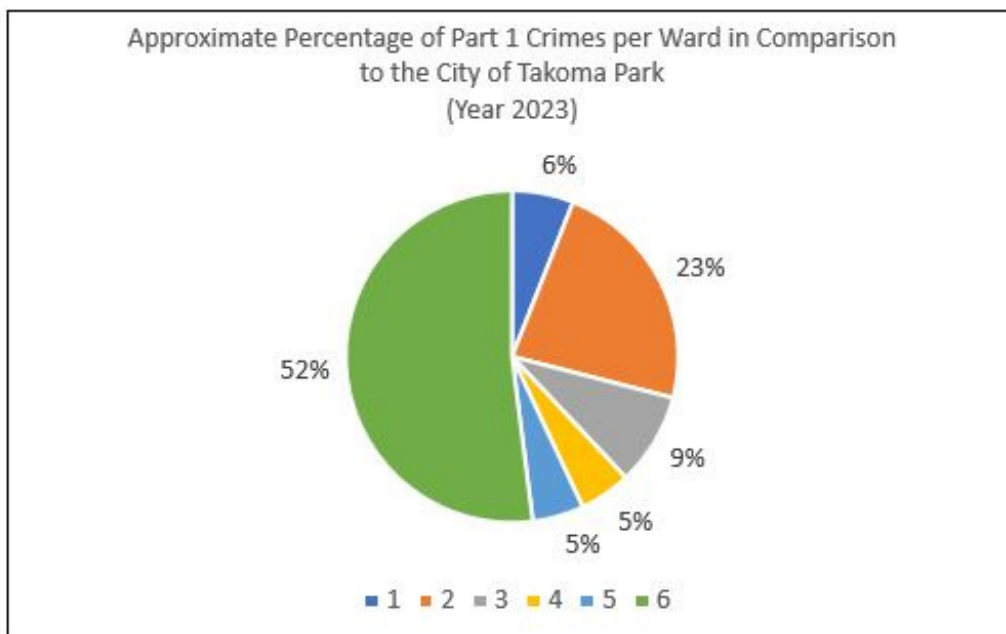

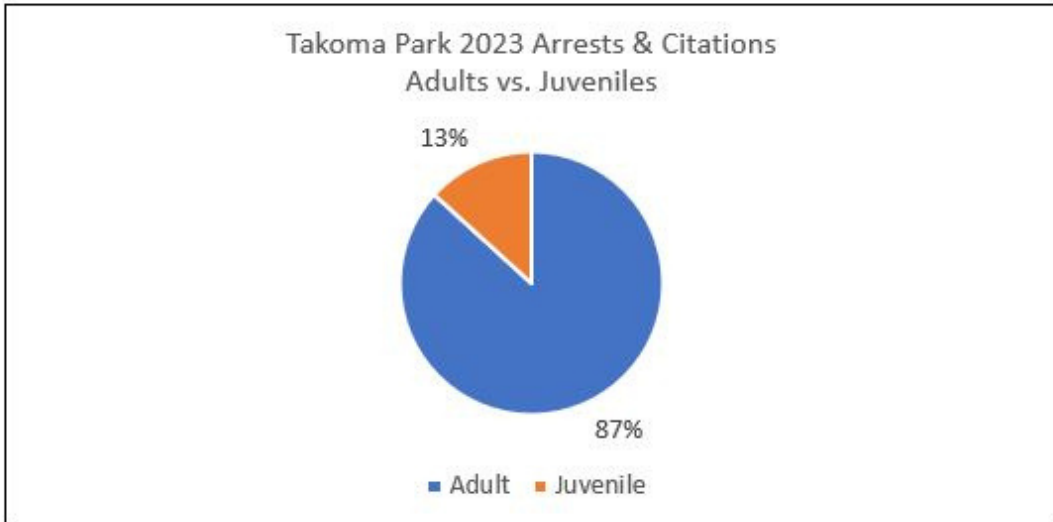

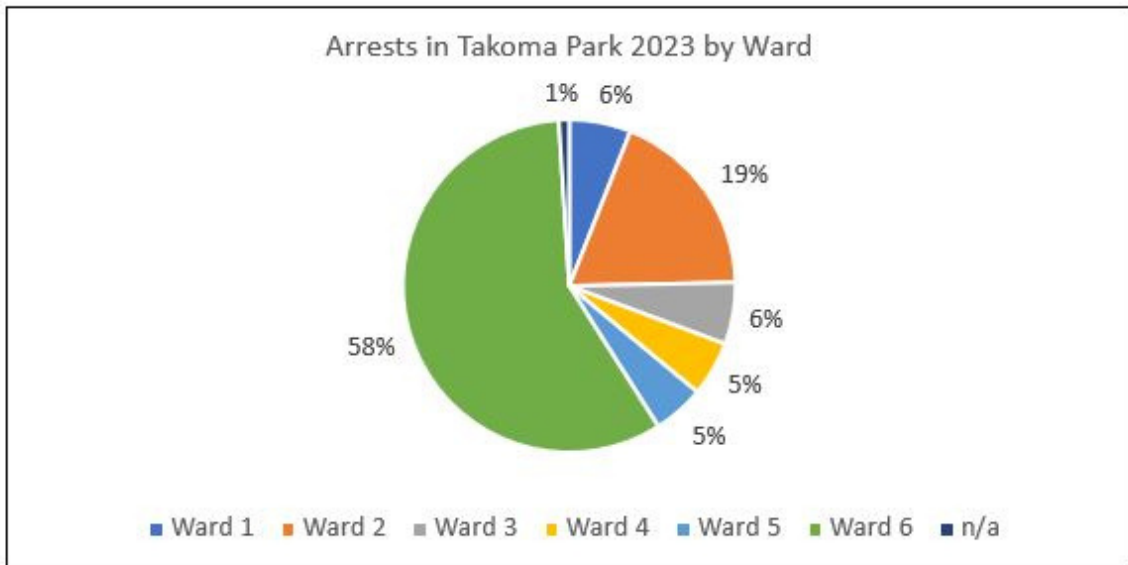

Dispatched Computer-Aided Dispatch Events

Dispatched Computer-Aided Dispatch (CAD) events refer to incidents or calls that have been processed and assigned by a computer-aided dispatch system to appropriate emergency response units, such as police, fire, or medical services. These events typically include information about the nature of the incident, location, time, and other relevant details necessary for responders to effectively address the situation. Dispatched CAD events play a crucial role in coordinating emergency response efforts and ensuring that resources are efficiently deployed to incidents as they arise.

Office of the Chief

The office of the Chief consists of the Chief of Police, the Deputy Chief of Police, the Executive Assistant to the Chief/Police Public Information Manager, and the Emergency Preparedness Manager. The Office of the Chief is responsible for the day to day management of the police department, policy and planning, media, and emergency preparedness. The Office of the Chief also oversees various departmental programs. The current Chief is Antonio DeVaul and Deputy Chief is Shibu Philipose.

Police Chief's Advisory Board

The Police Chief's Advisory Board was formed in October 2009. Members of the Board are briefed on all activities of the Police Department and bring issues and community concerns to the Chief's attention. Board members receive updated advisories and alerts on crimes and are invited to department events. Meetings are held at 7:00 p.m. on the third Monday of each month at the Takoma Park Community Center. Applicants are interviewed and selected by the Chief of Police and a member of the Board.

DUI Details

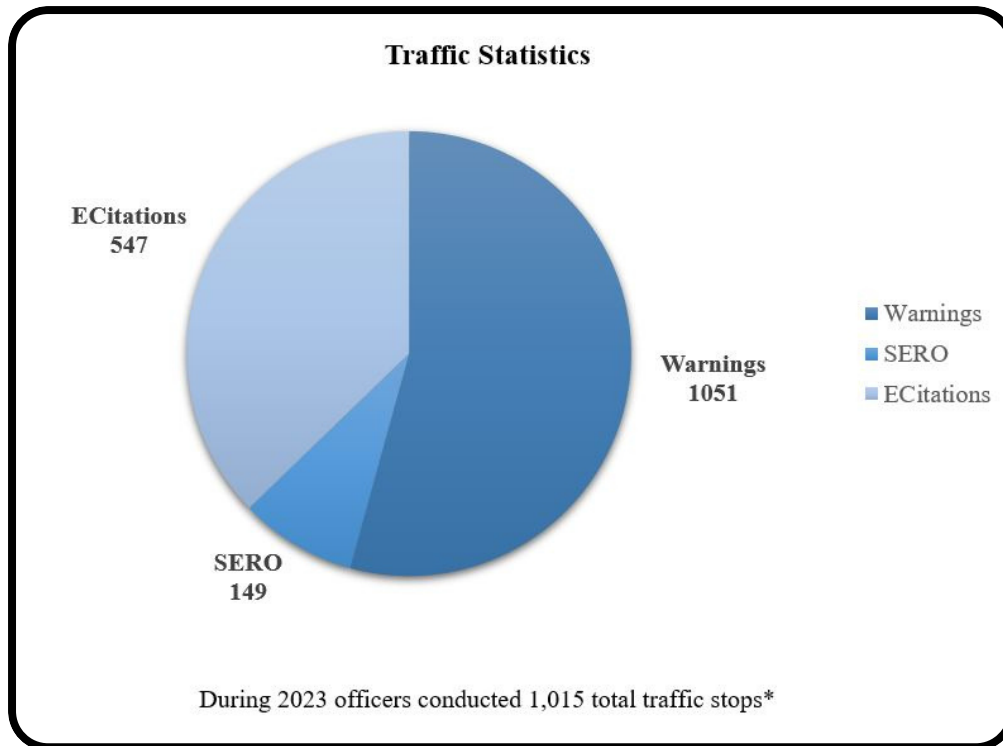

Traffic Statistics

Throughout 2023, the Takoma Park Police Department conducted several traffic related details, which concluded with officers issuing 547 E-Citations, 149 Safety Equipment Repair Orders, and 1,051 warnings.



*In 2023, 10 vouchers for the Lights On! Program were given out to residents. Lights On! Is a community-driven program that offers repair vouchers for participating law enforcement agencies and communities they serve. The program was founded in 2017. Officers can provide drivers with Lights On! vouchers redeemable for free repairs of broken lights at partnered auto shops. The vouchers reduce the financial burden that could lead to a potential downward spiral for community members in need as well as create a positive interaction between drivers and officers to build or re-build trust. For some families, a broken taillight or turn signal can sometimes mean choosing

between a minor auto repair or buying groceries. Having to fix these repairs for safety is important for the driver and other drivers on the road, but these offenses can lead to further financial strain. This is a well-intended effort to help community members. "We are committed to helping the residents of Takoma Park in as many ways as we can. This program is a great part of that commitment," said Takoma Park's Chief, Antonio DeVaul. He goes on to say, "We once again appreciate our ongoing partnership with RS Automotive in this endeavor to relieve even a small part of any financial burdens felt by our community."

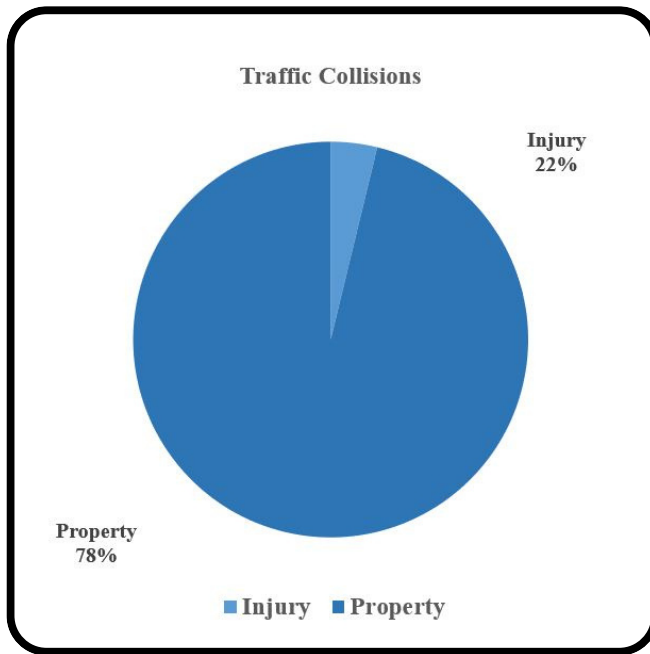

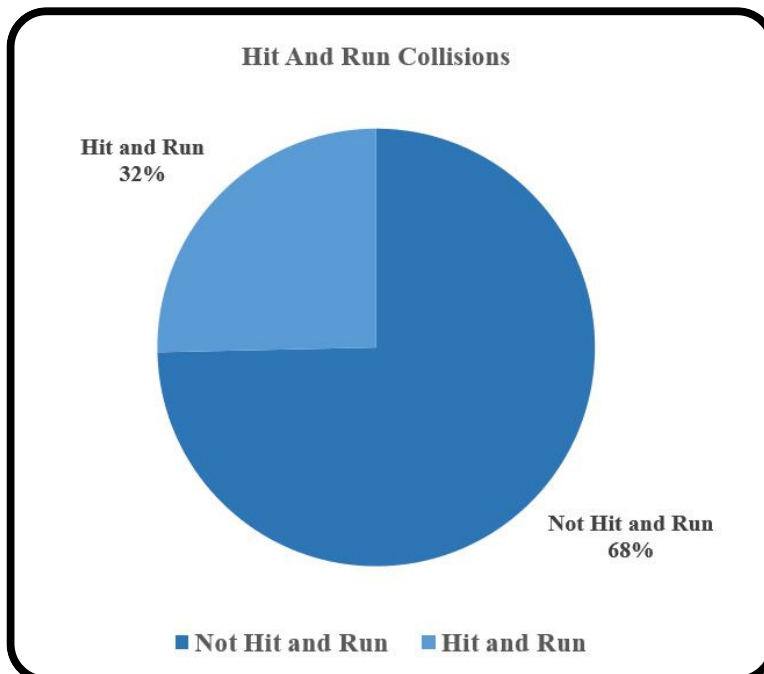

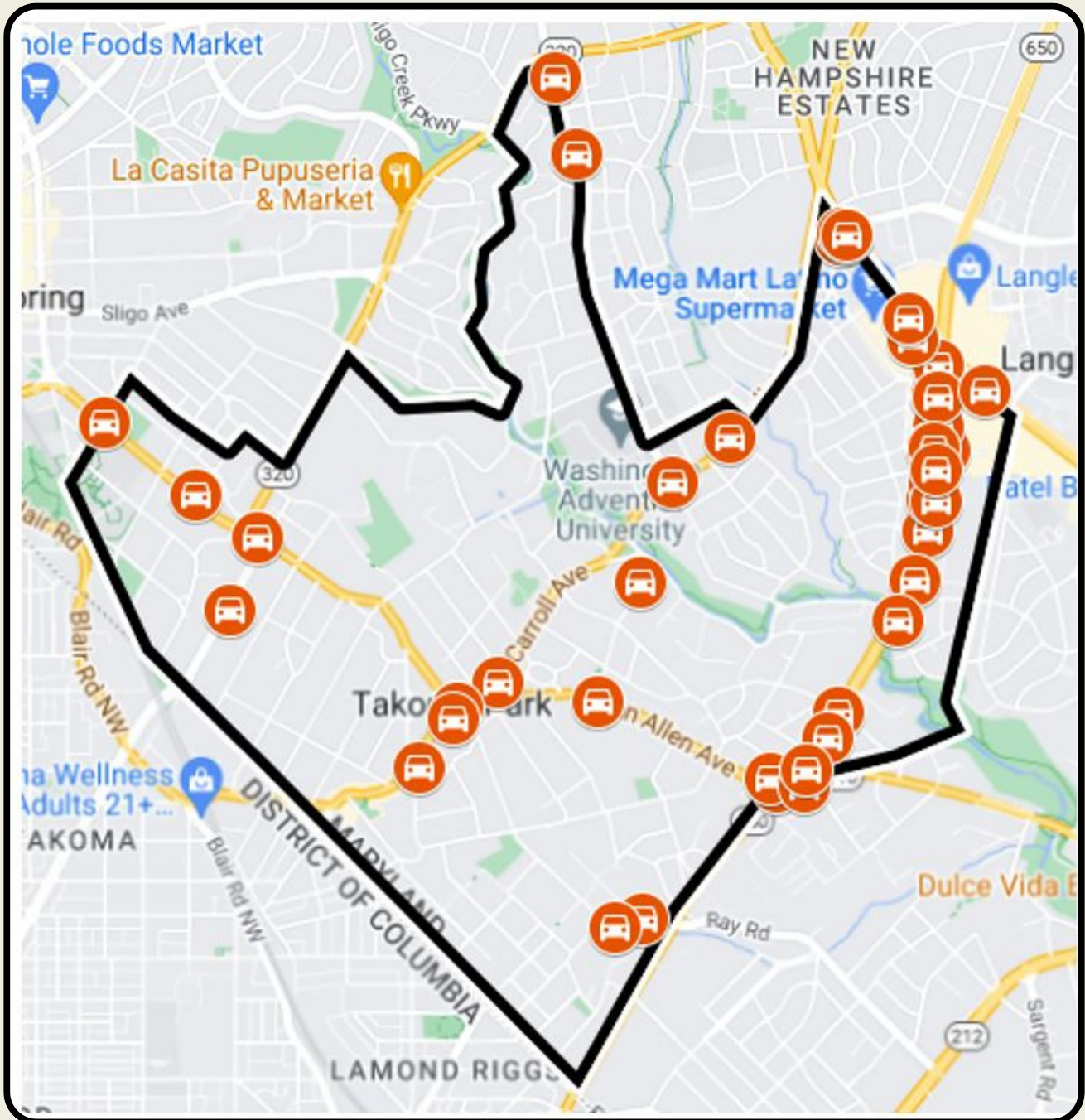
Hit and Run Collisions

Of the reportable collisions 66 were Hit-and-Run, 139 were not Hit-and-Runs.

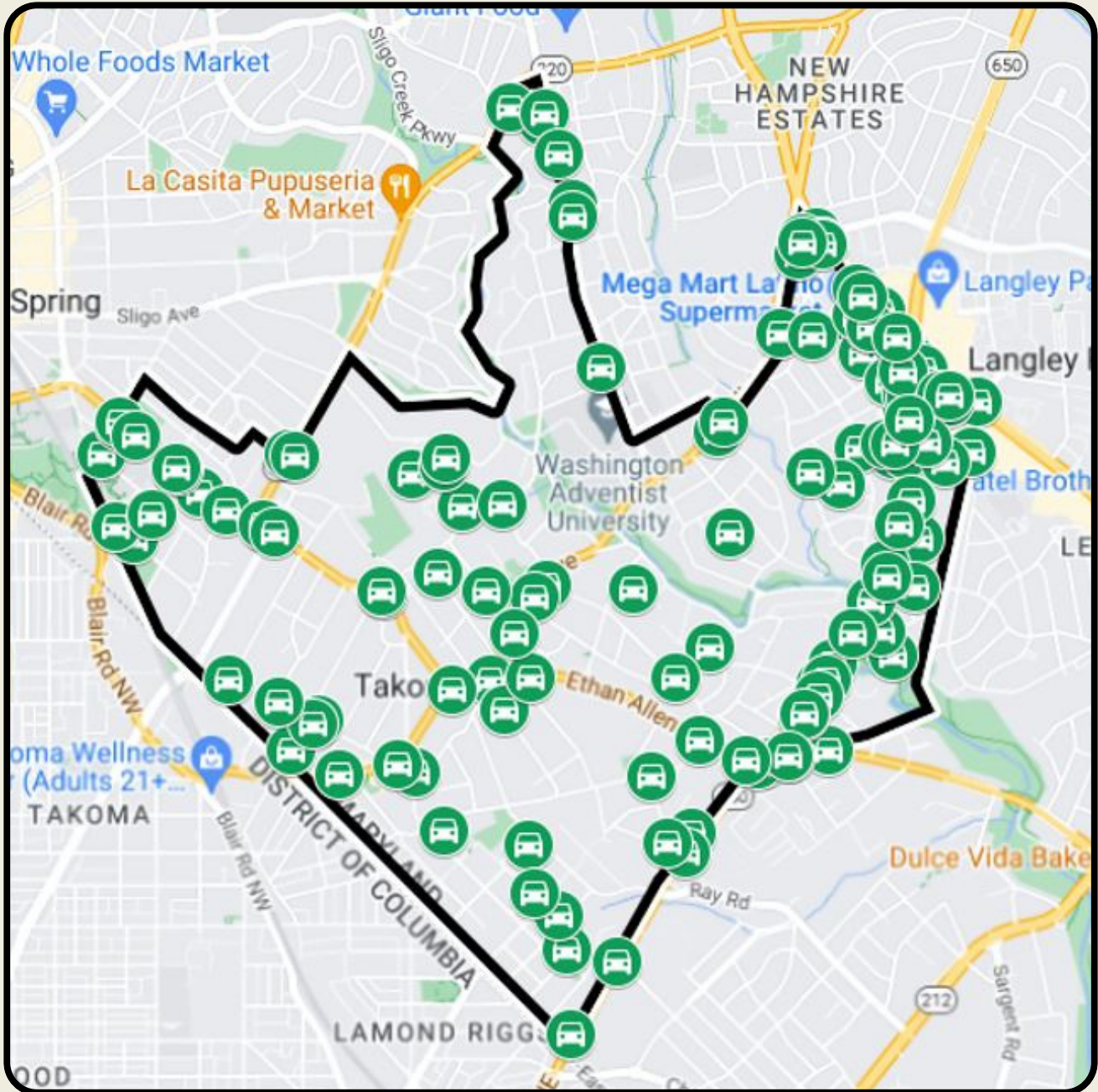

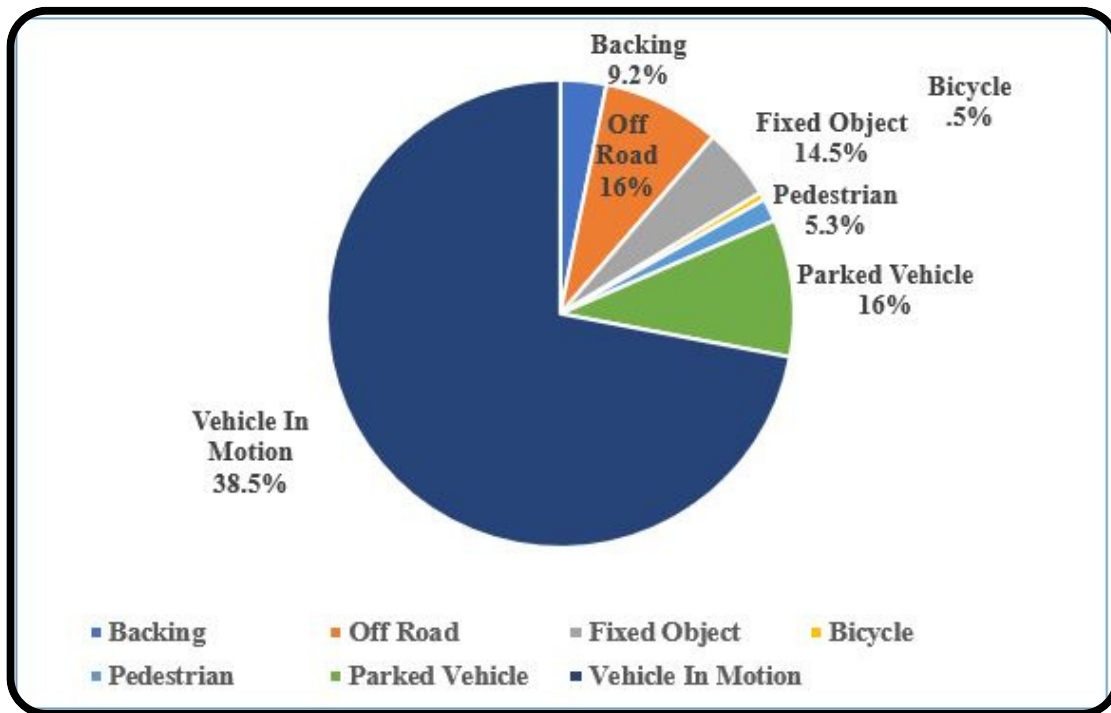
Personal Injury Collision Map

Automated enforcement is the use of technology to enforce traffic laws. To date, the most common form of automated enforcement implemented in the United States is red light cameras, which detect and photograph vehicles that commit red light violations. According to the Insurance Institute for Highway Safety (IIHS), approximately 300 communities in the United States use red light cameras.

Automated speed enforcement (speed cameras) is a less commonly used form of automated enforcement used to address vehicle speeds, automobile collisions and speed related injuries. Speed cameras detect the speed of motor vehicles and photograph vehicles exceeding a preset speed threshold. Jurisdictions use speed cameras to supplement traditional speed enforcement programs

Safe Speed Corridors

In February 2013, the City Council and State Highway Administration approved the implementation of Safe Speed Corridors. Safe Speed Corridors are stretches of roadway identified and approved for Speed Camera Enforcement. Portable cameras can be placed in locations that have met all requirements and authorized by the State Highway Administration. The goal of this approach is to encourage drivers to respect the speed limit along the entire stretch of a roadway, rather than at one fixed speed camera location.

Location of Cameras

Takoma Park's Safe Speed Program is currently utilizing four fixed pole cameras and five portable camera units. The fixed pole units operate 24 hours per day, seven days per week. The portable cameras operate 24 hours per day, seven days per week at the sites they are located. The sites are located as follows:

Fixed Poles

- ◆ 7200 block of New Hampshire Avenue/ southbound (fixed pole)
- ◆ 500 block of Ethan Allen Avenue/ westbound (fixed pole)
- ◆ 400 block of Ethan Allen Avenue/ eastbound (fixed pole)
- ◆ 950 block of East West Highway/ westbound (fixed pole)

Portable Units

- ◆ 900 block of University Boulevard/ eastbound (portable unit)
- ◆ 7400 block Carroll Avenue/ northbound (portable unit)
- ◆ 7100 block of New Hampshire Avenue/ northbound (portable unit)
- ◆ 7400 block of New Hampshire Avenue/ southbound (portable unit)
- ◆ 7300 block of New Hampshire Avenue/ northbound (portable unit)



The use of automated speed enforcement does not eliminate the need for personnel. In particular, automated speed enforcement technology requires the hiring of trained personnel to set up, maintain, and monitor equipment.

There are three forms of speed monitoring systems: fixed pole, mobile, and portable camera units (PCUs). Both mobile and fixed speed camera systems consist of a radar antenna and a camera system. A mobile system is mounted in a marked van, which can be moved around to different predetermined enforcement sites. Fixed pole cameras operate around the clock from a single location. Mobile camera systems require staffing by a trained operator, while fixed pole cameras require staff visits for the purpose of equipment monitoring and data downloads. PCUs can be moved around to different locations. The City of Takoma Park utilizes fixed pole and PCUs.

Program Description

State legislation authorizes the use of photo-radar/LIDAR speed monitoring on residential streets and school zones. Vehicle owners are subject to a \$40.00, non-moving violation citation if the vehicle speed exceeds the posted limit by 12 mph or more. The citation is a civil penalty and is treated as a non-moving violation. The civil penalty is not recorded on the owner's driving record by the State Motor Vehicle Administration, no "points" are assigned, and insurance providers are not notified. Citations that are issued by the City of Takoma Park are processed through a contract with Conduent, along with police approval through the Takoma Parks Traffic Division. Revenues from the citations are remitted back to the City of Takoma Park.

Corridor Locations

- ◆ 6900–7600 block of New Hampshire Avenue/ northbound
- ◆ 6900–7600 block of New Hampshire Avenue/ southbound
- ◆ 900–1300 block of University Boulevard/ eastbound

These automated enforcement locations were determined by traffic studies completed by Conduent at different locations throughout the City, as well as through accident data obtained from the Maryland State Highway Administration and the Takoma Park Police Department’s records section. Thirteen sites were chosen for traffic surveys which assessed traffic volume and violation activity at each location. Initially, citations were issued to drivers exceeding the posted speed limit by 11mph or more. On October 1, 2009, the Maryland State Legislature in Annapolis raised the violation limit from 11 miles per hour over the posted speed limit to 12 miles per hour over the posted speed limit.

Speed Camera Updates

The Safe Speed program has seen an increase in citations along New Hampshire Ave. and University Blvd. Some reasons for this can be attributed to increased traffic congestion due to continued construction of the Purple Line.

In the fall of 2019 a new contract with Conduent was approved which allows for a smaller fee for the cameras, as well as new cameras to replace the aging cameras which have been in use for an extended amount of time.



Automated Red-Light Enforcement Technology

Pedestrian and vehicle safety have always been a top priority. There has been an increase in personal injury collisions and personal property collisions, at various intersections within the city. Takoma Park is working with our current vendor (Conduent), which currently maintains and services our speed enforcement cameras, to install seven red light cameras at selected intersections in the City. The chart below shows the proposed locations. The community will be updated when the program goes live. There will be a 30 day grace period where only warnings will be issued at the start of the program.

March

Community Police Academy

Over 12 weeks, residents delved into the multifaceted world of the Takoma Park Police Department. From understanding the intricacies of criminal law and investigations to exploring the nuances of community policing, this program offered a comprehensive overview of various department functions. Whether it was learning about victim/witness rights, mastering traffic laws, or gaining insights into emergency preparedness, each session provided valuable knowledge essential for fostering a safer community. Other topics explored were use of force, media relations, and the speed camera program. This program rotates in several field trips each year, to include:

Wheel Lock Program

A viral TikTok challenge began causing individuals to steal Kia and Hyundai vehicles with a USB cable, which prompted the carmakers to release a free software update to stop the thefts. During the update process, they offered free wheel locks to owners of targeted vehicles through various programs. Takoma Park Police partnered with Kia Motors for their Wheel Lock Program to provide anti-theft steering wheel locks to our Takoma Park residents to help prevent vehicle thefts. The Takoma Park Police Department distributed all of the free steering wheel locks that were provided to them.



April

Distracted Driving Awareness

April is designated “National Distracted Driver Awareness” Month and Takoma Park Police officers participate and focus their efforts on distracted driving using traffic enforcement initiatives as well as educating drivers on the dangers of distracted driving. Distracted driving is any activity that could divert a person’s attention away from the primary task of driving; this includes using a hand-held cell phone and texting. The ultimate goal is to save lives by convincing motorists to obey the law. Takoma Park Police continue their efforts beyond the campaign month to focus on drivers who are distracted using hand-held cell phones, or engaging in other distracting activities while driving.

National Prescription Drug Take Back Day

In April and October of each year, the Takoma Park Police Department participates in the Drug Enforcement Administration (DEA) Nationwide Prescription Drug Take-Back Day. This campaign allows the public to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs. Although our agency participates in this nationwide event, residents looking to dispose of excess and expired prescription and over-the-counter medications can visit our safe and secure permanent drop-off location at our police department. The collection site is open 24 hours a day, seven days a week. Drugs can be dropped off with no questions asked. The Takoma Park Police Department collects and stores the items and then safely disposes of them through accepted practices as approved by the DEA.

In April 2023, Takoma Park Police collected 123 lbs. of unused & expired medications. Overall, 342.6 lbs. were collected between November 1, 2022 – April 22, 2023, including medications dropped in the permanent drop box in the police lobby.

Click it or Ticket Campaign

The Takoma Park Police Department participates in the statewide Chief's Challenge, which emphasizes safety restraint enforcement. Officers focus on enforcement of the state's seat belt laws as part of the nationwide "Click It or Ticket" campaign. Officers stand at various places throughout the City during the campaign to issue tickets to any person not wearing a seatbelt or who does not have their child properly restrained. They also educate the public on seatbelt usage and safety. According to the National Highway Traffic Safety Administration (NHTSA), "Click it or Ticket" is one of the most successful seat belt enforcement campaigns ever, helping to increase the national seatbelt usage rate.

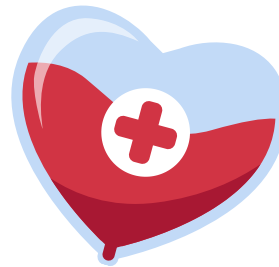

Blood Drive

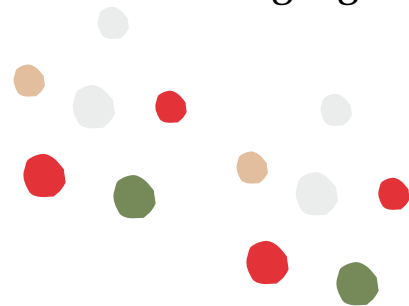

Etch & Catch Anti-Theft Catalytic Converter Program

We began our partnership with RS Automotive in 2021 in an effort to deter would-be thieves and to track stolen catalytic converters by engraving identifying marks on the catalytic converters and spraying them with high-heat neon spray. Stickers were also given out to show that the vehicle's catalytic converter had been marked by the Takoma Park Police Department. Our goal was to deter potential thieves looking to steal catalytic converters. In the event your catalytic converter were to be stolen and recovered, law enforcement would be able to trace the converter based on the markings. There were 16 thefts of catalytic converters in 2020, 17 in 2021, 15 in 2022 and four in 2023.

Shoe Drive

Statutory Mandates

A plethora of new laws or changes to existing laws were enacted and/or became effective in 2023, many of which impacted the policies and procedures of the police department.



HB0004/SB0129 Criminal Law - Sexual Crimes - Repeal of Spousal Defense

This bill repeals an exemption from prosecution for specified sexual crimes if, at the time of the alleged rape or sexual offense, the person was the victim's legal spouse.

The bill took effect October 1, 2023

HB0164/SB0057 Sexual Offenses – Crime of Violence and Lifetime Supervision

This bill (1) expands the definition of a “crime of violence” under §14-101 of the Criminal Law Article to include sexual abuse of a minor meeting specified criteria and (2) expands the list of offenses that subject an offender to lifetime sexual offender supervision to include sexual abuse of a minor meeting specified criteria and all circumstances of second-degree sexual offense and an attempt to commit a second-degree sexual offense (as that crime existed before October 1, 2017) when committed by an adult. The bill applies prospectively to a conviction on or after the bill’s October 1, 2023 effective date.

The bill took effect October 1, 2023

HB0174/SB0391 Criminal Procedure – Victims of Sexually Assaultive Behavior

This bill requires an Assistant State’s Attorney to meet with a victim of “sexually assaultive behavior” at the request of the victim after a decision by the Office of the State’s Attorney not to file a charging document against an alleged suspect or to dismiss charges against an alleged suspect.

The bill took effect October 1, 2023



HB0232/SB0653 Child in Need of Assistance – Neglect – Cannabis Use

This bill alters the definition of “neglect” in statutory provisions that govern child in need of assistance (CINA) proceedings. The bill specifies that neglect does not include the use of cannabis by any parent or individual who has permanent or temporary care or custody or responsibility for supervision of the child unless, as a result of the use of cannabis (1) the child’s health or welfare is harmed or placed at substantial risk of harm or (2) the child has suffered mental injury or been placed at substantial risk of mental injury.

The bill took effect July 1, 2023

HB0411/SB0487 Criminal Procedure – Violation of Pretrial or Post-trial Condition by Incarcerated Person – Victim Contact

This bill amends § 5-213.1 of the Criminal Procedure Article to explicitly prohibit a person, including an incarcerated person, from violating a pretrial or posttrial condition that prohibits the person from contacting, harassing, or abusing an alleged victim or going in or near an alleged victim’s residence or place of employment if the person is charged with committing specified offenses.

The bill took effect October 1, 2023

HB0745/SB0340 Criminal Law – False Statements – Emergency or Commission of Crime

Prohibiting a person from making or causing to be made a false statement, report, or complaint to a governmental emergency report recipient with reckless disregard of causing bodily harm to an individual as a direct result of a response to the statement, report, or complaint; and providing that a person who violates the Act, in addition to any penalties imposed, is civilly liable to an individual harmed by the violation.

The bill took effect October 1, 2023

HB1071 Criminal Law and Procedure – Cannabis – Fines for Smoking in Public, Stops, and Searches

This bill prohibits a law enforcement officer from (1) initiating a stop or a search of a person, motor vehicle, or vessel based solely on specified types of cannabis-related evidence and (2) conducting a search of specified areas of a motor vehicle or vessel during an investigation of a person solely for driving a motor vehicle or vessel while impaired by or under the influence of cannabis. The bill specifies that the Exclusionary Rule and its exceptions, as judicially determined, applies to the bill. In addition, the penalty for smoking cannabis in a public place is reduced for a first offense, to a maximum fine of \$50 (rather than \$250 under current law) and for a second or subsequent offense, to a maximum fine of \$150 (rather than \$500 under current law). The bill's provisions related to smoking cannabis in a public place take effect July 1, 2023, contingent upon Section 4 of Chapter 26 of 2022 taking effect. (Section 4 of Chapter 26 is set to take effect July 1, 2023.)

The bill took effect July 1, 2023

HB0824 Public Safety – Regulated Firearms – Possession and Permits to Carry, Wear, and Transport a Handgun

This bill (1) increases the maximum incarceration penalty for violations of the prohibition against wearing, carrying, or transporting a handgun, as specified; (2) modifies and expands an existing prohibition relating to the possession of a regulated firearm; and (3) modifies and expands the training requirements and procedures relating to the issuance and renewal of a handgun permit; it also increases the maximum handgun permit fees. In addition, the bill (1) requires the MDSP, in consultation with the Attorney General and Maryland Dept of Health, to develop, publish, update, and distribute a handgun permit training curriculum to all State-certified firearms instructors; (2)

requires MDSP to transmit a summary of new and amended laws relating to firearms to each e-mail address on file with the Department that is associated with (1) the purchaser or transferee of a regulated firearm or (2) a person who has registered a regulated firearm with the department; and (3) establishes reporting requirements. Specified provisions apply to handgun permits issued or renewed after October 1, 2023.

The bill took effect October 1, 2023

SB0001 Criminal Law – Wearing, Carrying, or Transporting Firearms – Restrictions (Gun Safety Act of 2023)

This bill (1) prohibits, with specified exceptions, a person from wearing, carrying, or transporting a firearm in specified areas; (2) prohibits, with specified exceptions, a person from wearing, carrying, or transporting a firearm onto specified real property under certain circumstances; and (3) establishes penalties for violations.

The bill took effect October 1, 2023

SB0858 Firearm Safety–Storage Requirements and Youth Suicide Prevention (Jaelynn's Law)

This bill modifies and expands (1) an existing prohibition relating to a child’s access to firearms and (2) an existing prohibition relating to possession of a regulated firearm. In addition, the bill requires the Deputy Secretary for Public Health Services to develop a youth suicide prevention and firearm safe storage guide by January 1, 2024. The Maryland Department of Health (MDH) must post the guide on its website and make an electronic version of the guide available to families, health and social services providers, and other interested entities, as specified.

This bill took effect October 1, 2023

HB0215/SB0450 Real Property – Limitations on Summoning Law Enforcement or Emergency Services – Prohibition

This bill prohibits a landlord from including provisions in a lease or form of lease that (1) limit the ability of a tenant to summon the assistance of law enforcement or emergency services or penalize a tenant solely for doing so or (2) penalize a tenant for the actions of another individual solely because the individual summoned the assistance of law enforcement or emergency services.

The bill took effect October 1, 2023

HB0636 Public Information Act – Inspection of E-Mail Addresses and Telephone Numbers

This bill alters the definition of “personal information” under the Maryland Public Information Act (PIA) to include an individual’s email address. The bill makes other changes under PIA that establishes when a custodian is prohibited from allowing, or authorized to allow, the inspection of records related to email addresses and telephone numbers, as specified.

The bill took effect October 1, 2023

HB0002 Income Tax – Subtraction Modification – Union Dues

This bill authorizes a subtraction modification against Maryland income tax for the amount of union dues paid by an individual during the taxable year that were allowed as a deduction under the Internal Revenue Code (IRC) prior to January 1, 2018, as specified.

The bill took effect July 1, 2023, and applies to tax year 2023 and beyond.

HB0508/SB0435 Property Tax Credit – Disabled Law Enforcement Officers and Rescue Workers – Definition and Eligibility

This bill requires a local government to determine the definition of a disabled law enforcement officer or rescue worker for purposes of receiving a local property tax credit. In addition, the bill expands eligibility for the property tax credit to include a disabled law enforcement officer or rescue worker or surviving spouse or cohabitant who was domiciled in the State any time within five years before the disabled law enforcement officer or rescue worker becoming disabled or dying.

The bill took effect June 1, 2023, and applies to taxable years beginning after June 30, 2023.

HB0984 Public Employee Relations Act

This bill substantially restructures the State's rules, procedures, processes, rights, and prohibitions regarding collective bargaining by public employees. More specifically, the bill (1) consolidates different collective bargaining laws that apply for different employees into one set of rules and procedures for public employees; (2) repeals the State Labor Relations Board (SLRB), the State Higher Education Labor Relations Board (SHELRB), and the Public School Labor Relations Board (PSLRB), and instead establishes the Public Employee Relations Board (PERB) to oversee collective bargaining for all public employees; and (3) makes several significant and/or substantial changes to the existing collective bargaining processes and requirements. Provisions of the bill deemed invalid are severable.

The bill took effect July 1, 2023

HB0123 Vehicle Laws – HOV Lanes – Plug-In Electric Drive Vehicles

Authorizing certain plug-in electric drive vehicles for which a permit has been issued by the Motor Vehicle Administration to use high occupancy vehicle (HOV) lanes regardless of the number of passengers in the vehicles; MVA, SHA and MDSP may consult to design the permit; authorizing the Administration to charge a fee, not to exceed \$20, for issuing the permit; and requiring, on or before January 1 each year, a report to be submitted to the Governor and the General Assembly on the effect of the use of the plug-in electric drive vehicle permits on the operation of HOV lanes.

The bill took effect April 24, 2023 and sunsets September 30, 2025

HB0391 Vehicle Laws – Parking Enforcement – Citations

This bill requires a parking citation issued by a political subdivision, State agency, or third-party contractor to include a box that the person issued the citation may check to indicate that the registration plates cited were not issued for the vehicle described in the citation. If a person returns a citation with the box checked, a political subdivision, State agency, or third-party contractor authorized to conduct parking enforcement on behalf of a political subdivision or State agency must verify through the Motor Vehicle Administration (MVA) whether the person should be held liable for the violation and may contact the person as part of the verification process.

The bill took effect October 1, 2023



HB0483/SB0074 Grossly Negligent or Drunk or Drugged Operation of Vehicle or Vessel – Prior Convictions

This bill establishes that a conviction for specified drunk and drugged driving offenses constitutes a prior conviction for purposes of determining subsequent offender penalties for a person unlawfully operating or attempting to operate a vessel while under the influence of alcohol, impaired by alcohol and/or drugs, or impaired by a controlled dangerous substance (CDS). Vice versa, a conviction for unlawfully operating or attempting to operate a vessel while under the influence of alcohol, impaired by alcohol and/or drugs, or impaired by a CDS constitutes a prior conviction for purposes of determining increased subsequent offender penalties for specified drunk and drugged driving offenses. The bill also establishes that a person convicted of specified drunk and drugged driving offenses is subject to increased subsequent offender penalties if the person has previously been convicted of manslaughter by vehicle or vessel (gross negligence).

The bill took effect October 1, 2023

Expungement of Records: Waiting Periods

SB0037 Criminal Procedure – Expungement of Records (REDEEM Act of 2023)

This bill shortens some of the waiting periods for filing a petition to expunge records related to a conviction eligible for expungement under § 10–110 of the Criminal Procedure Article. Some of charges that are now applicable for expungement are Disorderly intoxication; Operating and/or owning a business without the proper licenses and in bad faith; Assault; Making, issuing, and presenting a counterfeit prescription order (this does not include the use or possession of cannabis); Arson; Burglary in the fourth degree; Property damage for less than \$1,000; Any first-time violation of a misdemeanor charge;

Prostitution; and General theft. This is contingent upon the offender not having an outstanding balance with the court.

This bill took effect October 1, 2023

This medal is awarded to an officer whose work and actions have contributed significantly to the Department's visions and goals through extraordinary effort in the accomplishment of extremely difficult police work requiring skill and intelligence, or demonstration of outstanding performance by showing initiative, perseverance, and dedication to duty in highly creditable police work.

Criminal Investigations Section (CIS)

The Criminal Investigations Section (CIS) consists of one Bureau Commander, one Division Commander, one Criminal Investigations Division (CID) Supervisor, two CID Investigators, a Victim/Witness Coordinator, Property/Evidence Clerk, Crime Analyst and the Special Assignment Team (SAT) consisting of one supervisor and two officers.

CID Statistics

There were 193 new cases assigned during 2023. Out of the 193 cases assigned to CID for investigation, 60 were closed, 20 were exceptionally cleared, 113 were suspended and 31 arrests were made. It should be noted that an exceptionally cleared case counts as a closure due to a suspect being identified, the suspect most likely committed the crime, but there is not a sufficient amount of evidence to charge the suspect. The unit as a whole had a 41.45 percent closure rate.

Notable Arrests

During 2023, there were several notable arrests/case closures; some highlighted below.

Shed Burglaries: Detectives investigated a rash of shed burglaries that began in November of 2022, and continued into January of 2023. Investigators were able to identify a suspect from an arrest that occurred in December of 2022, and were able to exceptionally clear three shed burglaries that occurred in January of 2023.

Food Truck Robberies: During January 2023, four food truck robberies occurred within Takoma Park, including in the Silver Spring District. Takoma Park Investigators were able identify a juvenile suspect and charged him for four robberies. It should be noted that the fourth robbery was never reported, but investigators were able to identify

the victim. Takoma Park detectives provided Montgomery County Police investigators with the name of the juvenile who was charged in connection to our food truck robberies. With that information, Montgomery County Police were able to charge the same juvenile for the robberies that occurred in their jurisdiction.

Strong Arm Carjacking: In February of 2023, a Strong-Arm Carjacking occurred in the 6900 block of Westmoreland Avenue. Four to five males approached the victim and forced him out of his driver's seat. Two of the male suspects entered the victim's vehicle and fled the area. A lookout for the suspects and the victim's vehicle was broadcasted to surrounding jurisdictions.

On February 10, 2023, Fairfax County Police Department contacted Takoma Park Police investigators and advised that they had recovered the victim's vehicle parked at a Dick's Sporting Goods store. It was determined that four suspects had stolen several things from inside Dick's Sporting Goods and returned to the victim's vehicle. Fairfax County Police arrested the four suspects. Detectives from Takoma Park Police Department responded and took custody of the victim's vehicle and interviewed the suspects. One of the juvenile suspect's confessed to carjacking the victim's vehicle and was charged accordingly.

Armed Robbery: On February 18, 2023, officers responded to the 7400 block of New Hampshire Avenue for the report of an Armed Robbery. Preliminary investigation revealed that the victim was in a room with an unknown male acquaintance. The unknown male acquaintance temporarily left the room and returned a short time later with two other unknown males. One of the males displayed a handgun and stole property from the victim.

The incident was assigned to a Takoma Park Police Detective for investigation. Through investigative means, the detective was able to identify all three suspects, who were arrested and charged with Armed Robbery and other related crimes.

Strong Arm Carjacking: On March 4, 2023, officers responded to the 7100 block of Maple Avenue, for the report of a Strong Arm Carjacking. The suspect entered the victim's vehicle on the passenger side, displayed a handgun and pointed it at the victim's head and demanded the keys to the vehicle. The victim complied and was told by the suspect to get out of the vehicle. The suspect fled from the scene in the victim's vehicle. On March 4, 2024, Takoma Park Special Assignment Team (SAT) located the victim's vehicle in DC, unoccupied.

The vehicle was processed by Takoma Park Police investigators for DNA. Investigators obtained a DNA hit identifying the suspect. Through investigative means, investigators discovered that the suspect was suspected to be involved in 30+ additional felonies. This incident will be charged by federal investigators; therefore, this case was closed by exceptional means.

Stabbing/Rape: On March 15, 2023, officers responded to the 7700 block of Maple Avenue, for the report of a rape and stabbing. Preliminary investigation revealed that the victim had recently met the suspect on a dating app. The suspect met with the victim and raped her and cut her with a knife. Through investigative means, investigators were able to locate the suspect and confirmed his identity. Investigator's interviewed the suspect who confessed and was charged with First Degree Rape, First Degree Assault, and other related charges.

Child Neglect: On April 12, 2023, officers responded to the 1100 block of Linden Avenue for the report of a juvenile who had fallen out of the window. The victim did not sustain any serious injuries. Investigators investigated the incident, and worked closely with Montgomery County Child Protective Services. Through investigation, it was determined that there was a history of neglect of the parents' three children. As a result of the investigation, the parent was arrested and charge with Child Neglect.

Strong Arm Carjacking: On May 1, 2023, officers responded to the 7900 block of Lockney Avenue for the report of a Carjacking that just occurred. The victim had given a ride to a female acquaintance and an unknown male subject in the 7900 block of Lockney Avenue. At that location, the victim went into his trunk to retrieve something. The female acquaintance and unknown male began beating the victim. The suspects took the victim's car keys and fled the scene. Investigators were able to locate the female acquaintance and were able to identify the unknown male suspect. Investigators charged both suspects with Carjacking, Assault, and other related charges.

Sex Assault of a Minor: On May 2, 2023, officers responded to the 8100 block of Hammond Avenue for the report of a sex assault that had occurred earlier. Investigators took over the investigation and determined that a 13-year-old victim gave and received oral sex from a 50-year-old male. Through investigative means, the adult was identified and arrested in Ohio.

Church Burglaries: During the Month of July, the same church was burglarized on three separate occasions. Through investigative means, investigators were able to identify a suspect. Investigators were able to charge the suspect with two out of the three burglaries. The third burglary was exceptionally cleared due to not being able to develop enough evidence for that burglary to charge the suspect.

Burglary: On August 27, 2023, officers responded to the 1300 block of Holton Lane for the report of a burglary. The victim left her storage unit unsecured and went down to her vehicle to put something in it. When the victim returned, she discovered that an unknown person had stolen property from her storage unit. The victim's property was located in the hallway of the establishment, where there are no surveillance cameras. Investigators researched the surveillance camera where the victim's property was taken and observed two suspects exiting the area where the victim had her property. The suspects were seen carrying the property away. Investigators obtained a still photo of the suspect, who was immediately recognized by the investigator. Investigators charged the one suspect with Second Degree Burglary and other related charges.

Commercial Burglary: During September of 2023, police responded to the 7400 block of New Hampshire Avenue; a location that had been broken into twice by the same suspect. Through investigative means, investigators were able to identify the suspect. The suspect was charged with two counts of Second Degree Burglary and other related charges.

Residential Burglaries: During the month of November 2023, there was a spike in residential burglaries that impacted New Hampshire Avenue, Belford Drive, Auburn Avenue, Heather Avenue, and Ethan Allen Avenue. On November 24, 2023, officers responded to the 200 block of Spring Avenue for a burglary in progress. The residence was under renovation, but the victim/owner received notification on his cell phone that someone was in his house. The victim reported that there was a female and male subject inside the residence and that no one should be there.

Through investigative means, investigators were able to identify the male suspect. Investigators obtained an arrest warrant for the male suspect charging him with burglary and other related charges. It should be noted that since the arrest of the male suspect, there had not been any other residential burglaries in the area. Investigators were able to Exceptionally Clear the following burglaries.

Commercial Burglaries: During the month of December 2023, investigators investigated two commercial burglaries committed by the same suspect that occurred in the 7500 block of New Hampshire Avenue. Through investigative means, investigators were able to identify the suspect. Investigators obtained an arrested warrant for the suspect, who was later located and arrested.



Special Assignment Team (SAT)

The Special Assignment Team (SAT) is an investigatory unit which is comprised of two Corporals and one Sergeant. SAT Investigators operate in a plainclothes capacity and are tasked with fugitive apprehensions/extraditions, case enhancement for active investigations, complaints originating from residents impacting quality of life issues, such as narcotic violations, weapons offenses, property crimes, and prostitution.

SAT investigators are also responsible for assisting regional law enforcement allies with felony investigations which cross jurisdictional boundaries, self-initiated investigations stemming from pro-active street level enforcement, and assisting all facets of the police department and criminal investigations division.

In 2023, SAT made approximately 26 arrests and assisted CID and patrol with several other arrests. SAT conducted numerous police interactions, apprehensions and investigations including such criminal activities as homicide, distribution of illegal narcotics, firearm related offenses, larceny, burglary and assault. Additionally, SAT conducted hundreds of hours of surveillance for armed robberies, burglaries, auto theft, and theft from auto, among other serious crimes.

Notable Cases

Armed Robbery Warrant: During the first week of March 2023, Takoma Park Police investigators obtained an arrest warrant charging a defendant with the armed robbery of the El Solecito Food Truck located at 1017 University Boulevard Takoma Park, Montgomery County, Maryland on February 12, 2023. The defendant was also charged by Montgomery County Police investigators with the armed

robbery of the Elvira's Kitchen Food Truck located at 14011 Georgia Avenue Silver Spring, Montgomery County, Maryland on January 23, 2023. On March 6, 2023, Investigators from Takoma Park and Montgomery County Police contacted the Takoma Park Police Special Assignment Team (SAT), and requested their assistance in locating and arresting the defendant.

Within hours of this request, SAT investigators were able to locate the defendant and place him under arrest without incident. The defendant was transported to the Montgomery County Detention Center for processing, service of the arrest warrants and presentation to the District Court Commissioner. On March 7, 2023, the defendant had his initial court appearance with the District Court Commissioner and a determination was made the defendant would be "held without bond" on the arrest warrants.

Auto Theft and Violation of Parole Warrant: On May 5, 2023, SAT observed an actively wanted suspect in the 6300 block of New Hampshire Avenue. The suspect was observed traveling to and from the 6300 to 6800 blocks of New Hampshire Avenue. The suspect was subsequently stopped at Prince Georges Avenue at Belford Place. Warrants were confirmed and the suspect was transported the Montgomery County Central Processing Unit.

Stolen Vehicle Recovery and Warrant Arrest: SAT located a light blue 1999, 2-door Ford Explorer bearing a Maryland registration in the parking lot of 7411 New Hampshire Avenue. The vehicle was occupied by one person. The registration plate to the vehicle checked by the Communications Department came back listed as stolen from Washington D.C., which had been reported on June 4, 2023. SAT, along with the assistance of patrol officers, were able to get the suspect in possession of the vehicle into custody. The suspect was transported to CPU where he was charged with auto theft and other related charges.

First Degree Assault Warrant: SAT assisted CID with locating and apprehending a suspect in connection to a First Degree Assault and firearm related offense. SAT conducted surveillance and apprehended the suspect without incident.

Stolen Vehicle: SAT conducted a detail in the vicinity of 4th Avenue and Eastern Avenue for recent calls for shots being fired in the area. SAT officers observed two suspicious suspects on Eastern Avenue. SAT investigators conducted stationary and mobile surveillance on the suspects. The suspects were operating an electric Razor scooter.

SAT officers continued surveilling the two suspects as they went back across Eastern Avenue. SAT observed a green Honda CRV that appeared to be connected to the two suspicious suspects. SAT continued surveillance and determined that the Honda was a stolen vehicle. SAT officers requested assistance from patrol officers. As patrol officers moved in to assist with making the apprehension, all three suspects ran and a foot pursuit ensued. One of the suspects was apprehended on Eastern Avenue. A perimeter was immediately established and K9 was requested from Montgomery County Police.

The K9 was able to locate one of the suspects on Westmoreland Avenue in a front stairwell. A second suspect was located hiding in the back yard of a residence off of Eastern Avenue. The third suspect was identified, but not charged.

Attempted Stolen Auto: Around April 25, 2023, officers responded to Hickory and Elm Avenue for an attempted stolen auto in progress. Preliminary investigation revealed that four suspects got out of a blue Hyundai Elantra, carrying tools, and were attempting to steal a red Hyundai Elantra. As police arrived, the four suspects attempted to flee from the scene.

Two of the suspects entered the blue Hyundai and the other two suspects fled on foot. As the two suspects in the Blue Hyundai attempted to flee, they backed into the victim's red Hyundai causing minor damage and then fled the scene.

SAT was able to locate two suspects matching the suspects that fled on foot from the scene. The two suspects were detained. A show-up was conducted, and they were positively identified as two of the suspects attempting to steal the victim's vehicle. The two suspects were juveniles. The two juveniles were charged and released to their parents.

Controlled Dangerous Substance Arrest – Possession with the Intent to Distribute: Around October 7, 2023, members of the SAT team were in the area of New Hampshire Avenue when they observed two suspicious suspects. SAT continued surveillance on the two suspects, which ultimately led to the two suspects being stopped. One of the suspects attempted to flee from SAT investigators unsuccessfully and was detained.

SAT investigators recovered a clear baggy containing a white powdery substance from one of the suspects, which was later determined to be cocaine. SAT investigators located another clear baggy containing a white powdery substance, also later determined to be cocaine. SAT investigators requested a K9 to conduct a scan of the vehicle. Montgomery County Police K9 responded to the scene and conducted a scan of the vehicle. The K9 alerted on the front passenger side of the vehicle. SAT investigators located a large clear bag containing 17 small baggies of suspected cocaine. Both suspects were arrested and charged.

Attempted Carjacking: On May 11, 2023, SAT detectives located juveniles along the Eastern Avenue and New Hampshire Avenue corridor regarding an attempted carjacking that occurred along the border in the District of Columbia. A lookout was broadcasted and SAT located the involved juveniles. Surveillance was conducted and information was relayed to the Metropolitan Police Department's (MPD) Auto Theft Unit. Multiple juveniles were apprehended by MPD. Through investigatory means, it was revealed that the juveniles had numerous firearms. Takoma Park Police SAT detectives also located a stolen vehicle along the Takoma Park/DC border that was linked to the juveniles.

Multi-Jurisdictional Investigation/Search Warrant: SAT detectives worked with the FBI and the Montgomery County Drug Interdiction Team for several weeks regarding a suspect who lives in the 6400 block of Fourth Avenue, Takoma Park, Maryland. The FBI requested assistance from the Takoma Park Police SAT unit to gather intelligence, as well as target sheets involving the suspect and his associates. The FBI received intel regarding associates of the suspect sending blue M30 pills, which can be either counterfeit Oxycodone or Fentanyl, through the mail. These pills had been shipped from Los Angeles, California to Takoma Park, Maryland. The FBI intercepted two separate parcels containing large amounts of these pills at a location in Greenbelt, Maryland.

SAT conducted pre-raid surveillance at the residence on Fourth Avenue before the warrant was served. Montgomery County SWAT executed a Knock and Announce search warrant. The FBI and members of the Montgomery County Police Drug Interdiction Team were present during the search warrant. During the search warrant, multiple items were seized, which included three Glock gun cases, a bottle of Codeine Promethazine, a drum magazine for a rifle, and miscellaneous rounds of ammunition and magazines.

Prior to the execution of the search warrant, over twenty thousand Fentanyl pills (over two kilos) were recovered from a package going to the suspect's residence located on Fourth Avenue. The approximate street value for the pills were estimated to between \$200k-\$400k USD. The suspect was arrested and had possible additional charges pending.

During 2023, SAT detectives worked numerous details. Some of these details consisted of the following:

- Storage Unit Burglary Detail, 1352 Holton Lane
- Carjacking Detail, 6300 – 6900 block of New Hampshire Avenue, Old Town, side streets along Eastern Avenue
- Theft from Vehicle Operations (on and off for the year)
- Shoplifting Detail, Walgreen's

Internal Affairs Investigations Report

The Takoma Park Police Department's policy directives require investigations of all complaints against the Department or its employees, and that annual statistical summaries of such investigations by the internal affairs function be made available to the public. The following is a summary of complaints filed for the calendar year 2023.

Takoma Park Police Department Internal Affairs Complaint Investigations



Eleven complaints were recorded in 2023 with five subjected to internal investigations and seven subjected to administrative investigation reviews. Four complaints were submitted by community members and seven were submitted internally by an employee, the Chief of Police, or a member of the Command Staff. The majority of complaints received in 2023 were initiated by police department employees. There were two compliments submitted using the online option thanking officers for their handling of calls for service.

Subjects of the complaints in 2023 include a total of 10 sworn officers. More than one officer may be listed in a complaint or may be involved in more than one incident. Four civilian employees were the subject of a complaint.

Two of the complaints resulted in sustained findings of improper conduct. In one of the sustained cases, disciplinary action is pending, as the involved staff member has requested an administrative hearing board per the new Statewide Police Disciplinary process**. Two of the complaints received were unfounded, four were investigated and resulted in performance counseling being issued to involved staff, and three are still being investigated.

The 2023 statistical comparison with 2022 indicates an increase of five complaints in 2023 compared to 2022, with six complaints received in 2022 and 11 in 2023. All Takoma Park Police sworn officers wear body-worn cameras. Body-worn camera footage is essential in determining if the complaint is unfounded or provides evidence to support the allegations based on a review of the camera footage.

In 2023, officers had a total of 12,675 contacts with the public, which included calls for service, self-initiated calls*, and traffic stops. The complaints received represent less than one percent (.00087%) of all contacts made by officers from the Takoma Park Police Department in 2023.

Residents are reminded that the purpose of making a complaint against a police employee is detailed on the City of Takoma Park web page by selecting the government tab and then selecting the police tab. The information is also available on flyers available to the public in the police department’s lobby. Complaints and compliments can be filed online through the webpage.

Police Accountability Board**

The Police Accountability Board (PAB) – Administrative Charging Committee (ACC) must:

- Work with law enforcement agencies to review, provide policy advice and report on disciplinary matters stemming from public complaints about police misconduct.
- Hold quarterly meetings with the directors of one or more law enforcement agencies operating in the County who employ one or more police officers
- Appoint civilian members to the ACC and trial boards

- Receive complaints of police misconduct filed by a member of the public
- Review the outcomes of disciplinary matters considered by the ACC on a quarterly basis
- Advise the County Executive and Council on policing matters and
- Refer each complaint of police misconduct filed with the PAB to the appropriate law enforcement agency within 3 days after receipt for investigation.



Use of Force Activity

The Takoma Park Police Department has stringent reporting guidelines for Use of Force incidents. The Department's policy requires reporting under the following situations:

- Any use of a secondary weapon
- Any physical strikes
- Pointing a Taser or firearm in the clear direction of an individual
- Non-deadly force without a weapon that results in apparent physical injury or purported claim of injury
- Deadly Force
- Any intentional or unintentional discharge of a firearm or Taser
- K-9 deployment with injuries
- Any material difference in description of force reportedly used by an officer and reported by the subject upon whom the force was used.

An analysis was done on Use of Force incidents for the year 2023 and resulted in the following:

USE OF FORCE INCIDENTS – 22

There were 22 incidents in which force (use of force or show of force) was used/claimed in 2023. Eleven incidents were show of force incidents which gained compliance. All of the 22 Use of Force incidents were investigated and found to be justified and in accordance with Department Policy.

In 2023, Takoma Park Police officers had a total of 12,675 contacts with the public, which included calls for service, self-initiated calls, and traffic stops. Takoma Park Police Officers used force in .0017 percent of all contacts made by officers of the Takoma Park Police Department, which is less than one quarter of one percent of all contacts made.

The breakdown of the reported Use of force incidents is as follows:

Victim Witness Coordinator Statistics

The needs of victims within the service area of the City of Takoma Park can vary. Variables may include the type and extent of each individual crime, the existing support already in place for each victim, the age of the victim or the victim's financial needs. Some victims may require as little as basic information given by a police officer in the form of a pamphlet provided by the State, "Crime Victims and Witnesses: Your Rights and Services." Other victims may need many hours of support and assistance provided by police officers, the Takoma Park Police Department Victim/Witness Assistant and other related service providers.



The Victim Witness Coordinator, a civilian police employee, may initially come into contact with a victim at a crime scene if called in by an officer or detective, especially if the victim needs emergency services such as safety planning, protective orders, emergency shelter, or crisis counseling. The Victim Witness Coordinator contacts most victims to offer support, information, and accompaniment to court or offices of other agencies for services. A victim's needs are assessed at that time and referrals for additional services such as counseling, medical care, support groups, and compensation are given to victims after the crime or incident. The Victim Witness Coordinator also acts as a liaison between the victim and detectives investigating a case by

scheduling interviews, follow-ups, and translation for Spanish-speaking victims. They then pass on important information to victims and witnesses and explains police procedures, the investigative process and the criminal justice system. If requested, the Victim Witness Coordinator accompanies victims and witnesses to pre-trial interviews with prosecuting attorneys and additional court proceedings.



The Victim Witness Coordinator contacts people seeking information pertaining to unreported incidents or other concerns, such as family or immigration issues. These cases involved mostly Part I serious crimes; Part 1 crimes include murder, rape, aggravated assault, robbery, burglary, larceny, motor vehicle theft, arson, human trafficking – commercial sex acts, and human trafficking – involuntary servitude, as well as cases of domestic violence, assault, identity theft, runaways, elder abuse, child abuse and sex assaults.

The Victim Witness Coordinator is responsible for gathering all evidence, including photos, statements, lethality assessments, 911 calls, and all reports in cases of domestic violence. This information is then turned over to the State's Attorney's office for prosecutorial purposes. These cases are the most time-sensitive and intensive because of the possibility that abuse may increase.

The Victim Witness Coordinator is tasked to monitor court calendars for officers and personnel who have been subpoenaed to testify in criminal and traffic cases and also serves as a liaison between the department and the State's Attorney's Office. The Victim Witness Coordinator ensures there are no conflicts or complications, or additional information is needed for court. The Victim Witness Coordinator gives presentations related to victim's rights, issues and resources in the department's Community Police Academy. In addition, the Victim Witness Coordinator trains new officers on victim advocacy and domestic violence, translates Spanish/English as needed (both written and verbal) and maintains relationships with related service agencies in Montgomery County, as well as other counties, by attending meetings, webinars and trainings.

During 2023, the Victim Witness Coordinator directly engaged with 44 domestic violence victims, six sexual assault victims, four assault victims, one attempted murder victim, and one first-degree assault victim. There was a total of 276 contacts with victims of other crimes. Additionally, the coordinator provided Spanish language translation support 76 times, extending assistance not only to crime victims but also to the police department and various departments within the City of Takoma Park. The Victim Witness Coordinator played a pivotal role in handling and processing 1,203 court subpoenas for police personnel.

Notable Cases

- Referrals for Substance abuse were provided to parents of juveniles.
- Assistance and support for parents of a minor victim whose case did not proceed with the State's Attorney's Office.
- Established and maintained a rapport with a confidential source, obtaining crucial information for unresolved cases related to food truck robberies. Continuously stayed in contact with the source and communicated essential information to the detective in those cases.
- A participant in the Community Police Academy requested assistance through our Police Public Information Manager who referred her to the Victim Witness Coordinator. The victim was facing harassment and threats from a neighbor. Through training and experience, a comprehensive list of resources from neighboring jurisdictions was provided. As a result, the victim successfully obtained a peace order against the troublesome neighbor. Additionally, the homeowner was guided through the process of filing the necessary petition with the Maryland Court to have the tenants removed.
- Following discussions with a member of command staff, it was decided that the Victim Witness Coordinator would pursue referrals to support a mother who recently lost her job and babysitter. The mother was referred to A Wider Circle and maintained persistent communication with the agency, who advocated for the resident, and updated them on any changed circumstances. The objective was to ensure the home was in suitable living conditions for an upcoming home-life inspection. A Wider Circle prioritized equipping the resident's home. Additionally, the coordinator received assistance from the City's housing department to facilitate the approval of Takoma Park Cash assistance.

Honor Guard

The Takoma Park Police Department's Honor Guard was formed in the late 1980's and is made up of members from all ranks. The Honor Guard participated in various details on behalf of the City and Police Department listed below.

Support Services Division

The Support Services Division consists of one Lieutenant (Division Commander), a Records Clerk, Logistics/Payroll Clerk, Warrants/National Crime Information Center, Parking Permit Coordinator, and six Communications Dispatchers.

The Administrative Services Division is responsible for overseeing various functions that support the overall departmental units. These functions include policy review and development, fleet management, quartermaster/supply, technology implementation, grant research, budget preparation and administration. The communications section, which consist of a supervisor and six dispatchers, provides 24/7 communications services to the police department/public as well as 24/7 front desk services for residents.

Current Staffing

The department is currently authorized 43 sworn officers. We currently have four vacancies

Training

Training is a vital component to maintain and improve interactions with community members. Takoma Park Police Department continues to send members of its agency to various training throughout the years – from command staff members to private officers. Other than the vigorous and all-encompassing training that officers receive in the police academy, they continue to learn and hone in on their training skills through in-service training in our agency annually, as well as outside training. They train to work with the disabled, senior citizens, veterans, developmentally disabled, as well as persons with mental health issues. In addition, training includes supervisory liability, effective coaching, team building, media relations and law enforcement bill of rights. 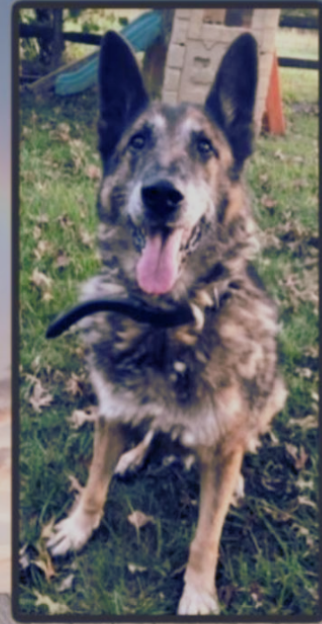
Audits
