2018 DATE 4/21	NAME Erik Dussere		I am writing because NDC's revised plan for Takoma Junction fails to address critical aspects of the Development Agreement and further endangers the survival of the Co-op. The Development Plan specifies that a primary project goal is "support of independent businesses" and a "retail-tenant mix with high priority for local and regional operators." Despite the extremely favorable rental terms in its 99-year lease from Takoma Park, NDC does not plan to pass on the benefits to local businesses. To the contrary, high rents will favor chain stores and drive up rents in the area, thus jeopardizing the local businesses we already have. They have already named one figure for the rent the Co-op would pay to be its anchor tenant—and then raised it 50%. Another goal is "encouraging alternate modes of transportation in relation to the property"; I fail to see how eliminating the bus stop and city bikes does that. The Co-op is the business most at risk. Rather than make parking and deliveries easier for the Co-op, the latest plan is actually worse: it requires shoppers and delivery people to traverse the length of the development to go between the Co-op and their vehicles (thus increasing the amount of time trucks are parked, as well). The Co-op is THE Takoma Park business we use and need the most. It reflects our city's values, contributes to the community, and provides decent jobs. I also really appreciate access to food. I don't want to drive to Safeway or Whole Foods every time I'm out of eggs or need a vegetable for dinner—especially if it means I have to drive through or detour around the Junction. Now it looks like we could lose our Co-op only to gain a development that doesn't meet the city's original goals. Throughout this process, I have been mystified by the City Council's continuing faith in NDC, and its apparent deafness to the community voices expressing concern. NDC has not inspired confidence: they didn't bother to meet with

Will the project, as it is now configured, lead to the development of small local businesses? Will it only make traffic problems in the immediate area worse? With its higher commercial lease rates, will the project lead to further gentrification and additional financial pressures on existing businesses? And what impact will the project have on the coop? I urge the Council and the Mayor to rethink this project and go back to the drawing boards. I realize how difficult vour job is, but that's Takoma Park and the input is part of what makes our City so special. I thank you for your continued service to our community.
