As we redevelop this precious city land, I find nothing about the status quo that is worth keeping— including the Co-op. I am a long-time member and frequent (large-family) shopper, but from my perspective, the location has always been a problem (yes, since 1998). I never let my children bike to the co-op, and even walking there has been a problem. I have observed many car accidents in front of the Co-op and of course have found the traffic to be a headache. There are MUCH better locations that would serve the Co-op (and the community) better. I find the notion of limiting the development of one of the last precious walkable parts of Takoma Park to accommodate large truck deliveries to be illogical (and ironic). I am delighted with the two-story building proposed but would prefer something larger, in keeping with the principals of smart growth. I live near Old Town and in the last twenty years, we have gained numerous large buildings as well as dozens of new businesses. We have more traffic, yes, but also more walkers and more delightful places to meet and enjoy our neighbors. Each of these changes was resisted by neighbors, and each development is imperfect because making a building financially profitable usually conflicts with other community needs. I have been a coop member since we moved to Takoma Park in 1986 and I like the convenience of having the store at the Junction. However, I am dismayed and frustrated that the discussion of the Junction redevelopment seems to have become such a divisive issue in our community. I DO NOT WANT TO START OVER IN THE REDEVELOPMENT PROCESS. I think we can only go forward and try to reach a compromisewhich means that all sides may have to give something up for the final plan. Suzanne Ludlow, the City Manager, told me at the open house on the budget that Takoma Park is now getting interest from businesses that are potentially interested in locating in or near our town. More economic development should result in additional tax base that will help fund the services that residents are requesting, but for which the City has not had the funds because residents are concerned about paying higher property taxes. This lot has been used for the last 20 years for parking, not the highest and best use of city property. I do have questions and concerns about the redevelopment. I am concerned about increased traffic since I have to go through that intersection to get to and from downtown Takoma Park. The city is now renovating the Ethan Allen / New Hampshire intersection and I am waiting to see if it will affect traffic that now backs up at times between the Junction and New Hampshire Avenue. 5/16	Andrew Strongin	3	I am writing to express my opposition to the NDC Development Project as presently constituted, for the following reasons: 1. The proposed structure is too massive, overwhelming the adjacent structures on Carroll Ave and literally looming 55' tall over the residences on Columbia. It'll be like the Mormon Temple hovering over the Beltway, except it'll be a parking garage towering over the "freed lot" and the BF Gilbert residential neighborhood. That you allow NDC to continue to refer to the undeveloped portion as a "treed lot" is an affront to trees everywhere. Also, the drawing off which you're working, which the City staff insistently and misleadingly references as a "Site Plan," of course is nothing of the kind, which should be obvious to anyone with any familiarity with the Zoning Ordinance. A Site Plan is an actual thing, with a real definition. Among other things, a "Site Plan" would include a scale drawing, whereas the concept presented by NDC is neither to scale nor realistic given it fails to show the shadow that will be across the sidewalk for most of every day. 2. The underground parking plan is obviously unsafe, as those exiting the unsignaled driveway will have to negotiate a blind turn onto Carroll, whether into or across oncoming traffic. There literally is no way a car can exit the driveway and see the traffic coming eastbound on Carroll without pulling all the way across the sidewalk and nosing into the traffic lanes. This is unsafe, and unless it is addressed should be a nonstarter. 3. There is no useful public amenity offered by NDC, except to those who can afford to shop in the (still unnamed) shops/restaurants. Indeed, the reported callousness of one among you, who allegedly suggested that residents who can't afford to shop in the new stores/restaurants nevertheless will be permitted to "window shop," if true, is astoundingly, staggeringly foul. Seriously, I hope the report is untrue. Beyond that, NDC is trumping up its bogus claim that the cement pad and fixed benches will provide a great
