Information to Share

New Hampshire Avenue Recreation Center Ownership Transfer

This morning the Bi-County Maryland-National Capital Park and Planning Commission (MNCPPC) formally approved the land swap with the City of Takoma Park that transfers ownership of the Takoma Park Recreation Center on New Hampshire Avenue to the City of Takoma Park and an undeveloped parcel along Long Branch Creek to the Commission. Legal paperwork remains to be completed, but essentially the Recreation Center becomes the property of the City of Takoma Park on July 1. We are looking to have a small gathering at the Center to ceremonially transfer the property, with a date to be determined. This action is a great step forward for Takoma Park and for advancing our community's plans for the New Hampshire Avenue Corridor and residents of the eastern side of our City.

Suburban Deer Management Presentation

Discussion of Tax Credits

As part of the FY20 budget discussions, we decided to tentatively schedule time in July to discuss property tax credit options. I have asked the Mayor to push back that discussion until after the August recess. Right now, our Finance Department is very short staffed (there are currently two vacant positions with an impending retirement coming), and they need to focus on the annual audit, which is required by law, as well as the work required each year as we transition from one fiscal year to the next. Jason and I are also very busy managing operations with two vacant department head positions, among other things. In short, I do not foresee an opportunity to do the prep work that would be needed for a discussion of options for property tax credits in July. I do want those discussions to happen soon, but wanted to let you know that we do not have the capacity to undertake this in the next two months.

117 Elm Avenue No Longer Tax Exempt

As of April 10, 2019, the property at 117 Elm Avenue, formerly the John Nevins Andrews School, is no longer tax exempt. The assessed value of the property as of July 1, 2019 is \$6,359,667, so the anticipated annual tax payment from the property will be \$34,323.

Maryland Municipal League Convention Next Week
