**WMATA Proposed Budget, beginning July 1, 2020**

The WMATA Proposed Budget includes a number of changes to both Metro Rail and Metro bus services and fares. Metrorail changes include restoring late night hours to midnight Monday-Thursday, and 2:00 am on Friday and Saturdays; increasing Sunday service; adjusting early morning weekday service before 6:00 a.m. to longer headway.

**Metro Bus proposed service changes**

- Increase the weekend frequency on high-ridership corridors that connect to Metrorail, and improve some Sunday frequencies to match Saturday service. Routes: 7A, 7F, 23B, 23T, 28A, 80, 83, 86, A12, C29, E4, F4, P6, P12, S2, S9, Y2, Y8
- Extend hours on four MetroExtra limited stop routes and improve frequency on one route. Routes: 16Y, 79, K9, X9
- Adjust frequency and hours of service  
Reduce hours of service, generally eliminating the first or last early morning and/or late-night trips, that have low ridership.  
Impacted routes: 92, 96, C4, D4, D6, E2, J2, K6, L8, T2, W1, Y2
