Public Statement Regarding Dispute Between NDC and the TPSS Co-op

City Statement of April 28, 2021

The City of Takoma Park issued a public statement this morning regarding the ongoing dispute between the Neighborhood Development Company and the Takoma Park Silver Spring Co-op. Over the past week, the City of Takoma Park has been actively involved in discussions to bring about a resolution to the dispute and to ensure that the Co-op is able to continue to receive grocery deliveries.

Tax Duplication Funds Being Discussed this Week at County Council

The County Council's Government Operations & Fiscal Policy (GO) Committee will meet on Friday afternoon to discuss what tax duplication funds will be allocated to Montgomery County municipalities in FY22. There will also be a discussion about how the process of tax duplication rebates may be changed going forward. Nancy Navarro is the Committee's Chair and Andrew Friedson and Sidney Katz are members. Their Committee recommendation will have heavy weight when the full County Council vote on the FY22 County Budget.

The Montgomery County Chapter of the Maryland Municipal League is **urging the County Council to vote to pay the full tax duplication amount.** That would mean adding \$5.2 million to the just under \$9 million proposed to be rebated to the 20 municipalities eligible for payments. It would mean an additional \$468,115 for Takoma Park for FY22. Negotiations for a fair Police Rebate formula would need to take place in the coming months to determine the right amount for those services, beginning in FY23.

Please contact the County Executive and the County Council to demand that the County pay the full amount of tax duplication money this year and every year.
