

City Manager's Comments

ARPA Updates:

The City is approaching 1,300 households who have received assistance through the Direct Cash Assistance program and staff is in the process of scheduling additional in-person events in the near future. If the City continues to average around 5 applications per/day as it did in February, the City would hit its target 2,100 households by the end of the year. To be eligible you have to be a Takoma Park resident earning under \$50,000/year. You can apply by coming to the Takoma Park Community Center between 8:30am-5:00pm; M-F during the week, or use the City's Direct Cash Assistance web-page https://takomaparkmd.gov/government/american-rescue-plan-act-arpa/arpa-social-services-partnerships/direct-cash-assistance/

Once on the City webpage, you can also search the phrase "Direct Cash Assistance" and the first item returned in the search will take you to the application page.

Housing & Community Development Updates:

3/29 Road Closure To Be Rescheduled: via Resolution last month, Council had approved the temporary closure of the 6900 block of Laurel Avenue for the purpose of conducting limited traffic counts. After internal conversations, staff have decided to delay this closure date until a more comprehensive count can be conducted. Further information will be provided to Council and the public when a new date is proposed.

Transformations Exhibition Opening: There will be an opening reception at 7:30 pm on March 23rd for a new exhibition titled, Transformations, which will feature work by local artists Beth Caruso, Landry Dunand, and Randall Williams. Their work explores transformations of paper-based mediums through photography, digital tools, and cut paper. The exhibition will be on view until June 7th.
