Public Works:

• The State Highway Administration's Carroll Avenue project is in the final phase which will be the milling and resurfacing of portions of Carroll Avenue between the DC line and University Blvd. The resurfacing work is expected to start November 8th and be completed in early December. The initial resurfacing work will be done at night - between 8 pm and 5 am. This will affect the sections of Carroll Avenue between the DC line and Westmoreland Avenue and from Philadelphia Avenue to Lee Avenue. Once those sections are complete, the work will shift to daytime paving which is expected to start Nov 20 from 7 am to 7 pm. This will affect sections of Carroll Avenue between Lee Avenue and Jefferson Avenue, the former Hospital entrance to Flower Avenue and Long Branch Parkway to University Blvd.

During the work, one lane will remain open to travel and there will be a flagging operation directing traffic through the work zone. Work days are Monday through Friday, but will not include the Thanksgiving holiday. During the paving operation, travel through Carroll Avenue is expected to be impacted. Side streets near the work areas may also experience temporary closures.

- The State Highway Administration has notified the City that crosswalk markings and stop bars are being replaced over the next several weeks along MD410.
 - o The locations on Philadelphia Avenue include: at Chicago Ave, Takoma Ave, Piney Branch Rd, Chestnut Ave, Holly Ave, Cedar Ave, Maple Ave, Holt Place and Carroll Avenue.
 - o The locations on Carroll Avenue include: at Grant Ave.
 - o The locations on Ethan Allen Avenue include: at Sycamore Ave, Manor Circle, Jackson Ave, Prince Georges Ave, Elm Ave and New Hampshire Ave.
- The Public Works Department recently received several grant awards. This includes \$10,000 from the Pepco Sustainable Maryland program and \$5,000 from Maryland DOT Urban Tree Program Grant for the establishment of a pollinator arboretum in Stuart Armstrong Gardens (Hodges Lane and Philadelphia Avenue). The Department also received a \$4,875 grant from the MDOT Tree Grant Program for our Takoma Tree initiative. The Department acknowledges the efforts of Anna Mische John, our Vegetation Maintenance Supervisor, and Marty Frye, our Urban Forest Manager in receiving this funding.

- City Manager search update- The position was posted in early October and closes November 15, 2023.
