

# Report for City Council Meeting of September 19, 2018

#### Information to Share

### **Dorothy's Woods**

On September 10, 2018, the City Council met in closed session to consult with the City Attorney regarding options for the preservation of the City's interest in and control over the City-owned Dorothy's Woods parcel, which was subject to a foreclosure action by Fairview Investment Fund, the holder of a lien secured by the property, and scheduled to be sold at auction on September 13. Fairview sought to collect \$382,600 in principal, interest, penalties, and expenses from the proceeds of the foreclosure sale.

Dorothy's Woods, a 2.68 acre, mostly wooded parcel, is one of the largest undeveloped properties in Takoma Park. The City purchased Dorothy's Woods at an IRS auction in 2015 with the primary intent of preserving it as open space.

Preceding the September 10 Council Meeting, the City Attorney engaged in negotiations with Fairview regarding securing the City's interest in the property by either purchasing Fairview's lien or having Fairview release the City's property from the lien. Fairview's lien was secured by the City's property as well as an adjacent property still owned by Washington-McLaughlin Christian School, but Fairview's lien was the first priority lien on the City property and was subordinate to a lien held by the U.S. Department of Housing and Development Department on the School's property.

After considering the history of the negotiation, the limitations on the potential to recover additional funds from Washington-McLaughlin Christian School if the City purchased the lien, and the risk that the property would be purchased by a developer at the foreclosure auction, the Council authorized a settlement with Fairview involving a payment of \$250,000 to Fairview in exchange for the dismissal of the foreclosure action against the City's property and the release of the City's property from the lien. Mayor Stewart and Councilmembers Kovar, Dyballa, Kostiuk, Seamens, and Smith voted in favor of the settlement. Councilmember Searcy voted against the settlement.

As a result of the settlement with Fairview and the City's earlier negotiation with HUD for the release of the City's property from its lien, the City's property is now free from the \$382,600 Fairview lien and the \$624,800 HUD lien.

The \$250,000 payment will be made from approximately \$150,000 of City funds and \$100,000 in resident donations. The total expenditure of City funds to purchase the property and obtain the release of the Fairview and HUD Liens is approximately \$235,000, including legal fees, the payment to Fairview, and the purchase price at the IRS auction. This total was offset by \$69,400 in earlier resident donations and the recovery of previously unpaid property taxes.
