ARPA:

Recipients of the Direct Cash Assistance are being contacted with a brief survey concerning the program. If you were approved for this program, please take a few moments and respond to this survey so that the City can better serve you in the future.

Public outreach for the Direct Cash Assistance program continues but has only brought in a few more approved applications and we continue to see a number of applicants from folks who believe there has been another round of funding. We are working to organize additional in-person events to try and reach as many people as possible before the end of October. We are now eyeing early November for next round of Council deliberation on what will happen next in the program.

Finance:

The city has been working on our yearly audit since the end of August. The Auditors will be working out of the Atrium meeting space for the next two weeks to finish the process.

The City met with the Police Pension Board on Tuesday, September 12th. The Actuary will give the Council a presentation in November with recommendations for contribution and will provide an updated rate for the FY25 budget. The City has broached the topic of ESG (Environmental, Social, & Corporate Governance) investments. Discussion included returning to quarterly meetings, so the next meeting will be January 2024.

- If you have signed up to provide testimony and are attending at the Community Center, please be sure to check in upon arrival with Larissa from the Planning Board.
- Testimony is limited to three minutes.
- If you did not register in advance to provide verbal testimony, there will be instructions provided with how to submit written testimony.
