Burglary – Entry into a building or residence illegally with the intent to commit a crime, especially theft.

CDS – Controlled Dangerous Substance.

Contact Shooting – An individual(s) was shot.

Emergency Evaluation Petition – An emergency evaluation petition is a legal process that enables a petitioner (sometimes a police officer) to get a person who is suffering from a mental illness or is in a serious mental crisis taken into custody and examined by a medical professional in a designated emergency facility. *This information is not released for the privacy of the individual(s)*.

Home Invasion – Involves breaking into a dwelling or home that is occupied. A dwelling can be defined as a house, apartment, houseboat, dorm room, RV and camp ground site. Felony home invasion is a first-degree burglary charge if it involves a dwelling and there is an intent to commit a violent crime.

Larceny – Theft of property.

Posted from Property – Given a trespass notice and cannot return to the property.

Robbery (**Strong Arm/Armed**) – The action of taking property unlawfully from a person or place by force or threat of force. If using a weapon, it's armed.

Suicide - *This information is not released for the privacy of the individual(s).*

Suspicious Situation – This information is not released so as to preserve the integrity of an investigation.
