Unattended Death - The phrase unattended death refers to a death in which the body is not found for days, weeks, or in some cases, months. Unattended deaths happen most commonly with the elderly, especially if they reside alone and do not have family or friends that check on them regularly. *This information is not released for the privacy of the individual(s).*
