# NORMS & CONVERSATION GUIDELINES

- Enter with Curiosity. When things get difficult, turn to wonder.
- Mute your microphone until you are about to speak.
- Listen to understand, not to respond.
- Encourage disagreement, while not being disagreeable (by behavior).
- · Stay mentally and physically present.
- Make it a brave space fearlessly share ideas, ask questions, and contribute unconditionally.
- Respect each other's thinking and value everyone's contributions; we are all contributors.
- Speak in "rough draft" we are all learners.
- Bring your thoughtfulness to your responses by being concise so that others may have time to speak.
- Seek first to understand, then to be understood.
- Listen attentively to others...don't interrupt.
- Attack the problem, not the person.
- Avoid taking a narrow view based on who you are and your role in the organization.
- Use "I" statements.
- Assume good intentions.

# STAKEHOLDER AUDIT PROCESS

- As a precursor to the establishment of the Task Force, Team LINK conducted a series of targeted interviews and focus groups to gauge community perception of Public Safety in the City of Takoma Park.
- The Audit included but were not limited to, Takoma Park community members, faith leaders, business leaders, multi-family tenants, resident managers, educators, city officials, and participants from other national public safety taskforces.
- From the audit conversations, Team LINK heard consistent themes. These findings will inform our work moving forward.



### GENERAL STAKEHOLDER FEEDBACK

- We heard the need to identify a working definition of "Public Safety" and what that means for the City of Takoma Park.
- Stakeholders suggested that the Task Force prioritize the needs of residents, especially those in marginalized groups/communities.
- We heard the consistent importance to review relevant data to identify the key areas of community concerns as they relate to public safety.
- Stakeholders recommended that we create many entry points for engagement, including exploring opportunities for feedback and survey of the community.
- Stakeholders recommended that the Task Force discussions include the structural disadvantages of disinvestment in marginalized communities, lack of educational opportunities, and community resources.

### GENERAL STAKEHOLDER FEEDBACK

- The Task Force can consider discussing mental and emotional health, in additional to the trauma-informed care.
- Stakeholders suggested that, if they were on the Task Force, they would consider recommendations to Council that include investing in training related to cultural competency and effective communication.
- Stakeholders recommended that the Task Force partner with City Departments throughout this process to reimagine public safety.
- Many stakeholders suggested the Task Force explore opportunities for youth involvement in the process.
- We heard that stakeholders would like to see Task Force conversations around expanding community and recreational activities, as they relate to public safety.
