Dear Ms. Bogdan:

We have completed our review of the preliminary plan uploaded on eplans dated November 6, 2020 that will be reviewed by the Development Review Committee at its March 19, 2019 meeting. We recommend approval of the plan subject to the following comments:

All Planning Board Opinions relating to this plan or any subsequent revision, project plans or site plans should be submitted to the Department of Permitting Services (DPS) in the package for record plats, storm drain, grading or paving plans, or application for access permit. Include this letter and all other correspondence from this department.

Significant Plan Review Comments

- Conventional bike lanes are master planned along the site frontage. We strongly recommend
 Maryland State Highway (MDSHA), the Maryland-National Capital Park & Planning Commission
 (MNCPPC) and the City of Takoma Park to ensure that the applicant build the bike lanes along the
 frontage with proper transition at both ends of the subject property.
- 2. We do not support the location of truck loading layby area for the following reasons:
 - a) The truck loading area transition appears to extend beyond the eastbound stop bar for the signal at Carroll / Ethan Allen.

- b) There is an existing bikeshare station closer to the roadway intersection and the proposed truck loading area is eliminating it. The existing bikeshare should remain in place and shall be shown on the plan. Please coordinate with Mr. Kyle Lukacs of our Division of Transportation Engineering. Mr. Lukacs may be contacted at kyle.lukacs@montgomerycountymd.gov or at 240-777-7207.
- c) There is an existing bus stop which should also remain in place. We recommend that the applicant install a bus shelter. If the applicant is planning on relocating the existing bus stop it should be within the right-of-way. At or before the certified preliminary plan, please coordinate with Mr. Wayne Miller of our Division of Transit Services to coordinate the size of the bus stop area, a shelter and also the location of the bus stop if the applicant plan on relocating the existing bus stop. - d) Per the plan, the proposed sidewalk is not located in the public right-of-way.
- 3. We recommend that a minimum of three feet in width be maintained between the access point and property line to ensure a minimum of six feet between driveways for a pedestrian refuge area should the neighboring property to the west redevelop. This will also prevent encroachment on the rights of adjacent properties.
- 4. The proposed sidewalk as shown in the plan is outside the right-of-way. Provide a minimum 5-foot continuous clear pathway (no grates) along all public streets located within the public right-of-way.

5. Transportation Demand Management

- a) <u>Bikeshare</u>: The preliminary plan drawing does not show the location of the existing bikeshare station at Carrol and Ethan Allen Avenue but shows a layby immediately adjacent to the station. The Statement of Justification does not address the bikeshare station moving. Safety would be compromised if a bikeshare station is right next to a layby where vehicles are pulling in and out. Precautions should be taken at all phase construction so as not to impede access to the bikeshare station or in any way negatively impact the station. Please coordinate with Mr. Kyle Lukacs of our Division of Transportation Engineering regarding possible relocation of the existing bikeshare station. - b) It is recommended that the Applicant be required to allow Commuter Services to promote alternative modes of transportation to employers at the development. This would include the promotion of bikeshare. The applicant should coordinate with Ms. Sandra Brecher, Chief of the Commuter Services Section at Sandra.Brecher@montgomerycountymd.gov or at 240-777-8380.

Standard Plan Review Comments

- 6. Show the necessary dedication from the centerline of Carroll Avenue (MD-195) in accordance with the Master Plan.
- 7. Columbia Avenue is maintained by the City of Takoma Park. We defer to them for any improvements along Columbia Avenue.
- 8. We defer to Maryland State Highway MDSHA for any improvements along Carroll Avenue (MD-195).
- 9. Sight Distance: The sight distance for the proposed access shall be approved by MDSHA.
- 10. **Storm Drain Analysis:** The Storm Drain shall be approved by the MDSHA and/or City of Takoma Park.
- 11. If the proposed development will alter or impact any existing County maintained transportation system management component (i.e., traffic signals, signal poles, handboxes, surveillance cameras, etc.) or communication component (i.e., traffic signal interconnect, fiber optic lines, etc.), please contact Mr. Kamal Hamud of our Transportation Systems Engineering Team at 240- 777-2190 or at kamal.hamud@montgomerycountymd.gov for proper executing procedures. All costs associated with such relocations shall be the responsibility of the applicant.
- 12. Provide a ten-foot-wide Public Utility Easement along your site's street frontage.
- 13. Upgrade pedestrian facilities at intersections along the site frontage & at adjacent intersections to comply with current ADA standards.
