Thank you for the opportunity to review the Traffic Impact Study (TIS) prepared by The Traffic Group, Inc, for the (Takoma Junction development – SHA Tracking #19-AP-MO-008-xx) in Montgomery County, Maryland. The State Highway Administration (SHA) review is complete and we are pleased to respond.

- Proposed access to the 26,768 square feet of office space, 13,377 square feet of retail space, and 9,821 square feet of quality restaurant is via one (1) full movement site access to MD 410.
- The following intersections were analyzed under existing, background and future conditions:
 - o Ethan Allen Ave & Carroll Ave/Sycamore Ave
 - o Carroll Ave & Philadelphia Ave
 - Carroll Ave & Site Access
- The report concludes that the study intersections will continue to operate at acceptable levels of service under future conditions.

- 1. For the response to TFAD Comment #4, we request that the revised report note that the SimTraffic model was calibrated, and if any calibration data is available that it be included in the appendix.
- 2. For the response to TFAD Comment #6, the queue summary tables in the revised report should reflect the actual storage lengths available for the respective queues.
- 3. For the response to TFAD Comment #11, it states that the Co-Op site's access will change to be from Sycamore Avenue only. Does space exist on the site to provide circulation for two-way traffic, and how will this change in access be coordinated with the Co-Op?
