

Artists, dancers and soup-makers open up shop

New Takoma businesses showcase food and the arts

The economy may be faltering, but the entrepreneurs in Takoma Park and Takoma, D.C. remain undaunted. Existing businesses are gearing up for the holiday season, with window dressings, increased inventories and plans for the annual open house. And three new businesses have opened their doors in the last month: ArtSpring, an art gallery and shop; Knock on Wood, a dance studio; and Soupergirl, a café and takeout.

"I think there's a momentum building," says Roz Grigsby, executive director of the Old Takoma Business Association. "There's something about critical mass." Business owners considering Takoma Park have taken note of the several new openings around town: Trohv, Takoma Bicycle, the Green Commuter, Mayorga, Cedar Crossings and My Little Bistro among them. Grigsby adds that the community has been shifting toward more young families as well, and it continues to be home to young professionals. "I think that's particularly appealing to a business owner," she says.

Here's what to expect from the newest spots in town:

ArtSpring Pops Up in Old Takoma

This "pop-up" community arts store and gallery, established by artists in 2008, opportunistically fills empty retail spaces for as long as a landlord needs a cash-poor, but vibrant, tenant that brings foot traffic to the neighborhood.

When ArtSpring's last short-term lease ended in Silver Spring, Takoma Park entrepreneur, landlord and Arts and Humanities Commission member Charlie Pilzer suggested that it was Takoma Park's turn. He offered ArtSpring a space at 7104B Westmoreland Avenue, wedged between his recording studio, Airshow Mastering, and the Curves gym. "Charlie has made us a very generous deal, and we're excited to be in Takoma Park," says Chris DerDerian, one of the managing partners of the store.

More than 200 artists, most of them from the local area, have sold pieces at ArtSpring. Selections at any given time might include painting, photography, jewelry and works in ceramics, clay, fabric, wood, metal, paper and other media.

Sales help to support Pyramid Atlantic Art Center, a Silver Spring studio devoted to printmaking, papermaking and the book arts. ArtSpring will be open every day except Monday.

After settling in on Westmoreland Avenue, ArtSpring intends to become a hub of activity. In prior locations, the store hosted weekend classes for kids and wineand-art nights for adults. "We're open to

Do you know your local businesses? If you have a favorite neighborhood coffee shop where they know your name and your drink, how much do you know about them? As a way to learn more about our business districts and ways to help them succeed, the City conducted the Commercial District Census (business survey) in 2010. It was also an opportunity to establish baseline data for future surveys. Every known business located in a City commercial district or within the City boundary was mailed a questionnaire. Of the 347 questionnaires mailed out, 141 businesses responded. Only businesses located within the City boundary were surveyed.

Retail, food lead business activities

While the City's commercial districts support a variety of activities, retail trade (25 percent) and food services (12 percent) are the bulk of businesses (37 percent combined). Other household services (personal, repair, community) account for 17 percent; professional and tech services about 13 percent; and health and social services followed close behind with 12 percent.

It is important to note that the City's census targeted commercial districts and included primarily ground-floor level businesses. It excluded non-district businesses such as Washington Adventist Hospital, associated office building businesses, Montgomery College, the Washington Adventist University and home based businesses.

Geographically, the Takoma Langley Crossroads area, near New Hampshire Avenue and University Boulevard, has the most businesses by far, at 48 percent of all businesses located in commercial districts. About 30 percent are located within Old Takoma (including Takoma Junction and Old Town). The rest are distributed in other nodes such as Maryland Gateway (New Hampshire and Eastern), Ethan Allen Gateway (New Hampshire and Ethan Allen) and smaller commercial corners.

Mom-and-Pop shops predominate

Most of the City's businesses are local mom-and-pops. While this creates a strong local identity, it also means that local retail-

Oct. 4 The Nominating Caucus will convene at 7:30 p.m. on Tuesday, Oct. 4, to accept nominations of candidates for Mayor and City Council for the Nov. 8, 2011 City of Takoma Park Election. The meeting will take place in the Takoma Park Community Center Auditorium, 7500 Maple Ave., Takoma Park, Md. While open to the public, only registered voters of the City may participate in the meeting. Nominations of candidates for Mayor shall be made on motion by any qualified voter of the City, and if such nomination is seconded by a qualified voter of the City, the person so nominated shall be considered a candidate. Nomination of each candidate for Councilmember shall be made on motion of any qualified voter of her/his ward, and if such nomination is seconded by a qualified voter of his/her ward, the person so nominated shall be considered a candidate. Any nominated candidate may decline a nomination during the nomination meeting. A person may only accept a nomination of one City office. The name of each eligible person nominated for the office of Mayor and Councilmember shall be placed upon the official ballot unless he/she files a declination with the City Clerk within three days after his/her nomination. Any person nominated as a candidate must meet the qualifications of the office for which she/he is nominated.

Voters registered with the Montgomery County Board of Elections at an address in the City of Takoma Park are eligible to vote in City of Takoma Park elections. If you are already registered, you do not need to do anything further.

If you are not registered, but wish to vote in the Nov. 8 City of Takoma Park election, or need to file a change of address, complete a State of Maryland voter registration form and submit it to the Montgomery County Board of Elections no later than Oct. 10, 2011.

Non-Citizen Voters

Residents of the City of Takoma Park who are not citizens of the United States are eligible to vote in City of Takoma Park elections. If you are already registered with the Takoma Park City Clerk's Office, you do not need to do anything further.

If you are not registered, but wish to vote in the Nov. 8 City of Takoma Park election, or need to file a change of address, complete a City of Takoma Park non-citizen voter registration form and submit it to the Takoma Park City Clerk's Office no later than Oct. 10, 2011.

General Registration Information Nov. 8, 2011 Takoma Park Election

To vote in the election on Nov. 8, a voter

must be a qualified voter of the City of Takoma Park and must have resided within the corporate limits of the City of Takoma Park for 30 days immediately preceding the election. The voter registration cut-off date is Oct. 10, 2011. Changes of address must also be filed by this date. Voter registration forms or change of address forms are available from the Takoma Park City Clerk's Office.

Homeowners Property Tax Credit Application Deadline Extended to Oct. 30

Are you eligible for a tax credit? The deadline for filing an application has been extended to Oct. 30.

The tax credit program is designed to help if you are a low or fixed income home owner, by limiting the amount you pay in property taxes. To receive the tax credit, an application and supporting documentation must be sent to the Maryland Department of Assessments and Taxation every year.

The maximum property assessment eligible for the credit is \$300,000, which means that even though your home may be assessed for an amount over this amount, it's only the first \$300,000 of its assessed value that will be counted for this credit. Here are the basic requirements for the program:

- Must own or have legal interest in the property
- Must be your principal residence
- Your net worth, not including the value of your home or qualified retirement savings/accounts, must be less than \$200,000
- Your gross household income cannot exceed \$60.000

While you are at it, don't forget to check your tax bill to see if you are getting a Homestead Tax Credit. This credit was automatically applied to your bill each year, but about a year and a half ago, the state made everyone apply again for this credit. You are entitled to it if your Maryland address is your primary residence.

I am a city tenant and wonder if the landlord may charge me a 10 percent late rent payment fee and also make me financially responsible for all repairs made in the rental unit. Are these charges permitted by City law?

First of all, a landlord may only charge a tenant a late rent payment ■ fee of up to 5 percent of the rent due for the rental period. (See Section 6.16.090 of the Takoma Park Housing Code). A late rent payment fee may not be charged if the rent is received within ten days of the rent due date.

If you are contesting a late rent fee charge, be sure you have written documentation confirming when the rent payment was received by the landlord. The burden of proof is on you if the complaint has to go a hearing before the Commission on Landlord-Tenant Affairs.

Second, the City's Landlord-Tenant Law indicates that a landlord is responsible for the payment of all repairs and maintenance of the rental unit (See Section 6.16.060.G). The landlord may not transfer this responsibility to the tenant unless the landlord can document that the damage being repaired was the result of negligence or misuse by the tenant.

This is true even if your lease says otherwise: Any lease provisions that conflict with City law are not enforceable (per Section 6.16.020 of the City's law). You may access the city code at www.takomaparkmd.gov on the left side, see "City Code."

Energy Efficient Rebate Program Being Offered to Homeowners

Montgomery County has recently received over \$1 million from the U.S. Department of Energy and is making this money available as individual grants to homeowners, to offset the cost of certain energy efficient project and products. It is available on a first come, first served basis to owner-occupied single family homes, townhouses and condominiums.

Each applicant can apply for a rebate of up to \$3,000 for energy efficient improvements, which can include building improvements such as duct and wall sealing, attic insulation, replacement of central air conditioning and heating systems, purchase of various appliances and installation of solar hot water heating systems.

ers are not benefiting from national advertising or loyalty programs that drive sales or foot traffic past their storefronts—it means these businesses are more challenging to run successfully.

The vast majority (81 percent) of businesses lease their premises, with reported retail space rented at an average of \$30 per square foot, and office space at \$24 per square foot. Most of businesses that reported owning the building in which they operate are construction related.

Most retail and food service businesses lease their premises. These rental rates varied widely within business districts as well as across districts. Ethan Allen Gateway reported the lowest range, hovering around \$18-20 per square foot. While in Old Takoma some rents were reported in the teens and \$30 dollar range, reported rents averaged \$24 a square foot. Takoma Langley Crossroads area retail tenants reported the most extreme variations (from the high teens to the \$50 range), with an average of \$32 a square foot.

Opening and Closing Doors

Perhaps most promising for the health of the City's commercial districts is the fact that, during the recession, at least nine new businesses opened. It is true, many more businesses closed, but their reasons were due to landlord reconstruction, family related issues and other non-local trends.

Takoma Park commercial districts did experience a reduction in income during the recession, but not uniformly. Between 2007 and 2010, 25 percent of the businesses responding to this portion of the questionnaire (81) reported an increase in sales, 49 percent reported a decrease, and 26 percent observed static sales. The majority of

The majority of businesses (at least at the time of the survey in the first half of 2010) were optimistic. Projecting forward three years, 55 percent of businesses anticipated an increase in sales, while only 30 percent of businesses expected a decrease.

Most businesses seemed to be cautious and were not considering any major changes. The majority intended to remain at their location, with 4 percent of respondents anticipating an expansion, 2 percent considering relocation, and 1 percent expecting to close (for personal reasons).

Businesses also had an opportunity to comment. An Old Town business owner felt that "Suitable commercial space in Takoma Park is scarce or absent. By suitable I mean: clean, well maintained, handicapped-accessible, secure (from holdups, break-ins), adequate parking." While her business is healthy and she expects an increase in sales for the next three years, she finds that the high rent makes the City a less attractive option when Silver Spring and D.C. offer suitable space.

Business Assistance

The City asked what types of public investments would most interest area businesses. The answer: mostly in marketing, with 12 percent of replies favoring marketing and advertising, 10 percent signage and branding visibility, 8 percent website development and 7 percent loyalty programs. One business in Old Takoma commented that "advertising encouraging local residents to support local business would help."

Eight percent of businesses identified parking as a problem, regardless of busi-

ness location. A Flower Avenue business experiencing increases in sales noted that they felt the "City of Takoma Park is currently losing lots of business because of this." Consistent with the image of Takoma Park as a green community, 8 percent of businesses would like support on energysaving and green business practices and 5 percent requested recycling support.

Less than 2 percent of businesses identified lower taxes, storage or co-op purchasing as useful means of City support, although two property owners commented on taxes as too high.

Many businesses also reported obtaining financing from non-commercial sources such as personal loans, credit cards and family, indicating that better outreach and marketing of available financing options may be valuable.

Where Do We Go from Here?

The Takoma Langley Crossroads area houses nearly half of the City's businesses, and it is clear that the area would greatly benefit from not only improvements to the physical infrastructure but coordinated marketing programs.

Especially along New Hampshire Avenue, the City's commercial districts are not in great shape. Signage and lighting is often substandard, and shopping areas need updates, maintenance and remodeling. The City has one façade improvement program underway in Old Takoma, which assists property and business owners with signage, remodeling and rehabilitation. A second façade program with a wider reach will be initiated this winter. The City also has three streetscape designs underway—

Fire, by the numbers

As of August 31, the Takoma Park Volunteer Fire Department and the personnel of the Montgomery County Fire and Rescue Service assigned to the station have responded to 508 fire-related incidents. The department addressed or assisted with 1,870 rescue or ambulancerelated incidents, for a total of 2,378 this year. Totals for 2010 were 566 and 2,202, representing a decrease of 390 incidents.

Another fire strikes the city

On Sept. 7, at 3:01 p.m., a serious fire occurred in a four unit apartment building in the 6600 block of Poplar Avenue. Units from Takoma Park, Silver Spring and Chillum Adelphia departments responded. The first unit to arrive on the scene was E702, reporting smoke coming out of the window on the first floor. The fire was under control within 30 minutes. It caused moderate damage to a room. No injuries were reported.

Investigators from the county fire marshal's office determined the cause to be: a lap top computer battery on a cushion. The unit was not plugged in.

Regular Absentee Ballot. Registered voters may request an application for a regular absentee ballot from the City Clerk or download the application from www.takomaparkmd.gov. Applications are now being accepted. Completed applications must be filed with the Clerk not later than seven days prior to the election (4 p.m., Nov. 1). Upon verification of a voter's eligibility, an absentee ballot will be issued—either by mail or in person. The completed ballot must be received by the Clerk prior to the closing of the polls at 8 p.m. on Election Day.

Late Absentee Ballot Requests and On-Site "Absentee Voting"

Beginning Nov. 1 and continuing through Nov. 7, on weekdays between 9 a.m. and 5 p.m., voters may apply in person for a late absentee ballot and may vote on site if they wish. If the applicant cannot apply and vote in person, he or she may designate in the application a registered voter of the City to act as agent in picking up and delivering the ballot (candidates and their families may not act as agents). The application must be completed and filed with the City Clerk prior to issuance of a ballot to the agent. As with regular absentee voting, a ballot cannot be issued until the voter's eligibility has been established, and the ballot must be returned to the City Clerk prior to the closing of the polls on Election Day.

Instant Runoff Voting

The City Council amended the City Charter in 2006 to adopt an instant runoff voting system for elections. Voters will have the opportunity to rank candidates by order of choice. The candidate receiving a majority of votes for Mayor shall be declared

Segunda Vuelta de Elecciones Inmediata

El Consejo de la Ciudad enmendó la Carta Municipal el 2006 aceptando un sistema de segunda vuelta de elecciones inmediata para las elecciones. El sistema permitirá a los votantes eligir candidatos en orden de preferencia. El candidato para el cargo de Alcalde que reciba la mayoría de los votos será elected. The candidate for Council receiving a majority of votes in each ward shall be declared elected.

The first choice marked on each ballot shall be counted initially as one vote. If any candidate receives a majority of the first choices, that candidate shall be declared elected.

If no candidate receives a majority of first choices, the judges of election shall conduct an instant runoff consisting of additional rounds of ballot counting. In every round of counting, each ballot is counted as one vote for that ballot's highest ranked advancing candidate. "Advancing candidate" means a candidate for that office who has not been eliminated. A candidate receiving a majority of valid votes in a round shall be declared elected.

Scantegrity Verified Voting

Again this year, the Board of Elections is working with Scantegrity to provide voters the opportunity to verify online that their votes were counted.

When marking their ballot, voters will receive a confirmation code that they can write down, take home, and check online to make sure their votes were counted. The confirmation number does not say how the voter voted, and the vote remains private. What it does say, however, is that the vote is included in the final tally and that the scanner read the vote correctly. The system is paper-based and works like an optical scan voting system, making it easy to use. The only difference is that when voting, voters will see a confirmation number instead of a completely black mark. Writing down and checking the confirmation number is optional. Cuando marquen la boleta, los votantes recibirán un código de confirmación que pueden anotar, llevárselo para la casa y revisar por Internet para asegurarse de que su voto fue contado. El número de confirmación no dice por quién votó el elector y el voto seguirá siendo privado. Lo que sí dice, no obstante, es que el voto se incluyó en el conteo final y que el escáner leyó el voto correctamente. El sistema utiliza papel y funciona como un sistema de votación con un escáner óptico, lo cual hace que sea fácil de usar. La única diferencia es que cuando vayan a votar, los electores verán un número de confirmación en vez de una marca completamente negra. Anotar y revisar el número de confirmación es opcional.

LANGUAGE LEARNING RESOURCES

Little Pim is our language learning program for small children. It's free for all of our library cardholders. The award-winning program features a cheerful animated panda named Little Pim, and is designed specifically to introduce foreign languages to young children, ages one through five.

You can choose one of 10 languages: English, Spanish, French, Chinese, Italian, Japanese, Hebrew, German, Russian and Arabic. Little Pim is the star of the programs, which feature native speakers and nicely-paced, entertaining activities to make it fun and easy for kids to learn a language.

Mango is our offering for older children and adults. Like Little Pim, it is free if you have one of our library cards.

Currently, there are 34 languages offered on Mango; in addition, there are separate English lessons available for speakers of 26 languages.

E-BOOKS

We offer two different collections of ebooks: the Tumblebook Library, which offers story books and more for elementary school children and Tumblereadables, online e-books for middle and high school students.

Both require a more-or-less up-to-date version of flash and an Internet connection, but you need only a computer – not

Library offers new online tools for kids big and small

After a \$5,000 donation from the Friends of the Library, library users now have five new online resources available to try out, including streaming audiobooks, language learning for kids and adults, and e-books for kids in English, Spanish and French. We are captivated by these online treasures and hope you will enjoy them as much as we do.

Here's a brief run-down of what's available. For more information, check out our blog post of Sept. 5 (just go to www.tinyurl.com/tpml-toys), where you will find loads more information. If you still have questions, we are always happy to answer them. Just call us at 301-891-7259.

How it works:

- To get started, just go to website: www.takomapark.info/library and look for the "Online Resources" box at the right-hand top of the page. There are five separate new "toys" to play with.
- Click on the first arrow in the box (under "Books, Magazines and Newspapers") and you'll find three new reading resources: Tumblebooks for Children, which has storybooks for children up to ages 9 or so; then Tumble Readables, online e-books for kids and young adults; and Audiobookcloud, a great source of streaming audiobooks. Click on the second arrow in the box (under "Learning and Research Tools"), and you'll find a shortcut to our language page.
- NOTE: You need to enter all of our online subscription services through our website, so remember to bookmark our pages, not Mango or Tumblebooks directly.

a dedicated e-reader – to access these resources. They work just as well on Linux computers/pads as they do on Windows and Mac computers.

The Tumblebook Library collections come in three languages: English, Spanish and French. In addition to the picture book and non-fiction titles, our version of the Tumblebook Library includes some chapter books and graphic novels. These are labeled "read-alongs" and have a different user interface.

Tumblebook features differ somewhat from book to book, but in general you will be able to turn audio on and off, turn pages automatically or manually, assemble your own collections of favorite books, write book reviews, and search by author, subject area and so on. TumbleReadables includes chapter books and novels, ranging from a book like "The Sleepover Squad" to a classic like "The Dubliners." The text is adjustable, and the books often include some combination of extra features, such as audio narration, summaries, explanations, definitions and the chance to add highlights or notes.

This resource is perfect for reluctant readers and ESOL students, but many good and experienced readers will enjoy these books as well. The collection also includes a few graphic novels, which are all narrated.

STREAMING AUDIOBOOKS

Our AudioBookCloud resource is mostly for teens and adults. It offers more than

City staff an important COG in regional government

Given the current contentious national political climate, collaboration within government may seem like an elusive concept. Yet, for those who work on the front lines of local government—police, fire and rescue personnel, recreation managers and other public officials—collaboration can be embraced, particularly in a multijurisdictional location such as the Washington, D.C. metropolitan area.

Recognizing this fact, Takoma Park officials have for many years sent selected employees to participate in the Regional Executive Development Program, a year-long leadership and management program sponsored by the Metropolitan Washington Council of Governments (MWCOG) in partnership with the Center for Excellence in Public Leadership at The George Washington University.

The program brings local government managers from throughout the Metro area together for three days each month, with each three-day session focusing on a different leadership and management topic, such as ethics, effective communication, budgeting and financial management and project management. The structure of the program allows participants to not only enhance their leadership skills, but to build networks with their professional peers from other jurisdictions.

"I feel fortunate to participate in a program like this," says Eric Rasch, Takoma Park recreation manager who is currently enrolled in the program. "I have expanded my knowledge base about leadership and regional issues and I have expanded my network, because I can call on anyone in my cohort to get their input or advice."

Deputy City Manager Suzanne Ludlow, who was one of the City's two original participants (in 2001), shares Rasch's sentiments.

"I still network with the other participants from my class," she says.

Ludlow says another benefit of the program is learning how other juris-

dictions operate.

"I enjoyed having as classmates people from other jurisdictions that were high up in government," she says. "That gives you a great sense of not only how other jurisdictions do things, but who to go to for information when you need it, both of which benefit the City tremendously."

Beyond just interacting with their peers, participants also work together on team projects, with each project focused on addressing a regional issue that the COG has identified as important. Starting with Cohort 9 in 2010-2011, the projects are focused on helping the region reach the targets set in the Region Forward Report, which is preparing the Greater Washington Area Region for the year 2050. The results are then presented to the Chief Administrative Officers Committee, which convenes monthly at COG.

This year, Rasch and his fellow team members examined ways to preserve tree canopy throughout the region, a fitting topic given Rasch's affiliation. Not surprisingly, the team's research into best practices in preserving tree canopy led to a familiar place— Takoma Park.

"I obviously knew that preserving tree canopy was important in Takoma Park, but I didn't know that it was the leader in the entire region," he says.

Ludlow is not surprised that Takoma Park was used as an example for one of the projects, adding that the program allows both the city and its officials to shine. "Participants from the bigger jurisdictions learn that there are officials from smaller towns and areas that are highly skilled," she says.

Natalie Houghtby-Haddon, Associate Director of the Center for Excellence in Public Leadership, agrees. "We have had a long history with participants from Takoma Park and they bring a vital perspective into the program. They really showcase the diversity of the region and its municipalities," she says.

almost anything," adds Jose Dominguez, executive director of Pyramid Atlantic, and a former member of the Arts and Humanities Commission. "We can stay open if there's an event at House of Musical Traditions or Roscoe's, and we can be a space for small fundraisers and concerts-anything that ties to art. We want to be part of what's going on in Takoma Park."

Knock on Wood Returns

For Knock on Wood tap studio, moving to Takoma Park is not only a return to its roots but a resurrection. Hit hard by the recession, the studio closed in March 2011. "It was a tough decision, but our Board was committed to finding a new space, and our teachers were very loyal," says Ruth Silverstein, a board member. "When space became available in Takoma Park, we took it."

In mid-September, after a frenzy of painting and remodeling, Knock on Wood returned to the city where it was launched 16 years ago by Yvonne Edwards. Classes are being held at 6925 Willow Street in Takoma, D.C. (across from CVS Pharmacy), and students can register at any time. Classes are available for tappers of all ages (kid, teen, adult) and abilities (beginner, intermediate, advanced).

Edwards, who is 77 years old, also founded the Tappers With Attitude Youth Ensemble. She still performs, and she's made Knock on Wood one of the few studios in the nation that focuses solely on teaching "rhythm tap."

Rhythm tap has roots in English clogging, Irish step dancing and African slave dances, says Silverstein. It emerged at about the same time as jazz. "Rhythm tap is described as making music with one's feet," Silverstein says, in contrast to "Broadway" or "show" tap, which incorporate ballroom dance or ballet steps.

Registration for classes was strong in the fall, and Silverstein says the studio has been "embraced" by a community that supports the arts. "It feels as if the stars have aligned for us," she says.

Capitol Tap, a new youth performance ensemble, is joining Knock on Wood as a resident company. Capitol Tap was established last year by Lisa Swenton-Eppard, former assistant director of Tappers With Attitude, with support from Baakari Wilder, who performed on Broadway in Bring in Da Noise, Bring in Da Funk.

Knock on Wood will have an open house in October; check www.knockonwood.org for information.


Soup to go comes to stay

From the street, customers can see kettles of soup steaming through the windows; inside, they can either sit down and enjoy a bowl, or grab something from the refrigerator to take home. This is Soupergirl, where the menu includes three different soups at a time-selections like red pepper carrot puree, peanut vegetable and mung bean tomato-and two salads, such as barley, black bean and corn-on a rotating basis. The frig has a larger selection.

All soups are homemade, vegan and kosher, and rely heavily on organic ingredients and locally grown vegetables from places like Tuscarora Farms and Twin Springs Fruit Farm.

The two-year-old, family-owned (mother-daughter) business evolved from a D.C. basement to a soup delivery business working from an industrial kitchen. Now the soups are concocted at the Takoma site. Deliveries continue, but the café, which opened Sept. 7, gives the enterprise a new direction. Located across from the Takoma Metro station, at 314 Carroll Street N.W., the idea is that Takoma Park commuters will stop by on their way home from work and grab dinner, or meet for lunch if they're among the many who work at small home offices and other enterprises around town.

DISCOUNT TREES AVAILABLE TO BEAUTIFY YARDS, REPLACE THE CANOPY

The season is right to plant trees, and in Takoma Park that means residents can help replenish the aging tree canopy in the City. This year, as an extra incentive to plant, City Council voted to offer a \$100 discount on one tree per property owner (unless it is a replacement tree required as part of a Tree Removal permit). Residents can add a tree to their yards for just \$95 plus 6 percent sales tax, a total of \$100.70. Add a second tree and the bill is still only \$307.40, planted and guaranteed for one year.

Established discounts still apply as well, through the City's annual bulk buy tree sale. As a purchasing agent with Arbor Landscapers, the City is making five species available at wholesale prices. and marketing. With so many businesses nearby in Silver Spring and D.C., Takoma Park needs to build an image and stand out from its competitors.

Main Street Takoma has been doing just that. With an online website, a facebook page with a loyal following, a revolving loan and a calendar filled with events, the organization, in partnership with the City and the State of Maryland, has worked hard to increase Old Takoma's profile as the place to be. The City's New Ave initiative and website provide a similar service to New Hampshire Avenue businesses (including the Crossroads), establishing an



online identity and one-stop shop to learn about loans, grants and resources needed to start a business.

That sort of branding will help Takoma

Park stand out as a unique and desirable commercial district, and draws just the sort of business shops need to thrive.
