## Takoma Park gets out to vote

On 7:30 the morning of Election Day, volunteers reported that voter turnout was good so far. This was a sign of good things to come as Takoma Park enjoyed a 21 percent turnout rate, one of the highest in the last few election years.

By 7:45 a small line had formed as residents voted before heading to work. Residents of all ages showed up at the polls, from families strolling with young children to 55+ voters who came accompanied by spouses and other relatives. And they all embodied the spirit of community and inclusiveness that Election Day brings out in Takoma Park.

"I have always appreciated the openness of the election process in Takoma Park,"

observed 15-year resident Margerita Silverstone of Ward 1. Silverstone was in favor of the advisory question on the ballot if it meant the process could be "even more open and inclusive."

One of her fellow residents shared this sentiment. Joan Horn, also of Ward 1 and a 35-year resident of Takoma Park, was also in favor of the advisory question. In addition, Horn said, "Face-to-face contact made the difference in casting her vote." She talked with Kate Stewart during her campaign and "would like to see her continue on the same path" should she become Mayor.

## Voters showed strong support for the advisory question

Judging from the results of last month's election, many Takoma Park residents are in favor of moving City Elections to even-numbered years. Beginning with the election in November 2018, and providing that voting rights can be maintained for City residents who are (1) 16-17 years old, (2) non-citizens, or (3) on parole or probation for a felony conviction, and that instant runoff voting and same day voter

registration can be maintained, the City of Takoma Park municipal elections for Mayor and Councilmembers could be changed to the Tuesday following the first Monday in November in each even-numbered year to coincide with Maryland statewide general elections. Below is the tally of voters in favor of the advisory question broken down by wards.

## Recommended Decision Issued on Hospital Move

On Nov. 18 Maryland Health Care Commissioner Frances B. Phillips issued a recommended decision to approve the certificate of need request for Washington Adventist Hospital to move most of its operations from the Takoma Park Campus on Carroll Avenue in the center of the City of Takoma Park, along Sligo Creek Stream Valley Park, to a new location in the White Oak area of Montgomery County.

The recommended decision has five approval conditions; the first two directly affect Takoma Park:

- Urgent care center** (in the location of the current Emergency Department). Adventist HealthCare Inc. must open an urgent care center on its Takoma Park campus.
  - The urgent care center must operate 24 hours a day, every day of the year.
  - Adventist HealthCare Inc. may not eliminate this urgent care center or reduce its hours of operation without the approval of the Maryland Health Care Commission.
- Specialty hospital for psychiatric services** (a stand-alone version of the current behavioral health in-patient unit of the hospital). In the fourth year of operation of a replacement Washington Adventist Hospital, Adventist HealthCare Inc. shall provide a report to the Maryland Health Care Commission on the operation of the specialty hospital for psychiatric services in Takoma Park. This report must review:
  - patient intake and transport issues
  - coordination of care for psychiatric patients between the White Oak and Takoma Park campuses
  - the specific financial performance of the special hospital, exclusive of the operation of Adventist Behavioral Health and Wellness overall.

# Takoma Park Boy Scout Troop 33 celebrates nine decades of service

For 95 years, local boys have been joining Takoma Park Boy Scout Troop 33, and the reasons now are the same as they have always been.

“Leadership skills and management skills,” says current Senior Patrol Leader Nate Blower, 17, when asked what he values most about of the Boy Scout experience. “And knowing how to tie different knots will come in handy, too.”

It is that mix of the organizational and aspirational (leadership, service projects), the practical (knot tying) and the natural (camping, hiking) that has kept young

boys involved in Boy Scouts of America (BSA) since it was established in 1910 in New York City to help young people be “Prepared for Life.”

Ten years later, in 1920, Troop 33 was established in Takoma Park, where it has been continuously chartered to the Takoma Park Presbyterian Church. As has happened so many times since, troop members and Takoma Park residents gathered at the church for a fundraiser on Saturday, Nov. 14. This time it was for a chili dinner to commemorate the troop’s 95th anniversary.

Such a long-standing association be-

tween a troop and a sponsoring organization is “rare,” said current Scoutmaster Tim Miller. “We have a really great relationship with them,” he said.

That relationship was showcased during one of the seminal moments in the troop’s (and church’s) history. In 2012, both stood up against what was at the time a BSA policy excluding “open or avowed homosexuals” from membership (a policy that has since been changed).

The troop was one of the most openly critical and defiant of the national policy and even adopted a rainbow theme at its

annual pancake supper that year to show its support for inclusiveness.

But that is only one of many achievements and milestones the troop can claim. Troop 33 has a proud record of service and achievement. The newly chartered troop of the 1920s undertook community projects, such as a clean-up of the Sligo Creek area. On February 22, 1932, a select patrol from Troop 33 performed the opening ceremony of the George Washington Bicentennial Birthday Celebration at his birthplace in Wakefield, Va.

Inc. stated its intention to have on-campus laboratory and radiology services to support these units as well as a rehabilitation hospital (currently located within Washington Adventist Hospital). A federally qualified health center on the Takoma Park campus will remain and be expanded. Washington Adventist University intends to lease 50,000 square feet of hospital building space for its use.

City Staff discussed the recommendation with the Takoma Park City Council in closed session on Nov. 23.

The City of Takoma Park will submit comments, and the City will be interested to see the comments from WAH and the hospitals opposed to the move.

The relocation of Washington Adventist Hospital’s main hospital out of the City was expected, but is a disappointment to the City of Takoma Park. Washington Adventist Hos-

pital has been an integral part of the history and fabric of Takoma Park. Over the last year, the City Council, Staff, and residents have worked diligently to ensure that throughout the certificate of need process the needs of Takoma Park residents have been front and center.

As a result of our hard work and persistence, the top condition of the Commissioner’s recommended approval is the maintenance of an urgent care facility at the Takoma Park campus, to be operated every day, 24 hours per day, beginning as soon as the hospital move takes place. This will ensure that there is no gap in care for the primary care service that our community needs. Clearly, the commissioner recognized the need for these services based on the information the City presented.

The recommended decision will go before the full Maryland Health Care Commission on Dec. 17 for a final deci-

## Public Works Snow Removal Plan

Public Works staffers are preparing to work hard to clear whatever snow falls on Takoma Park's 34 miles of city-maintained roads, as well as walkways and sidewalks around city parks and public buildings. City staff tracks potential storms as they occur and prepare to respond as soon as the snow starts to fall. Plow crews start plowing operations when one inch of snow is on the ground and are prepared to work 12-hour shifts. The City uses Public Works Right of Way staff as primary plow drivers, and sanitation drivers fill in the second shift. When significant snowfall occurs, city trash and recycling collection may be canceled to allow sanitation drivers to pitch in with road clearing. The City's Garden Division staff clears public sidewalks during daylight hours, with assistance as needed from temporary laborers. Public Works encourages businesses and residents to do their part to clear snow and ice from the sidewalks adjoining their property.

Takoma Park's winter weather response plan divides the city into five snow removal zones, each with an assigned response vehicle. Within each zone, "primary streets" are those with the most traffic and those that connect neighborhoods. "Secondary streets" are shorter, with fewer homes, and include courts, alleys and dead ends. City

crews first clear primary streets and then proceed to secondary streets. The City's goal is to create two travelable lanes on each primary street within a 12-hour shift if the snow fall is six inches or less. If the snow fall is six inches or more, the expectation is to have one travelable lane over a 12-hour period. Snow removal equipment remains in service around the clock until all the roads are cleared. Often, when severe weather is on the way, the city begins anti-icing procedures by applying a sand salt mixture or liquid de-icing chemicals to the street surface. Plowing begins once snowfall has accumulated to one inch on the street. If the storm produces only sleet and ice, the city treats roadways with sand and salt. Snow and ice response service on some streets is performed by outside agencies. **The State Highway Administration is responsible for clearing Carroll Avenue, Ethan Allen Avenue, New Hampshire Avenue, Philadelphia Avenue and Piney Branch Road. Sligo Creek Parkway is a Maryland National Capital Park and Planning Commission roadway, and snow and ice response is performed by Montgomery County.** However, city plows will assist with snow removal on these streets in the course of their work to clear city streets.

## Four Helpful Tips during a Snow Event

- 1. Stay connected.** Conditions leading to a declared snow emergency include the expectation of a significant quantity of snow or an ice event. The City Manager may declare a snow emergency and will announce the status through Takoma Park Alert, local media, and on the City's website, Facebook and Twitter. The following restrictions go into effect during declared snow emergencies:
- 2. Avoid parking on the street.** Residents are strongly encouraged to park vehicles in their driveways whenever possible. Fewer cars on the street allow city plows to more quickly and safely clear the roads. If you must park on the street, make sure to park your car as close to the curb as possible and maintain a distance of at least 25 feet from an intersection.
- 3. Clear your sidewalk.** Residents are responsible for clearing the public sidewalks adjacent to their prop-

erty. When possible, keep sidewalks clear of snow and ice by regularly shoveling accumulated snow during and after a snow event. Please do not shovel large amounts of snow into the street when clearing your driveway, lead walk or sidewalk. The best place to pile snow is on the lawn or grassy areas. Piles of snow shoveled out into the street can cause problems for passing vehicles.

- 4. Be a good neighbor; help others in need.** Reach out and ask neighbors if they need assistance with keeping their sidewalks clear. Many residents are physically unable to shovel snow and ice and are hesitant to request help from neighbors or friends. Your thoughtfulness can make a big difference to someone who might otherwise be unable to cope. **Missed the Snow Angels sign up deadline? Not to worry! Those who registered before Dec. 1 will be contacted by Dec. 4.**

If you have not registered before December 1, you may still contact the Lifelong Takoma Program. However, you may be given an alternate resource for snow removal depending on the number of volunteers available.

If there are enough volunteers to provide assistance, we will open up the Snow Angels Program on a graduated basis to include those who contacted us after Dec. 1. Under these circumstances, we may be able to provide snow removal services to residents who have contacted us, after the deadline, by the (date) order in which they contacted us for snow removal requests. ## Let it snow! And be a good neighbor!



Although we never really know this far in advance, forecasts for our area indicate there is a good chance for some heavy snows this year. With the potential for more snow comes an opportunity for residents and business owners to show what good neighbors they can be. When it snows, we need to remove snow and ice from sidewalks, so neighbors, children and customers can travel safely. When sidewalks aren't clear, people have to walk in the street or try to navigate dangerous patches of ice, so please be considerate of neighbors and the community and keep your sidewalks clear.

The City recently changed some of its regulations regarding snow removal. Residents now have until noon after a night of snowfall, and until 9 p.m. after a day of snowfall, to remove snow and ice from

their sidewalks. Businesses will need to keep their sidewalks clear between 9 a.m. and 5 p.m. The full width of your sidewalk must be clear unless full-width clearing is not feasible, in which case at a minimum a continuous three-foot wide path of the paved sidewalk must be cleared. Lastly, to protect our sidewalks and trees, the use of salt is strictly prohibited on sidewalks or within 10 feet of any trees.

Would you be willing to help out your neighbor? If your neighbor needs some assistance clearing off their sidewalk, offer to give them a hand after you finish clearing yours. For those who are physically unable to remove or clear snow, volunteers may be available to help through the Snow Angels Program. If you need a hand this winter or you'd like to help out those in the community (see page 10), contact the Lifelong Takoma Program.

For vendors and shoppers alike, the sale is a place to connect with the community and purchase one-of-a-kind gifts. For the 10th Takoma Park Holiday Art, Bailey is one of 30 local artists, who craft fountain pens, jewelry, hand-painted furniture, and more.

"This year we had fierce competition for the slots, and the result was a group of our most talented artists," said Rob Rudick, a local photographer and the sale's organizer and founder.

Support from Takoma Park residents has kept the sale going for almost a decade. Even

the artists are eager customers.


"Hopefully I'll make some sales, so I have more money to spend," said Bailey. "It's like a yard sale because you end up taking more stuff home when you walk around and see what your neighbors have to offer."

While some take home necklaces or scarves, the sale has more to offer to those involved. "My wife and I deliberately moved to Takoma Park because it was such a unique and peaceful community," said long-time art sale vendor Bruce Ramsay, who started painting while rehabilitating from a traumatic brain injury. "I appreciate the good will of everyone that I've dealt with since my injury, and I am a phenomenally fortunate human being to be able to paint."

Bruce's treatment of space and color in his wildlife paintings has made him a staple at the sale for five years, but the sale's selection jury loves new talent as much as it loves familiar favorites.

"My dream has always been for this to be a real art sale rather than a craft sale," Rudick said. "We're getting closer to that every year. The painters we have this year are really amazing."

Whether it's a painting of a rooster or a sense of community pride, Takoma Park gets a haul from the sale every year. The 10th Takoma Park Holiday Art Sale will be on Saturday, Dec. 12 from 10 a.m. to 4 p.m. in the Takoma Park Community Center.

Stewart, councilmember for Ward 3, was elected Mayor of Takoma Park, and Peter Kovar, one of two newcomers to the city council, won the Ward 1 seat with 630 votes. Ward 6 councilmember Fred Schultz kept his seat, receiving 206 votes. The other four candidates, Ward 2's Tim Male, Ward 3's Rizzy Qureshi, Ward 4's Terry Seamens, and Ward 5's Jarrett Smith ran unchallenged. Bernice Tyler, who has lived in Takoma Park for 45 years, also appreciated candidates who gave their campaigns that personal touch. "Folks who came to my home to visit personally got my vote," she said.





## Library renovation planning progresses

Greg Lukmire, principal architect of The Lukmire Partnership, presented the most recent concept design for a renovated and expanded Library to the City Council at their work session on Oct. 29. It incorporates recommendations from the Council, as well as residents and Library and other City staff.

The new floor plan shows the expanded floor plan with additional space in yellow. In addition, there are “character sketches,” which provide an idea of how the renovated Library could look from the outside based on this new design. The existing floor plan is shown here for purposes of comparison.

Three of the seven character sketches are also shown here. Taken together, they illustrate a number of important elements: The scale and architectural character of the building is unchanged, relative to the surrounding neighborhood. The community constructed mosaic remains, as do most trees. The main entrance, with its new, well-lit canopy, faces the parking lot rather than the flood wall. Larger glass windows allow more natural light and invite passers-by to visit the newly renovated space inside. A new canopy identifies the entrance to the Community Center.



Eight young men associated with Troop 33 lost their lives serving in World War II. In its 95 years, Troop 33 has engaged an estimated 4,000 boys in scouting, and 96 scouts of Troop 33 have reached the highest level of scouting achievement, the rank of Eagle Scout, including Hank Harman, who earned his at the age of 86!

In 1957, Troop 33 purchased 43 acres of rolling timberland east of Romney, W. Va., for a permanent troop camp with funds donated primarily by the parents of Waldo E. Schmitt, one of the former Troop 33 scouts who perished in World War II. Today, Camp Waldo E. Schmitt includes a

large main cabin, a Venture Scout cabin, numerous patrol camp sites, a lake, and nature trails.

For Troop 33 scouts, such as Adil Hall, 11, it is the opportunity to bond with nature at places such as Camp Schmitt that make scouting so appealing.

Hall, who says he got involved in Scouts four years ago after hearing one of his friends talk about how great it was, loves "camping, hiking, trailing, exploring around, all of it."

His self-described "best friend" Mateo Griffis, agrees.

"Camping is the best," he says. "I love running around and being free."

Talk to scouts at the Troop's 100th, 150th or 200th anniversary, and it's a safe bet they will express the same love.

# Amnesty International celebrates human rights day in Takoma Park with two events

craft and story programs; author visits, book discussions and the many school class visits held in the current children's room every day.

A new space for our burgeoning young adult book collection contains some comfortable lounge seating. The children's room, with its circular glass partition, contains enclosed group study rooms as well as work tables and some additional lounge seating for younger readers and their parents. The new arrangement of book stacks allows more natural light and meets ADA accessibility standards, as do the new restrooms.

In summary, this new design preserves adequate space for books, has sufficient seating of various kinds, connects to the Community Center, makes public space visible to staff, allows convenient access to the Library, and harmonizes well with

the landscape and surrounding neighborhood.

The estimated cost of implementing this design will be between \$4 and \$4.5 million, including construction, furnishings, fees and testing.

The Library will be scheduling public meetings this month and in January to hear and address comments and ques-

tions regarding this latest concept design. We hope for an enthusiastic response by community members that will lead to Council approval and detailed design development preceding a full renovation.

site under "Library Renovation Project." There is also an exhibit in the Library, which shows the floor plan and all seven of the character sketches.



## THE FIREHOUSE REPORT

### The Firehouse Report

As of Oct. 31, the Takoma Park Volunteer Fire Department and the personnel of the Montgomery County Fire and Rescue Service assigned to the station have responded to 531 fire-related incidents in 2015. The department addressed or assisted with 2,739 rescue or ambulance-related incidents for a total of 3,270.

Totals for 2014 were 563 and 2,378, representing an increase of 329 incidents.

During October 2015, Takoma Park volunteers put in a total 1,260.5 hours of standby time at the station, com-

pared to 1,645.5 in October 2014. Grand totals as of October 2015 were 13,230.5 hours, compared to 14,174 hours in 2014, a decrease of 943.5 hours.

### Maryland fire deaths

The Maryland State Fire Marshal Office reported as of Nov. 16, 50 people have died in fires, compared to 49 in November 2014.

### My apartment was broken into and some of my valuables were taken. Can I require the landlord to reimburse me for my losses through his insurance policy?

Your landlord's insurance covers for damage to the property and the building; however his insurance will probably not cover for your personal losses unless you can show that the landlord was negligent and caused the mishap. You and other tenants are strongly encouraged to consider purchasing renters insurance, which provides coverage against losses from theft, vandalism, fire or smoke, explosion, windstorm and water damage (excluding floods). Renters insurance would also protect you if others are injured in your apartment and may pay for your legal defense if you are taken to court.

Prior to purchasing renters insurance the following considerations should be made:

- Determine how much insurance is enough to replace all of your personal possessions by creating a home inventory, a detailed list of all your personal possessions and their estimated value. The Insurance Information Institute offers free home inventory software at [www.knowyourstuff.org](http://www.knowyourstuff.org)
- Evaluate replacement cost vs. actual cash value coverage. A replacement

cost policy pays to replace your possessions without accounting for depreciation. An actual cash value policy pays to replace your possessions minus a deduction for depreciation. Although replacement cost coverage is usually about ten percent more than actual cash value coverage, the extra cost should be weighed versus the generally quick depreciation rate of most personal property;

- Consider adding a floater (a separate policy that provides additional insurance) if your personal property includes expensive jewelry, furs, collectibles or other valuables. Receipts and/or appraisals of the property covered by the floater must be provided.
- Determine if your renters insurance provides liability protection that covers you against lawsuits for bodily injury or property damage for acts done by you, your family members and your pets. Most standard renters insurance policies generally provide at least \$100,000 of liability coverage, but additional amounts are available.
- See if you are eligible for discounts. Discounts on renters insurance may be available if you have a security system, use smoke detectors, use dead-bolt locks, have good credit and have another policy (auto or business).

The Maryland Insurance Administration estimates that the average renters insurance policy costs \$15-\$30 per month. 

## Lifesaving and safety in case of power emergencies: The POPPI method

In this area, we have considerable experience with power outages, so what can we do to deal with this reality? How might we care for people who need electricity to survive? How might we learn about the potential for outages, such as during hurricanes or tornadoes?



### Did you know?

- In case of outage or power problem, call Pepco 1-877-737-2662/1-877-pepco62 24 hours a day.
- 48 percent of Maryland power lines are underground; 52 percent are above and are subject to damage from natural disasters, such as hurricanes and tornadoes, which require Pepco attention and action.
- There are approximately 442 nurs-

ing homes/assisted living facilities in Montgomery County. Only 3-4 percent have back-up generators. This means that Pepco must service these facilities as well as our homes, schools and businesses.


- In cases of massive power outages, such as those during Hurricane Sandy,
  - the required order of power restoration is life threatening situations, such as downed live wires; hospitals, water treatment plants, nursing homes/assisted living facilities and general population.

# Kilowatt Smackdown Winners

During a six-week period, student volunteers competed against one another to see who could complete the most energy assessments for local Takoma Park businesses. Sponsored by the City of Takoma Park, these free energy assessments consisted of an energy efficiency survey and a utility bill check-up. Seven student volunteers helped 63 local businesses identify an average energy efficiency savings per business of 32 percent or \$1,450 per year, which is the equivalent to a total of 325 tons of carbon emissions offset annually! Students earned scholarships, internships and prizes, including gift cards and resume reviews.

The winning student was Begoña Blasco of Catholic University with 28 assessments completed; second place went to Chidera Igbokwe of University of Maryland with 15 assessments, and third to Emily Oldham from Catholic University with 9 assessments completed.

In the coming months, Green Impact Campaign will work with the participating businesses to further understand their assessment results and further implement



recommendations:

- Provide businesses with a Green Impact Campaign Certified Business window decal to show their participation and commitment to being a local, sustainable business.
    - Assist businesses interested in becoming certified as a green business through Montgomery County's Green Business Certification Program.
  - Nextility will help businesses secure lower energy supply rates and green energy through the utility. Nextility can also provide solar assessments for qualifying buildings.
    - PEPSCO will provide businesses with various rebates on the purchase of energy-efficiency equipment, including lighting, appliances, refrigeration and HVAC, helping bring down the cost of upgrades by more than 50 percent.

- The goal is to have power restored to 70-80 percent of the population within three days.

### What can you do?

#### Follow your Power Outage Preparedness Plan (POPPI):

- Enter Pepco's number (877-737-2662) in your cell phone in the ICE area (in case of emergencies); your cell phone should still have power for a while.
- If your life or someone in your family's depends on electricity for emergency medical and life-support equipment, such as respirators, kidney dialysis machines, sign up for the Emergency Medical Equipment Notification Program (<http://tinyurl.com/puc8a22>). An information package is sent annually to help you prepare for emergencies. Note: Participants must renew annually.
- If you want to be notified of restoration estimates, get outage maps, report outages or safety hazards, and more, sign up for the Pepco mobile app (<http://tinyurl.com/oska2ra>).

- If you want to be sure that your back-up generator will work, test it. It's important to have full-back up generation (full 3phase load). Hook up the generator to your system as you would if the power was out and run it full load for a while once a month.
- Check and update your emergency plan, which should include:
  - medical needs and doctor info
  - contacts list, local and out of area
  - meeting place if you are separated from family, others
  - supplies for three days
  - radio and batteries
  - several working flashlights
  - grab bag of items you need if you have to leave for a while
  - notify security company, if you use one

## In Memory – Anita Datar

Takoma Park resident Anita Dakar was killed in the terror attack in Mali on Nov. 20. On Nov. 22, residents gathered at the gazebo in Takoma Park for a candlelight vigil to remember Datar and other victims of violence in Paris and Mali.

As reported by *The Washington Post*, Datar was the only known American killed in the attack in Mali. The 41-year-old global health policy expert had been there working for about week before the hotel where she was staying with coworkers was taken under siege.

Datar was senior director for field programs for Health Policy Plus, a project funded by the U.S. Agency for International Development initiated to improve reproductive health in developing countries. Datar had spent much of the past 10 years of her career with Palladium, an international development firm, pursuing global public health, particularly family planning and HIV prevention and response.

Palladium is establishing a memorial scholarship in her name to Johns Hopkins University's Bloomberg School of Public Health. Her son Rohan is a second grader at Takoma Park Elementary School.
